CAMPGROUND RULES AND REGULATIONS

2019 Canby Wine, Food & Brew

Canby Wine, Food & Brew camping is dry camping only. There are **no hook-ups** for power, water or sewer in the campground. Please contact the Campground Superintendent if you have a medical condition requiring special camping assistance.

**Return this application to the Fair Office by May 15, 2019
\$25.00 late fee if this permit is received after May 15, 2019
No refunds will be given for cancellations after May 15, 2019**

1. Spaces will be pre-assigned by the Campground Superintendent. Please check-in upon arrival at the campground to pick-up your camping paperwork and space assignment. The Camping Superintendent has the authority to have vehicles towed and request the removal of disruptive or unruly campers.
2. Admissions passes to the Canby Wine, Food & Brew will be required and are not included in the fee for camping space(s).
3. Campers may move in beginning Friday, May 31st from 9:00am to 9:00pm.
4. All vehicles and RVs must display the campground permit provided. Vehicles without permits will be towed at the owner's expense.
5. Campers will have in and out access throughout the night, but will need their camping tag to get back inside the camping grounds.
6. Campground speed limit is 5mph. This is strictly enforced. Fire lanes must be kept open at all times. Vehicles blocking fire lanes will be towed at owner's expense.
7. Persons under the age of 18 will not be allowed to camp independently. An adult must be at the campsite when children are present.
8. Your permit allows for 1 campsite and 1 vehicle parking permit. Your camper and vehicle **MUST FIT within your assigned space. Including awnings and tip outs.**
9. For vehicles that do not fit within the camping space boundaries additional parking is available in the Campground Overflow parking lot. See Campground Superintendent for space assignment in the overflow parking lot. Parking passes for general parking can be purchased at the Fair Will Call window for all other vehicles.
10. Hay and Straw cannot be stored in the campground due to Fire Marshall Regulations.
11. Courteous respect for other campers is expected. Quiet time is from one hour after Festival closing until 7:00am. The Festival closes at 11:00pm. **Generators must be turned off by 10:00pm.**
12. The following are **NOT** allowed in the campground at any time:
 - x Alcohol
 - x Smoking
 - x Pets
 - x Open Fires
 - x Waste water dumping on campgrounds
13. Propane/Pellet BBQ's have been approved by the Fire Marshall, so you may cook with them.
14. A sanitary service will be on site to empty holding tanks (there is a fee). Contact the Camp Superintendent to make arrangements.*
15. All Campsites must be vacated within 2 hours of the close of the Canby Wine, Food & Brew. Anything left more than 12 hours will be removed and the registered occupant will be charged for removal.

CAMPGROUND FEES: **RV and vehicle MUST fit within boundaries of assigned campsite.** Vehicles that cannot fit within campsite boundaries must park in the campground overflow parking lot. Obtain this parking pass from the Campground Superintendent.

Short Space: 20' long x 16' wide = **\$15.27** (Site will fit tent or small RV & includes 1 parking pass) **Tax included**

Long Space: 21' to 40' long x 16' wide = **\$22.76** (Site will fit RV under 40' long & includes 1 parking pass) **Tax included**

Extra Long Space: 40' to 45' long x 16' wide **\$28.45** (Site will fit 40' to 45' RV & includes 1 parking pass) **Tax included**

Taxes: Clackamas County Fair is now required to collect Transient Lodging Tax for Clackamas County, City of Canby, and State of Oregon.
