The meeting began at 5:30 p.m.

Task Force Chair, Lisa O'Brien welcomed the task force and reviewed the meeting agenda.

The August 19th, 2020 meeting minutes were approved with one correction to the attendance list.

Kathryn Krygier informed the group that the geotechnical testing is proceeding at the building site. She will have an update when the report is are submitted by the geotechnical engineer. Jaqueline Betz informed the group that the Gladstone Planning Commission approved text for an amendment related to parking in downtown Gladstone. The amendment would allow for the new library to be built without onsite parking. The next step is to be considered for approval by City Council.

### **Vote on Preferred Design Alternative**

Allison Brown invited the group vote to recommend the preferred design alternative to the Board of County Commissioners: Laurene McClintock motioned to approve option three as the preferred alternative and Nancy Turner seconded the motion. The motion was approved unanimously.

Jennifer Hoffman and Kathryn Krygier reviewed the steps in the process which is the alternative refinement and completion of the report, next steps and future meeting schedule.

Mitzi Olson reviewed the status of the bylaws for the future library board. Per the IGA, the Gladstone Library Board will dissolve one year from approval of the IGA which is November, 2020. The draft bylaws were presented to both library boards at recent meetings. The Oak Lodge Library board unanimously approved the draft. The Gladstone Library Board voted 3-3. The next step will be for the bylaws to be presented to the Board of County Commissioners on November 17<sup>th</sup>, 2020 for formal approval. Once approved, the library board recruitment will commence.
