Members of the Board:

Approval to accept a revenue Agreement from Parenting Now to conduct a pilot group for *Haga de la Familia un Placer* (*Make Parenting a Pleasure*) parenting series. Children, Family & Community Connections, acting as the local parenting education hub for Clackamas County, will recruit and enroll up to 10 Spanish-speaking Latinx families to participate.

Revenue award amount is \$5000. No County General funds are involved.

#### BACKGROUND:

The Children, Family and Community Connections (CFCC) Division of the Health, Housing & Human Services Department requests the approval to accept this direct award from Parenting Now to train a Parenting Educator in the use of *Haga de la Familia un Placer* and recruit 10 Spanish-speaking Latinx families and hold a 12-week culturally-specific parenting series pilot group in Clackamas County. The information gathered from this pilot group will inform Parenting Now on how this series is received and inform future culturally specific parenting programs. Parenting Now is a non-profit organization that provides parenting education and support to families with young children to create and sustain healthy, safe environments for children.

This Agreement is funded through Parenting Now and is effective upon signature by all parties for services ending September 30, 2022. This revenue award has a value of \$5000.

# Agreement to Conduct Pilot Group for Haga de la Familia un Placer

This Agreement describes the arrangement between **Parenting Now** (PN) and **Clackamas County / Clackamas Parenting Together** parenting education hub (Agency), in which the Agency will conduct a parenting group as a pilot group for *Haga de la Familia un Placer* (HFP), the Spanish language cultural adaptation of the PN curriculum, *Make Parenting A Pleasure, Second Edition*. During the pilot groups, the Agency will provide feedback to PN about parents' acceptance of the activities and discussions.

# Pilot Group Details: Agency Responsibilities

#### Agency Responsibilities:

- 1) Pilot group Parenting Educator agrees to become familiar with the *Haga de La Familia un Placer* curriculum prior to the pilot group sessions by:
  - a. Attending the Parent Educator training, date TBD
  - b. Reviewing the materials sent by PN prior to the Parent Educator training.
- 2) Recruit and enroll pilot group participants for a 12-week *Haga de la Familia un Placer* series: up to 10 Spanish-speaking Latinx families to participate in the pilot group (up to 20 adults, two adults per family)
- 3) Collect basic demographic information from parents enrolling for the pilot group, and send to PN for reporting purposes. Information will be items such as parent's age, race/ethnicity, country of origin, number and ages of children, possibly a question about household income level. A confidential, protected method of transmitting this information from the Agency to PN will be developed.
- 4) Provide a location for the pilot group to take place, physical or virtual.
- 5) If groups are held in person, provide refreshments and childcare for each of the sessions.
- 6) Provide copies of materials for each session; i.e., handouts needed by participants and any materials required for activities.
- 7) Maintain attendance records for each session.
- 8) The Agency's Parenting Educator (PE) will fill out a "Fidelity Diary" after each session. The Fidelity Diary consists of a list of the discussions and activities, per the session booklet. The PE is asked to indicate whether she/he completed the discussion or activity (yes/no/partial) and write any comments. The Fidelity Diary will be in Spanish and English.
- 9) PE agrees to speak on the phone with a PN project staff person after each session, to review the Fidelity Diary and provide qualitative feedback about the parents' acceptance of the discussion, activities, and video in the session, and any other feedback about parents' participation. We expect these phone calls to take 15-30 minutes for each session.
- 10) For program evaluation purposes, PE will administer the Mid-Course Survey during Session 5 (included in the Session 5 booklet) and the Parenting Skills Ladder



evaluation during Session 12. The Parenting Skills Ladder will be provided in Spanish and is available online or in paper format.

11) Agency will provide each adult pilot group participant \$10 for each session attended, for a total of \$120 for the entire series. When total attendance for the entire series has been tallied, PN will provide a lump sum to the agency, for Agency disbursement to parents.

### Parenting Now Responsibilities:

- 1) Provide to the agency a \$5,000 payment for conducting the pilot group, plus our heartfelt thank you!
- 2) Provide *Haga de la Familia un Placer* session booklets in electronic PDF format for use by the PE in leading the sessions as well as a thumb drive with the videos for the sessions and/or a link to the videos on YouTube.
- 3) Provide training to the PE in use of the curriculum, prior to the pilot group startdate.
- 4) Provide copies of the Fidelity Diary for the PE to complete after each session, either hard copy or electronic. The Fidelity Diary will be in Spanish and English.
- 5) Communicate with the PE after each session, per #6 above, to ask for input about the parents' participation with the discussions and activities in each session.
- 6) At the end of the series, provide to the agency a lump-sum payment for parents' participation incentives, to be dispersed to each parent based on her/his attendance.
- 7) Provide to the agency a summary of the evaluation feedback provided by parents in the Mid-Course Survey and Parenting Skills Letter.
- 8) Provide to the agency a copy of the completed Haga de la Familia un Placer curriculum, which includes print copies of each session booklet, a Parenting Educator Guide, a starter packet of 15 each Parent Booklets and Certificates, and a thumb drive containing all videos for the series.
