

# Appointed Boards and Commissions (ABCs) Recommendation

The Traffic Safety Commission, staffed by the Department of Transportation and Development, currently has 4-6 openings on their commission due to term expirations. Ten to twelve members are allowed with four-year terms.



Recruitment opened to the public in March and again in May 2024. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, seven applications were received and four were recommended to be appointed. However, one of the recommended applicants was hired by the County, so they will not be appointed. Two applicants are new and one applicant is currently on the board. Interviews were offered to all applicants, however one never responded two applicants did not attend their scheduled interview. Interviews were conducted with four eligible applicants on August 7, 2024. The TSC is recommending three individuals and will reach out to those who did not attend the interview a second opportunity in early 2025.

The Board of County Commissioners could select other candidates or require further recruitment.


