This Voters' Pamphlet contains information designed to assist you in voting. In addition to general voting information, you will find ballot titles, explanatory statements and arguments pertaining to three local measures that appear on the September 16, 2003 ballot in Clackamas County.

Please remember, in order to vote on any of these measures, you must be a registered voter as well as a resident of the city or special district that has placed the measure on the ballot. You will not vote on everything in this pamphlet, only that which appears on the "Official Ballot" guide contained in your vote-by-mail packet!

If a ballot was delivered to your residence for someone who should no longer be receiving ballots at your address, please write "RETURN" on the envelope and place it back in your mailbox. If a ballot was sent to someone who is deceased, please write "DECEASED" on the envelope and place it back in your mailbox.

Your voted ballot must be received in the Elections Office, 825 Portland Avenue, Gladstone, OR, by 8:00 PM on election night to be counted. **Postmark does not count!** If you prefer, instead of mailing your ballot, you may take it to the Elections Office or to one of the Drop Site Locations listed on page 12 of this pamphlet. Drop boxes will be available at these locations beginning August 30 and extending through 8:00 PM on September 16, 2003.

The address for Internet access for election results is on page 10. On election night, results will be posted on the Internet beginning shortly after 8:00 PM. These results will be updated periodically as ballots continue to be processed throughout the evening.

VOTING-BY-MAIL IS AS EASY AS 1-2-3!

Using the Official Ballot Guide, note the number to the right of the measure response (Yes or No) of your choice. Locate the same number on the Punch Card Ballot.

Example:

1 Looking at the sample Official Ballot Guide (figure 1) you decide to vote yes on the measure. The number of this choice is 41.

2 You place the Punch Card Ballot (figure 2) on a hard, flat surface and locate the same number (41). Using a pen, pencil or any item with a pointed tip, you press straight down on the small black dot above the number of your choice.

3 While pressing down, slowly lift the top of the Punch Card Ballot with your other hand until the rectangle containing the black dot is completely detached (figure 3).

Remember: To make sure you have voted correctly, check to see that the number of the selection of your choice matches on both the Punch Card Ballot and the Official Ballot Guide.

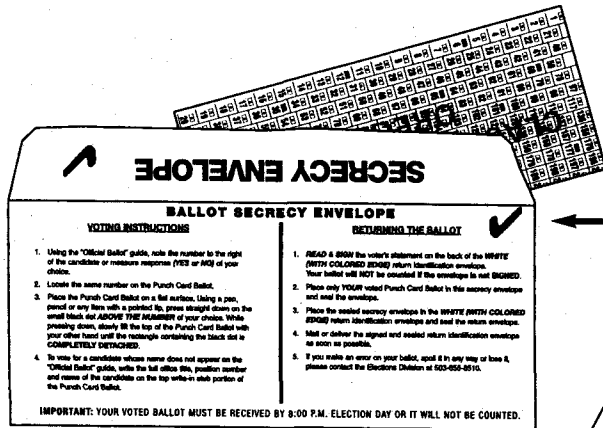

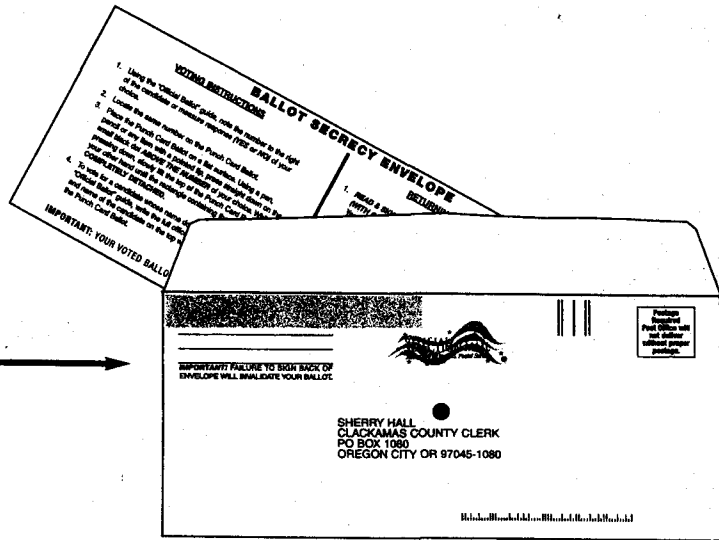

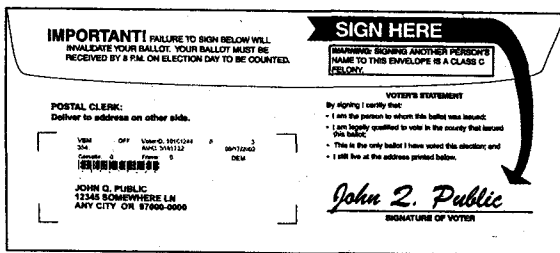

BALLOT TITLE

EXPANDS OREGON CITY BOUNDARIES TO INCLUDE ADDITIONAL LAND

QUESTION: Shall the City's boundaries include 13.6 acres of additional land on the southwest edge of the City?

SUMMARY: This measure would expand the City's boundaries by approximately 13.6 acres by including within the City property described as follows:

A 13.6-acre tract comprised of two tax lots located on the southwest edge of the City, on the east side of Leland Road, more particularly: Tax Lot 1900 SE ¼ of SE ¼ of Section 7, and Tax Lot 400 SE ¼ of Section 7, T3S R2E, W.M., Clackamas County, Oregon.

The annexation proposal was submitted to allow future rezoning and eventual single-family residential development of tax lot 1900 and an addition to a city park from tax lot 400. However, those developments will require further city action and will not be affected by the annexation vote.

The properties are located on Leland Road and contain 13.6 acres with two single-family dwellings and a population of 3. The properties are currently zoned FU-10 "Future Urbanizable" and are located within the City's UGB. The County's "Oregon City Area Land Use Plan" designates the property Low Density Residential.

The City Commission has concluded that it meets all state, regional and City requirements for annexation into the City and services can be adequately provided to the property. The Commission's report is available from the City Recorder at 320 Warner-Milne Road, Oregon City, OR 97045.

EXPLANATORY STATEMENT

The territory to be annexed is located generally on the southwest side of the City on the east side of Leland Rd. It contains two tax lots totaling 13.6 acres, with two single-family residences, a population of 3, and is valued at \$553,300.

The property owner of Tax Lot 1900 desires city services to facilitate development while the owners of Tax Lot 400 are in the process of splitting the tax lot into two with the majority being added to Wesley Lynn Park property via a lot line adjustment. Both the City and the owner of Tax Lot 1900 will benefit from this annexation as it will facilitate joint construction of the extension of Frontier Parkway, an important connection in the City's street system, as well as the access to the park.

Upon approval, the territory will be withdrawn from Clackamas County R.F.P.D. #1 and the County Service District for Enhanced Law Enforcement as allowed by statute.

REGISTERING TO VOTE?

Q: Who may register to vote?

A: Anyone who is:

- ◆ A resident of Oregon;
- ◆ A United States citizen; and
- ◆ 18 years of age or older.

(If you will turn 18 years of age on or before the date of an election, you may register after the 60th day before the election.)

Q: When may I register?

A: You may register at any time. However, your registration card must be postmarked no later than the 21st day before the election at which you intend to vote.

Q: How do I register?

A: Registration by mail forms are available at your county elections office, most post offices, libraries, Department of Motor Vehicle Offices (DMV), some city halls and schools. In addition, you may download and print a form from the County Clerk's (Elections Division) Home Page. Complete the form and mail it directly to the elections office of the county in which you reside.

Q: What if I need assistance registering to vote?

A: Call the elections office for further instructions at 503-655-8510/TTY 503-655-1685.

Q: Do I have to re-register for each election?

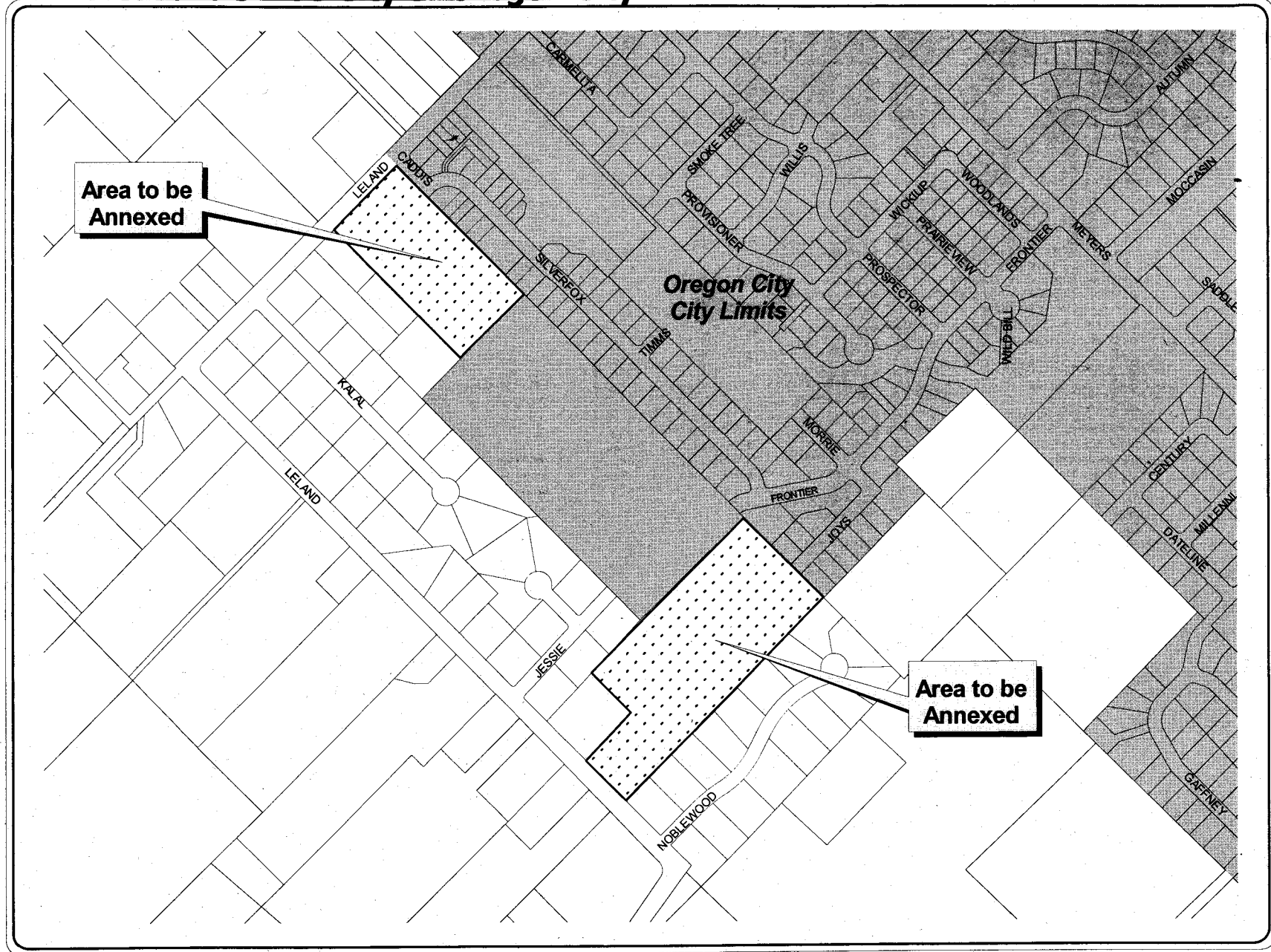
A: No. You only need to update your registration when:

Measure No. 3-107**BALLOT TITLE****ADVISORY VOTE ON FORMATION OF A WESTSIDE URBAN RENEWAL DISTRICT**

QUESTION: Shall a west Wilsonville urban renewal district be formed to fund transportation and other infrastructure improvements using tax increment financing?

SUMMARY: A west Wilsonville urban renewal district is intended to stimulate economic development in underdeveloped areas of the city without increasing property taxes paid by existing residents and businesses.

Westside redevelopment focuses on residential construction to provide needed housing. Investment in streets and other public infrastructure will help leverage State/Federal grants and an anticipated \$500 million in private investment in the local economy.

Tax increment is a financing tool which uses taxes paid on the increased property values within a district to construct urban renewal projects. Revenues will come primarily from the increase in the taxable value of new construction within the Villebois Urban Village. Bond proceeds will be used to pay for needed infrastructure including:

- The Boeckman Road extension,
- A new north-south connector at Kinsman,
- Alternative to Wilsonville Road at Barber,
- Another Old Town/Wilsonville Road connection,
- An elementary school site,
- Parks, playfields, openspace.

If this measure passes, an Urban Renewal Plan defining district boundaries and specific projects will be prepared for review and approval by the Planning Commission before adoption by City Council.

EXPLANATORY STATEMENT

Wilsonville is a growing, dynamic community, but its roads and infrastructure have not kept up with demand, thus affecting the livability of the community. There is insufficient housing for the number of individuals who work in the city. Currently, thousands commuting into Wilsonville daily contribute significantly to the city's traffic congestion.

Villebois, a model urban community planned for the former Dammasch Hospital site, will help address Wilsonville's critical housing shortage by offering diverse housing options for those that now commute here for work. Villebois will also provide a revenue stream from its increased property values that will be used to pay for street and other improvements without assessing new taxes to current residents and businesses.

The proposed urban renewal district boundaries include the area west of Boones Ferry Road (Westside Master Plan area) and the Villebois (Dammasch) Planning area. Only projects located within the specific boundaries of the district can be funded through urban renewal tax increment financing. The proposed projects will improve the transportation grid for west Wilsonville. In addition to new street connections, improvements are also planned for bike and pedestrian connections, utilities, sidewalks, curbs, storm sewers and related infrastructure.

Primary projects in the plan include:

- The Boeckman extension to Tooze Road, for which the city has already obtained \$6 million in state and federal grants

- A Kinsman Road extension to serve as a new north-south connector between Wilsonville Road and Boeckman
- A Barber Road extension to serve as an additional east-west connector north of Wilsonville Road
- A contribution toward the purchase of a new elementary school site
- Development of new parks, playfields and open space
- A second route to connect Old Town to Wilsonville Road on the Westside

The urban renewal contribution to these projects is estimated at \$40 million. These improvements in turn are projected to stimulate \$500 million in private investment. Once the urban village is developed, it will increase Wilsonville's tax base after the bonds are paid off and the district is retired.

The City Council will define the boundaries of a westside urban renewal district and determine the projects to be funded from revenues generated by the district if this measure passes. An intended result of the new district is a better transportation system and public amenities, which will enhance Wilsonville's livability.

Urban renewal allows property taxes already assessed and collected to be bonded to fund capital investments to support community and economic development efforts. Property taxes collected within the district above a base level are placed into an urban renewal fund instead of being divided among other taxing authorities. Bonds are sold based on the increase in property values within the district. These bonds are then repaid out of urban renewal funds.

State law limits the amount of land and assessed value that can be placed within urban renewal districts to 25% of the total land acreage and 25% of the total assessed value of property within the city.

- **An increased property-tax base** over time based on new development that contributes towards providing the community as a whole with additional monies that may be used for parks, playfields, schools, roads and other public amenities.
- **A better economic climate** that encourages shopping, dining and other activities in Wilsonville, directly benefiting local merchants and their employees.

The formation of an urban renewal district provides great benefits for Wilsonville without financial risk to the public coffers and current property-tax payers. Urban renewal allows new development to pay its own way without burdening existing city rate-payers and helps to propel Wilsonville into becoming a better, more self-sufficient community capable of providing greater living and working opportunities.

AURORA FIRE

Measure No. 24-106

BALLOT TITLE

LOCAL OPTION TAX FOR GENERAL OPERATIONS AND CAPITAL PROJECTS

QUESTION: Shall the Aurora RFPD impose a local option tax of \$.68 per \$1,000 for five years beginning 2003?

This measure may cause property taxes to increase more than three percent.

SUMMARY: This measure may be passed only at an election with at least a 50 percent voter turnout. The Fire District will use the tax revenue from this measure for capital projects and general operations. The part for general operations would increase staffing from one person to three personnel. The part for capital projects would include the replacement of a 1974 Fire Engine, the replacement of a 1975 Fire Tanker, replace outdated airpacs and airtanks for firefighting, replace outdated defibrillators for medical calls, purchase a staff vehicle, and purchase property for facility improvements. The proposed rate would raise approximately \$275,885 in 2003-2004, \$284,162 in 2004-2005, \$292,686 in 2005-2006, \$301,467 in 2006-2007, \$310,511 in 2007-2008, for a total of \$1,464,711.

EXPLANATORY STATEMENT

The Aurora Rural Fire Protection District was established in 1948. It covers 64 square miles of property and includes the Cities of Aurora and Donald. It was staffed exclusively by volunteers until 1995. At that time one paid employee was hired to do all of the maintenance, training, record keeping, and respond on calls as an Officer. We now have 47 Volunteer firefighters, who responded to 750 calls of service in 2002, and still only one full time employee. The District needs to hire two more full time employees to provide a safe level of operations.

For the safety of the District patrons and employees, we need to replace some outdated equipment and apparatus. This includes replacing a 1974 Fire Engine, a 1975 Fire Tanker, outdated defibrillators and air packs.

Looking to the future, the District needs to purchase land for facility expansion.

A local option tax of \$.68 per \$1,000 of valuation would fund these necessary equipment replacements and staff increases.
