Approval of Resolution No.1896 to Amend Resolution No. 1893: Authorizing the Execution and Delivery of Documents in Connection with the Financing, Development and <u>Operation of the Easton Ridge Apartments</u>

Purpose/Outcomes	Resolution No. 1896 amends the purchase price wording of the previously approved Resolution No. 1893 from "a minimum" of \$21,130,000" to "a maximum" of \$21,300.000. This is consistent with the Oregon Department of Housing and Community Services 1/24/13 appraisal.

BACKGROUND:

The Housing Authority of Clackamas County (HACC), a Division of the Health, Housing, and Human Services Department, requests approval of Resolution No. 1896 amending Resolution No. 1893 to authorize the sale of the Project from HACC to the Easton Ridge LLC for a maximum purchase price of \$21,130,000, based on a 2012 appraisal.

The Board previously approved this resolution at its January 17, 2013 business meeting; however, that resolution called for the sale of Easton Ridge LLC for a minimum purchase price of \$21,130,000.

As has been previously discussed, multiple funding sources are being coordinated for this Project, including low income housing tax credits allocated by the Oregon Department of Housing and Community Services (OHCS). In connection with its review of the Project, OHCS commissioned a new appraisal of the property to determine the allocation of tax credits. While the new appraisal valued the property at almost \$1 million more than the previous appraisal in 2012; this appraisal included a higher amount for deferred maintenance, which netted out to a lower As-Is Market Value when compared to 2012.

OHCS uses the *As Is Market Value* versus the *Market Value after Renovation* to determine the amount of tax credits to allocate. This change in the *As Is Market Value* translates to a loss of roughly \$455,000 in tax credit equity which will be paid from Easton Ridge surplus funds that will become available at the time the existing 1996 Bonds are retired. There is no impact on county general funds.

RECOMMENDATION:

Staff recommends that the Board approve Resolution No. 1896 amending Resolution No.1893 to authorize the sale of the Project from HACC to the Easton Ridge LLC for a maximum purchase price of \$21,130,000. This change to the Resolution wording is required and is consistent with this revision.

BACKGROUND:

Measure 3-401 was approved by the voters of Clackamas County in September, 2012. The Measure restricts the Board of Commissioners from authorizing the use of County Resources for public rail transit without first obtaining approval of County voters in the form of an authorizing ordinance.

There are pending intergovernmental agreements and transactions related to the Portland Milwaukie Light Rail project that may fall within the terms of Measure 3-401.

The May 21, 2013 election is the first opportunity to place the question before the voters.

The attached Measure, Ballot Title and Explanatory Statement have been reviewed by the Board of Commissioners in two separate study sessions.

DRAFT WHEREAS, Measure 3-401 was passed by the voters of Clackamas County in September, 2012 and is codified in the Clackamas County Code;

WHEREAS, Measure 3-401 requires a public vote before the Board of Commissioners authorizes the use of County resources for Public Rail Transit;

WHEREAS, Clackamas County is a party to agreements that provide for the use of County resources for the Portland Milwaukie Light Rail project;

WHEREAS, the Board of Commissioner intends to allow a public vote on the use of County resources for Portland Milwaukie Light Rail:

MEASURE

The People of Clackamas County ordain as follows:

A. The Board of Clackamas County Commissioners is authorized to use the following County Resources for the Portland Milwaukie Light Rail Line:



Execution of an agreement with TriMet funding \$1,279,740 in road and signalization improvements in the vicinity of Park Avenue, Oatfield Road and McLoughlin Boulevard.

- Transfer to TriMet of a property described as Tax Lots 11 E36CD03300 and 11 E36CD03400, approximately 2,614 square feet in size, for which the County will be credited \$20,915.
- Transfer to TriMet of a parcel of approximately 3,485 square feet in size, for the sum of \$1,360.
- Execution of a Continuing Control Agreement providing that TriMet will control any portions of county-owned streets and sidewalks that will be occupied by light rail tracks or stations.

B. This measure shall become immediately effective upon passage. If any provision of this measure is barred from operation by superior law, the other provisions shall remain unaffected.

Caption

Use of Certain County Resources for Portland Milwaukie Light Rail.

Question

Should Clackamas County use certain county resources to meet previous contractual commitments toward the Portland Milwaukie Light Rail Project?

Summary

In September 2012, County voters approved Measure 3-401, which calls for a public vote before any County resources are used for Public Rail Transit.

In accordance with Measure 3-401, this Measure seeks voter approval of an ordinance authorizing the use of County resources for the Portland Milwaukie Light Rail line. The County is asking for voter approval of these items to comply with the terms of Agreements signed by prior Board of County Commissioners in 2010 and 2012.

If voters approve the Measure:

- The County will fund \$1,279,740 in improvements to roads and signals near the proposed Park Avenue Light Rail Station. The funding sources will be the County Road Fund, along with \$279,740 in Systems Development Charges to be paid by TriMet.
- The County will enter into an agreement allowing TriMet to control portions of county roads and sidewalks occupied by PMLR rail facilities.
- The County will transfer two small parcels to TriMet: A 2,614 square foot parcel valued at \$20,915, and a 3,485 square foot parcel valued at \$1,360.

EXPLANATORY STATEMENT

In September, 2012 County voters approved Measure 3-401, which requires voter approval before the Board of Commissioners authorizes the use of any County resources for public rail transit.

TriMet is constructing the PMLR line, which will run from Downtown Portland to a proposed station near the intersection of Park Avenue and McLoughlin Boulevard. The PMLR line will run along an alignment selected by area governments as the Locally Preferred Alternative in 2008.

In February, 2010, the Board of County Commissioners (Board) approved an Agreement with TriMet for the PMLR project. Under the Agreement, the County agreed to provide \$25 million toward the project, and also agreed to negotiate in good faith for any further agreements that might be necessary to complete the project. The Clackamas County Development Agency and the North Clackamas Parks and Recreation District were also parties to the agreement.

In August of 2012, the Board approved a Supplemental Agreement which reduced the County's cash contribution by \$2.4 million dollars. As part of the agreement, the County agreed to fund road and signalization improvements to roads in and around the intersection of Park Avenue and Oatfield Road. The County also agreed to transfer to TriMet a small (2,614 square foot) parcel of property for which the County will receive a credit of \$20,915.

In addition, this measure addresses a small, landlocked parcel (3485 square feet) that would be conveyed to TriMet for construction of the Trolley Trail and retaining walls. TriMet values the property at approximately \$1,360.

Approval of this measure would constitute approval by the voters of an authorizing ordinance authorizing the following four items related to the Portland/Milwaukie Light Rail line:

- Execution of a funding agreement funding \$1,279,740 in road and signalization improvements in the vicinity of Park Avenue, Oatfield Road and McLoughlin Boulevard. TriMet will pay \$279,740 of that amount in Systems Development Charges, while the remainder will come from the County Road fund.
- Transfer of a property described as Tax Lots 11 E36CD03300 and 11 E36CD03400, approximately 2,614 square feet in size, for which the County will be credited \$20,915.
- Transfer of a parcel of approximately 3,485 square feet in size, for the sum of \$1,360.
- Execution of a Continuing Control Agreement providing that TriMet will control any portions of county-owned streets and sidewalks that will be occupied by light rail tracks or stations. This agreement is required by the Federal Transit Administration.

The actions authorized by this measure would be one-time authorizations that end with the completion of the project. The, cost of staff time for completion of these items would not be likely to exceed \$23,000.

BACKGROUND:

Measure 3-401 was approved by the voters of Clackamas County in September, 2012. The Measure restricts the Board of Commissioners from authorizing the use of County Resources for public rail transit without first obtaining approval of county voters in the form of an authorizing ordinance. North Clackamas Parks and Recreation District ("NCPRD") is legally distinct from the County, and not subject to Measure 3-401. However, NCPRD may seek an advisory vote from its residents if it so desires.

Under the terms of the Funding Agreement between Clackamas County, NCPRD and Trimet entered into in 2010 ("Funding Agreement"), NCPRD has an obligation to negotiate in good faith towards realizing any transactions necessary to accomplish the construction of Portland-Milwaukie Light Rail ("PMLR"). As part of that Funding Agreement, the parties agreed to the "Locally Preferred Alternative" for the route of PMLR, which included locating the final segment of the track on land currently intended for use as part of the Trolley Trail. Negotiations were undertaken and the general outline of the possible transaction is that TriMet would pay NCPRD for the fair market value of the land used, and would assemble and sell to NCPRD replacement land immediately to the west on which the Trolley Trail would be located. As part of that negotiation, NCPRD and TriMet executed a Design and Construction Agreement in May 2012 that allowed TriMet access for certain construction-related activities, and obligated TriMet to build that section of the Trolley Trail at TriMet's expense, saving NCPRD approximately \$400,000. The next anticipated step under the Funding Agreement would be

for NCPRD to sell approximately 2 acres of land and purchase back approximately 1.2 acres of land from TriMet.

The attached Measure, Ballot Title and Explanatory Statement (together, the "Ballot Language") seeks an advisory vote on whether or not to proceed with the next steps. The Ballot Language will be reviewed by the Board of Commissioners in a study session scheduled for February 19, 2013. The Board may request amendments to the draft Ballot Language at the study session that would be incorporated into the draft discussed at this February 21st business meeting.

The NCPRD District Advisory Board is considering this issue and may provide a written recommendation on the matter to the Board prior to this business meeting.

Property exchange between the North Clackamas Parks and Recreation District and TriMet.

Question

Should the North Clackamas Parks and Recreation District exchange a portion of the Trolley Trail with TriMet for Light Rail?

Summary (175 words)

In September, 2012, County voters approved Measure 3-401, calling for a public vote before any County resources are used for Public Rail Transit. North Clackamas Parks and Recreation District (NCPRD) is legally distinct from the County, and not subject to Measure 3-401. Any measure binding NCPRD needs to be voted on only by voters within its boundary. However, the NCPRD board is seeking an advisory vote from its voters.

This Question would support the sale of a portion of the "Trolley Trail" property between River Road and Park Avenue to TriMet. In exchange, TriMet would sell to NCPRD a strip of adjacent property, construct the trail without cost to NCPRD, and provide NCPRD with additional compensation.

NCPRD is considering this transaction because, under the terms of a 2010 Agreement with TriMet, NCPRD is obligated to negotiate in good faith to take actions necessary to complete the Portland Milwaukie Light Rail project. The district would also avoid approximately \$400,000 in construction costs and would receive additional cash from the sale.

Explanatory Statement

This Advisory Question asks voters within the boundary of the North Clackamas Parks and Recreation District whether the NCPRD should sell approximately 0.6 miles of the 6-mile Trolley Trail property to TriMet. In exchange, TriMet will sell to NCPRD 0.6 miles of adjacent property and construct the trail at TriMet's cost.

NCPRD acquired the Trolley Trail property, including the segment discussed in this Measure, from Metro in 2005. Under the terms of the agreement with Metro, if the property used is no longer used for green space/trail purposes, NCPRD needs to either repay the cost of the property or purchase replacement green space.

TriMet is constructing the Portland Milwaukie Light Rail line (PMLR), which will run from Downtown Portland to a proposed station near the intersection of Park Avenue and McLoughlin Boulevard. The PMLR line will follow an alignment selected by area governments as the Locally Preferred Alternative in 2008. In 2010, NCPRD along with Clackamas County signed an agreement recognizing this route and agreeing to negotiate in good faith to complete all transactions necessary related to the same.

In 2012, the NCPRD Board authorized TriMet to begin construction activities on the Trolley Trail in return for a guarantee that TriMet would construct that portion of the trail at TriMet's expense, currently estimated at \$400,000.

The portion of the Trolley Trail at issue runs from River Road to Park Avenue, adjacent to McLoughlin Boulevard.

Under the terms of the transaction, NCPRD would sell approximately 2 acres of the Trolley Trail property to TriMet for the Portland/Milwaukie light rail project. TriMet would in turn sell to NCPRD the adjacent strip of property, approximately 1.2 acres, and construct the Trolley Trail. TriMet would compensate NCPRD for the difference in value between the two properties.

This Measure asks the NCPRD voters whether the NCPRD Board should go forward with the property transaction.

Should the NCPRD sell a portion of the "Trolley Trail" property to TriMet, where TriMet would:

- Sell a strip of adjacent property to NCPRD for the trail;
- Construct that section of the trail without cost to NCPRD; and
- Provide NCPRD with additional compensation to make up the difference in value?

NCPRD is considering this transaction because, under the terms of a 2010 Agreement with TriMet, NCPRD is obligated to negotiate in good faith to take actions necessary to complete the Portland Milwaukie Light Rail project. The district would also avoid approximately \$400,000 in construction costs and would receive additional cash from the sale.

Explanatory Statement

This Advisory Question asks voters within the boundary of the North Clackamas Parks and Recreation District whether the NCPRD should sell approximately 0.6 miles of the 6-mile Trolley Trail property to TriMet. In exchange, TriMet will sell NCPRD 0.6 miles of adjacent property; construct the trail at TriMet's cost and provide NCPRD with additional funds. NCPRD acquired the Trolley Trail property, including the segment discussed in this Measure, from Metro in 2005. Under the terms of the agreement with Metro, if the property is used is no longer used for green space/trail purposes, NCPRD needs to either repay the cost of the property or purchase replacement green space.

TriMet is constructing the Portland Milwaukie Light Rail line (PMLR), which will run from Downtown Portland to a proposed station near the intersection of Park Avenue and McLoughlin Boulevard. The PMLR line will follow an alignment selected by area governments as the Locally Preferred Alternative in 2008. In 2010, NCPRD along with Clackamas County signed an agreement recognizing this route and agreeing to negotiate in good faith to complete all transactions necessary related to the same.

In 2012, the NCPRD Board authorized TriMet to begin construction activities on the Trolley Trail in return for a guarantee that TriMet would construct that portion of the trail at TriMet's expense, currently estimated at \$400,000.

The portion of the Trolley Trail at issue runs from River Road to Park Avenue, adjacent to McLoughlin Boulevard.

Under the terms of the transaction, the NCPRD would sell approximately 2 acres of the Trolley Trail property to TriMet for the Portland/Milwaukie light rail project. TriMet would sell the NCPRD the adjacent strip of property of approximately 1.2 acres, and construct the Trolley Trail. TriMet would compensate the NCPRD for the difference in value between the two properties.

This Measure asks the NCPRD voters whether the NCPRD Board should go forward with the property transaction.
