

Appointed Boards and Commissions (ABCs) Recommendation

The District Advisory Committee (DAC), staffed by the North Clackamas Parks and Recreation District (NCPRD), currently has 4 openings on their committee due to term expirations and resignations. Eleven members are allowed with four-year terms.

Recruitment opened to the public on 4/3/2024 and closed on 5/30/2024. Recruitment took place by press releases, Facebook, Nextdoor, NCPRD website, and the county website. Through this recruitment process, 10 applications were received and 4 were recommended to be appointed. Three applicants are new and 1 applicant is currently on the board.
