Opioid Settlement & BHRN Update - Apryl Herron & Mary R.	<ul style="list-style-type: none">➤ BHRN Update 7 dimensions of services, 17 entities, 2 organizations working to lift up the 24hr peer screening line. Required to have a low barrier screening tool to assist with referrals. 12 offer peer services. Working to have someone be a part time coordinator and keep the BHRN on track and keep the group functioning. Measure 110 may be repealed depending on elections. Mary feels there are a lot we should keep an eye on with elections coming up. Pam said that a gap analysis was done after the fact of measure 110 and that should have been done prior. There are four areas that the strategic plan will focus on: Youth and young adults, means safety, health care, and community. Each focus area will have its own subcommittee to address strategic goals - these committees will meet monthly, and the coalition will now meet quarterly. Quarterly Coalition meetings will be 4:30 - 6pm January 17th, April 18th, July 18th. ➤ Work Force Updates - Adjustments are being made for getting licensed in Oregon. Language regarding Washington hours being approved Oregon.
