Amendment value is \$29,818 for 1 year. Contract value increased to \$177,318.00 for 6 years.

Funding is through the State of Oregon Public Health Modernization.

**EXECUTIVE SUMMARY:** The Clackamas County Public Health Division (CCPHD) of the Health, Housing & Human Services Department requests the approval of Amendment #1 to the Technology Services Agreement with Conduent Healthy Communities Corporation for the Public Health Community Data Dashboard.

This Amendment is to continue access to Conduent’s central database, which assists with implementing the Blueprint for Healthy Clackamas County Initiative. This product includes mapping and data visualization tools, data dashboards, over 100 health and quality of life indicators, promising practices, social needs indexes, local resources, and information on health-related community engagement activities happening across Clackamas County. This technology is essential in helping to provide timely public health information to partner organizations and community members looking for information about the health of the County.

**RECOMMENDATION:** Staff recommends that the Board approve Amendment #1 to Intergovernmental Agreement #8510.

**AMENDMENT #1  
TO THE CONTRACT DOCUMENTS WITH Conduent Healthy Communities Corporation FOR  
HCI Platform Software Licenses  
Contract #8529 H3S #8510-01**

This Amendment #1 is entered into between **Conduent Healthy Communities Corporation** (“Contractor”) and **Clackamas County** (“County”) and shall become part of the Contract documents entered into between both parties on **October 9, 2018** (“Contract”).

The Purpose of this Amendment #1 is to make the following changes to the Contract:

1. ARTICLE I, Section 1. **Effective Date and Duration** is hereby amended as follows: The Contract termination date is hereby changed from September 30, 2023, to **September 30, 2024** (“Extended Term”).

2. ARTICLE I, Section 3. **Consideration** is hereby amended as follows:

In consideration for County’s use of the Licenses and Services for the extended term of the Contract, County agrees to pay Contractor an amount not to exceed \$29,818. This amount reflects the following annual License amounts:

- a) License – Annual Standalone Platform fee is modified from \$25,000 to \$27,318.
- b) License - Annual Consumer Expenditure will remain the same at \$2,500.

The total Contract compensation will not exceed \$177,318.
