

Appointed Boards and Commissions (ABCs) Recommendation

The Veterans Advisory Council, staffed by the Department of Health, Housing and Human Services Social Services Division, currently has 6 openings on their commission due to term expirations and resignations. 19 members are allowed with 2-year terms.

Recruitment opened to the public in December 2023 and closed on January 25, 2024. It was then re-opened on February 8, 2024 and closed on March 1, 2024. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, 3 applications were received and 2 were recommended to be appointed. 3 applicants are new and 0 applicants are currently on the board. Interviews were conducted with all eligible applicants.
