NOTE TO APPLICANT: Sections 104.11 of the *current Oregon Residential Specialty Code* grant the Building Official the ability to consider alternatives to or modifications of the Code in unusual cases. It is the policy of Clackamas County Building Codes Division that the use of these Sections of the Code be limited, and that individual cases be considered carefully within the context of the requirements of these provisions.

This application is specific to and limited to the project identified above.

- A. <u>Section 104.11: Alternate Materials, Alternate Design and Methods of Construction:</u>
- 1. Pursuant to Section 104.11 of the *Oregon Residential Specialty Code*, the undersigned Applicant hereby requests approval of an alternative to Section of the Code, which requires that (cite that portion of the Code from which the Applicant is seeking relief based upon the proposed alternative):

Alternative proposal to the barrier requirements for residential swimming pools, Appendix G, Sections AG105.1-AG105.2.

2. The undersigned Applicant proposes the following alternative to Section <u>AG105.2</u> of the *Oregon Residential Specialty Code* (provide a detailed description of your proposed alternative):

We are proposing a powered safety cover complying with ASTM F1346 in place of the barrier around the swimming pool required in Appendix G of the 2017 ORSC. This is allowed per the 2015 International Residential Code (IRC) in Section R326.1 which refers to the 2015 International Swimming Pool and Spa Code (ISPSC). Section 305.1 Exception #2 of the ISPSC exempts residential swimming pools from the barrier requirements with a powered safety cover that complies with ASTM F 1346.

3. For the following reasons, Applicant believes that the proposed alternative to Section <u>AG105.2</u> of the *Oregon Residential Specialty Code* complies with the provisions of the Code, and that the material, method or work offered is, for the purpose intended, <u>at least</u> the equivalent of that prescribed in this Code in suitability, strength, effectiveness, fire resistance, durability, safety and sanitation.

The 2015 IRC and 2015 ISPSC are model codes for the 2017 ORSC and as the base national codes for the state specialty code, can be considered as suitable alternative paths for the intent of providing the equivalent safety protection.

The undersigned acknowledges that any delay by the County with respect to enforcing strict compliance with any conditions imposed on any permit(s) issued based upon the proposed alternative(s) or modification(s) shall not be deemed to be a waiver and shall not stop or bar the County from enforcing compliance with any conditions, including the County's right to issue, cease and desist orders and/or to seek immediate relief, as appropriate.
