Approval of a Board Order to authorize a Purchase Order to SHI International for authentication systems and enhanced customer support. Total Contract Value is \$258,195.13 for 2 years. Funding is through County-approved American Rescue Plan Act funds and \$186,225.17 of budgeted departmental cost allocations, which does include a small portion of budgeted County General Funds.

EXECUTIVE SUMMARY: SecureAuth IdP is a flexible, adaptable identity and access management solution that was originally implemented by Technology Services (TS) in March of 2021 to help improve the County's cybersecurity posture by reducing identity related breaches. In March 2024, TS used initial ARPA funds to implement a project to migrate the County's authentication system to a disaster resilient hybrid cloud model. This project required an upgrade to our support contract with the vendor. The new proposed contract will use ARPA and budgeted County funds to extend the County's use of this product through March of 2027.

Of the \$258,195.13 contract value, \$71,969.96 are ARPA related funds that will pay for enhanced support through 12/31/2026. The remaining \$186,225.17 for the SecureAuth IdP Platform and the remaining 3 months of enhanced support not covered by ARPA funds will be paid using budgeted departmental cost allocations.

RECOMMENDATION: Staff respectfully recommends the Board of County Commissioners approve the Board Order allowing the purchase of SecureAuth IdP and enhanced support through SHI using Omnia Partners - IT Solutions Cooperative Contract # 2018011-02.

Whereas, Omnia Partners IT Solutions, a cooperative purchasing entity, established a cooperative contract, contract number 2018011-02, with SHI International Corp (“SHI”) for the purchase of information technology solutions products and services;

Whereas, the Clackamas County Technology Services Department (“TS”) currently needs to renew the County’s SecureAuth licenses;

Whereas, TS desires to utilize the aforementioned cooperative contract with SHI to purchase licenses in an amount not to exceed \$258,195.13;

Whereas, TS requests authority to purchase the aforementioned software and services by issuance of a purchase order (“PO”); and

Whereas, POs are issued directly through the Clackamas County Department of Finance’s management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:

1. The requested purchase of the aforementioned software and services from SHI, in an amount not to exceed \$258,195.13, is hereby approved; and
2. The Clackamas County Department of Finance is hereby delegated limited authority to issue a PO for the aforementioned software and services.
