WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

This policy session is a follow-up from the November 2021 policy session during which the Board approved proceeding with the library with a \$7 million budget. We request direction from the Board regarding next steps in the construction of the Gladstone Library in light of significant cost increases.

EXECUTIVE SUMMARY:

Since November 2021, two major funding issues have arisen: 1) questions about repayment of a revenue bond using library operating funds and 2) construction cost increases (Attachment A).

- Revenue Bond Repayment (\$2.1 million) -- The initial funding package included a revenue bond that would be repaid by County General Funds (\$3.9 million) and Library District operating funds (\$2.1 million). However, the Library Master Order and Master IGA approved several years ago restrict the use of Library District funds to operations only. In light of this, Stakeholders raised significant concerns regarding the inclusion of these funds for construction for the Gladstone and Oak Lodge libraries.
- 2. Construction Costs (\$2.4 million) -- The construction industry remains extremely volatile. Public bid, construction manager/general contractor (CMGC) design-build projects in the first quarter of 2022 routinely came in approximately 30% over estimated budgets, with some even coming in 100% over budget. The main causes of this volatility include:
 - Prices of construction materials jumped more than 20% from January 2021 to January 2022, according to an analysis by the Associated General Contractors of America.
 - Material shortages that were projected to be resolved the second quarter of 2022 are now forecasted to continue.
 - Labor shortages and labor cost increases continue both in management and in the field. Labor rates have increased approximately 9% for carpenter/drywall/framing unions and others.
 - Material costs are rising because of the limited availability of materials and resources.
 - These material and labor challenges have resulted in extended construction schedules. A project that used to take 9-10 months to build, now takes 10-11 months to complete.
 - Because of capacity limitations and an abundance of projects, subcontractors are being very selective, which reduces the number of bidders for projects and raises the cost estimates.

This aligns with the BCS strategic result of preserving, improving, and enhancing the quality and capacity of managed properties and facilities. The construction of the new libraries supports the Oak Lodge and Gladstone Library program so the public can access publically funded diverse materials and services to achieve their individual goals.

How does this item align with the County's Performance Clackamas goals?

This project aligns with the Vibrant Economy Goal: It provides economic development, public spaces, and community enrichment services to residents, businesses, visitors, and partners so they can thrive and prosper in healthy and vibrant communities.

LEGAL/POLICY REQUIREMENTS:

The IGA between the County and the City of Gladstone includes a commitment from the County to construct and manage two libraries: Gladstone and Oak Lodge.

PUBLIC/GOVERNMENTAL PARTICIPATION:

A number of public outreach strategies were initiated to reach the widest audience. Public input ranged from in-person interviews with teens, residents and staff, to an on-line open house. Project information and events were advertised via multiple methods, with a dedicated project website to share information, surveys and updates. A dedicated Planning Task Force was created made up of residents from the Gladstone Library Service area, and members of the Gladstone Library Advisory Board, Gladstone Library Foundation Advisory Board and Clackamas County Library Board of Trustees.

OPTIONS:

The following options are presented to address the funding needs:

A. Revenue Bond Payment Options

- A. Amend the Master Order
- B. Use County funds to pay the library portion of the bond

B. Construction Cost Escalation

- 1. Pay additional costs with County General Funds and/or explore the use of County ARPA funds
- 2. Reduce costs with additional value engineering
- 3. Stop the project and pay IGA termination fee (\$360,000)
- 4. Delay the project to provide time for the market to stabilize (amend the IGA)
