#### BACKGROUND:

The Social Services Division of the Health, Housing and Human Services requests approval of amendment #1 to Agreement #18944 with Ride Connection, Inc. This agreement passes through STIF funding to be specifically used for dedicated dialysis rides provided by the Social Services Transportation Reaching People (TRP) program. This agreement provides continuation funding for the portion of the rides that are provided inside the TriMet District to areas that have been designated high equity needs area by the TriMet HB 2017 Transit Advisory Committee. This project helps riders to remain independent in meeting their dialysis treatment needs for as long as possible.

The TRP program provides rides in either a lift equipped mini-buses or mini-vans driven by paid staff as well as with volunteer drivers providing rides in their own vehicles. TRP provides transportation to dialysis clinics located throughout the county and in the greater Portland-metro area in these vehicles. When possible, riders with a similar destination and arrival times ride together to increase program efficiencies. Generally, transportation is provided weekdays between 8:00 am and 5:00pm.

This amendment adds another year to the total contract length and increases the total funding for the two year period to \$169,198. This contract is late due to Ride Connection not being able to release agreements/modifications to its sub-contractors until their funding source released their contract and approved the Subrecipient agreements issued by Ride Connection. The maximum funding for this agreement is \$169,168. The term of the agreement is July 1, 2021 to June 30, 2023. County Counsel reviewed and approved this agreement on September 30, 2021 and the amendment on July 19, 2022.

No County General Funds are involved. No matching funds are needed. This amendment provides the second year of the two-year grant funding that was awarded during the January 2021 application cycle.

#### **RECOMMENDATION:**

Staff recommends the Board approval of this agreement and that the Board Chair, or her designee, to sign on behalf of Clackamas County.

#### CONTRACT MODIFICATION #1 to 18944 Between Ride Connection, Inc., and Clackamas County, by and through its Health, Housing and Human Services Department Social Services Division Original Contract Dated 7/1/2021

**Ride Connection, Inc.** (hereinafter "Ride Connection") and **Clackamas County, by and through its Health, Housing and Human Services Department Social Services Division** (hereinafter "Contractor") agree to the following terms and conditions of the contract cited above:

#### 1. Recitals 7., is deleted in its entirety and replaced with the following:

Pursuant to ORS Chapter 184 and OAR Chapter 732, Divisions 40 and 42, TriMet and Subrecipient enter into this Agreement for the sole purpose of disbursing the approved STIF Formula Funds to Subrecipient in order for Subrecipient to complete one or more projects specified in the approved FY2022-23 STIF Plan. Maximum amount of Grant funds shall not exceed **\$169,198**. These funds shall be used solely for the Project(s) and not be used for any other purpose.

## 2. Section 1, <u>Term</u>, is deleted in its entirety and replaced with the following:

The term of this contract shall begin on 7/1/2021 and shall remain in effect through 6/30/2023 unless terminated sooner under the provisions of this Agreement.

## 3. Section 12. B., Funding, is deleted in its entirety and replaced with the following:

In accordance with the terms and conditions of this agreement, Ride Connection shall provide Contractor an amount not to exceed **\$169,198** for an increase of **\$85,850** of Grant Funds for eligible project costs as in Exhibit A.

# 4. Exhibit A, Project STIF Funds Total, is deleted in its entirety and replaced with the following:
