| Committee Reports All | Advocacy/Legislative Committee - Michele asked about how the meeting went regarding SB137. Mary advised that counties sent letters opposing the bill. She said the bill did not move out of the committee. She advised that if they don't go to work session's bill usually dies. <br> > Mary advised that she testified at OHA's budget meeting specific to BH and the importance of county safety net services. <br> Mary talked about SB763 and read what the Clackamas County lobbyist had written. NAMI is working on this bill to define verbiage re: civil commitment and what "danger to self \& others and imminent danger means. <br> > There was discussion regarding a farm bill and that it includes verbiage regarding SNAP benefits. <br> NAMI is taking a stance nationally regarding ERPO and not taking guns due to certain diagnosis. <br> Teresa talked about a bill regarding marijuana tax paying for treatment and how the state ended up using the tax money to fill the budget gap rather that for treatment. <br> Nominating Committee - Natalie advised there were a few applicants.
