Purpose:

Informational update only – Staff from Fengate and PCL will be present to provide an update regarding the replacement courthouse.

Background:

The current courthouse was built in 1936 and has earthquake risks, multiple safety concerns and limited space which results in delays in justice for county residents.

Fengate PCL Progress Partners (FP3) was the successful bidder to design, build, and partially finance a new courthouse at the Clackamas County Red Soils Campus. Construction of the courthouse is expected to be completed in 2025.

Clackamas County and FP3 have entered into a public-private partnership.

Prior BCC Action:

The Board of County Commissioners approved selecting a contractor to begin construction on a replacement courthouse on June 29, 2022.




