## Appointed Boards and Commissions (ABCs) Recommendation

The Housing Advisory Board, staffed by the Housing Authority of Clackamas County, currently has 11 openings on their commission due to term expirations and vacancies. ## Appointed Boards and Commissions (ABCs) Recommendation

The Public Health Advisory Council, staffed by the Public Health Division, currently has 16 openings on their council due to being established as a newly formed advisory council to the BCC. Sixteen (16) members are allowed with three year staggered terms.

Recruitment opened to the public on 12-16-20 and closed on 2-1-21. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, 47 applications were received and 16 were recommended to be appointed. Sixteen applicants are recommended for appointment. After paring down the list of candidates from 47 to 29 candidates, the 29 remaining applicants were asked to complete a supplementary questionnaire and pared down to 16.
