EXECUTIVE SUMMARY: The purpose of this request is to approve the purchase and implementation of VMware Cloud Disaster Recovery (VCDR). Clackamas County has made significant investments in VMware technology to support the operational functions of County applications, data, and related services. This purchase expands on that investment by providing recovery services to protect critical technology services against regional outages, natural disaster, ransomware, or other threats. The VCDR solution provides immutable recovery points, guided restores, and cloud enabled services for rapid recovery. We are seeking approval for a 3 year contract with CDWG, for a total contract value of \$788,417.91 using Cooperative Contract: National IPA Technology Solutions (2018011) for services and support through 06/31/2027. ARPA funds totaling \$515,239.54 to be paid in FY 23/24 covering year 1 and 2, and TS fund 747 will be responsible for year 3 payment of \$273,178.37 in FY 25/26.

RECOMMENDATION: Staff respectfully recommends the Board of County Commissioners approve the Board Order allowing the purchase of VMware Cloud Disaster Recovery (VCDR) through CDWG.

Whereas, the Clackamas County Department of Finance requests authority to purchase the aforementioned goods and services by issuance of a purchase order (“PO”); and
