

**Because less than 30 questionnaires are included in this report, each graph and table display counts rather than percentage information.











1549436	My kids walk home despite some of my concerns for health and convenience reasons. But having sidewalks would make me feel SO much better! Sidewalks on the route particularly Shafford and Ginseng crosswalk on Pierce from CR Elementary
1549447	My kids walk with a group of kids or they don't walk at all. My kids sometimes walk home with friends to go to their place since we are homeless and staying in Portland.
1549450	We live up very steep hill (problem #1). We have one mile on high speed highway (prob #2). Another uphill route w/o bike lane (prob #3).
1549443	None. I don't feel my child is responsible enough to walk bike to school.
1549448	We don't live downtown Estacada.
1549439	My children walk to the library after school then catch a transit bus. I wish the path to the library was more safe + had sidewalks. MANY children walk this route.
1549451	We live just minutes from all three schools, but the bus picks up @ 6:50 giving an hour bus route. She could get another hour of sleep if the bus picked up later or the school opened sooner allowing for parent drop-off.
1549445	Rural school distances too great to promote either walking or bike.
1549442	We are over 20 miles outside of town. Under NO circumstances would my child ever walk/bike to school. Sorry!
1549456	We live to far form the school. The roads condition & lack of sidewalks make it hard for me to even walk her. It is too dangerous for her to walk alone.
1549455	Not all the children have the means to have proper attire- jackets, hats, shoes that don't "flip-flop" to be walking in all kinds of weather. Crosswalks needed to cross Cemetary Rd at the walk path & at Foothills.
1549457	We live close to Colton than Estacada. Walking is only an option if we have after school activities.
