RE: AntFarm Molalla Resource Center Grant Agreement Update

DATE: March 11, 2025

REQUEST: Staff requests the Board be informed of an upcoming Consent Agenda item for Board action.

BACKGROUND: In April of 2024, the Board approved funding recommendations pursuant to the county's Notice of Funding Opportunity for City-led Homelessness Initiatives. This included an award to AntFarm for acquisition and improvement of a property in Molalla to use as a supportive services resource center. The grant agreement to fund this property acquisition is currently pending AntFarm's signature and will appear on the Board's consent agenda on March 20, 2025. The total value of the grant is \$735,800. Funding is through Oregon Housing and Community Services. No County General Funds are involved.

AntFarm's application was approved with the condition of a statement of support from the City of Molalla, which the city provided in January of 2024. In January of 2025, Health, Housing and Human Services provided AntFarm with a letter of intent to award the funds for purchase of a property located at 106 E 2nd Street, Molalla, Oregon, 97038.

Through acquisition of the property, AntFarm will further its mission of serving rural families by offering services to people experiencing or at risk of experiencing homelessness at a comprehensive resource hub. Services will include homelessness prevention, transition and placement services, addiction services, financial literacy, employment, job training and retention education, peer support services, workplace support, access to shelter services, and other housing services that stabilize people experiencing homelessness and housing instability.

RECOMMENDATION: None at this time, but an item recommended for approval will appear on the Board's March 20, 2025 Business Meeting Consent Agenda.

WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Health, Housing & Human Services is seeking Board approval of funding recommendations for proposals submitted in response to the Notice of Funding Opportunity for city-led homeless services initiatives.

EXECUTIVE SUMMARY:

In working to improve coordination and collaboration, increase geographical distribution of services, and support local leaders in tailoring approaches to addressing housing insecurity and homelessness that best suit their communities, Clackamas County released a Notice of Funding Opportunity (NOFO) in December 2023 for city-led homelessness initiatives (see Attachment 1 for full text of the NOFO). The NOFO was funded by \$5.0 million in Supportive Housing Services (SHS) funds allocated by the Board of County Commissioners as part of the plan for one-time and limited-term uses of the SHS carryover balance, along with funding from the State of Oregon, budgeted County General Funds, and other funds.

The Notice of Funding Opportunity was intended to spur creativity and innovation at the city level, empowering local leaders to supplement the often highly effective but under resourced local efforts to meet the needs of very low income households in their cities. Allowable initiative categories were very broad and included outreach and engagement, emergency shelter and navigation, housing services, health and wellness, advocacy, and employment and benefits. Proposals were requested to:

- Identify the proposing city and any partnering agencies or community based organizations.
- Describe the need or infrastructure/service gap that exists in the community, including any populationspecific needs.
- Articulate the proposed investment and its connection to the recovery-oriented needs of low- and extremely-low income households experiencing housing instability or homelessness.
- State whether the investment is one-time or limited-term. If limited-term, state the requested duration.
- Provide a high-level budget with costs broken out by capital, personnel, and materials and services.
 Include the total number of full-time equivalent (FTE) positions that will be funded any applicable line-level detail, distinguishing between one-time and limited-term costs.
- Information on community engagement, outreach, or other public communication that has been conducted on the project to date and future plans for those activities.

Health, Housing & Human Services received more than \$30 million in requests submitted by eleven cities in dozens of distinct proposals. The list of all proposals by city and amount is included as Attachment 2. Because Supportive Housing Services funds are restricted for use within the Metro area Urban Growth Boundary (UGB), proposals have been grouped as "Urban City Proposals" and "Rural City Proposals." Staff reviewed each proposal against the following criteria:

- Clear alignment with county goals and priorities for its recovery-oriented homeless services system of care
- 2. Additive to the system, consistent with the requirement that Supportive Housing Services investment supplement, not supplant, existing investments.
- 3. Leverage connection points to the broader recovery-oriented system of care.
- 4. Duration not longer than three years, recognizing that the Notice of Funding Opportunity was for one-time and limited-term investments. (Exception being the capital projects in Estacada and Molalla, which received preliminary intents to award through a prior Notice of Funding Opportunity.)

Staff have summarized each of the proposals by city with the requested funding amount and duration. They have also provided a recommendation for each of the proposals. This information is included in Attachment 3.

In total, staff have recommended funding at least one proposal from each of the 11 submitting cites and 20 proposals totaling more than \$7.2 million over three years, starting in Fiscal Year 2024-25 and running through FY 2026-27.

Clackamas County was allocated \$2.0 million by the State Legislature in 2022 in House Bill 5202 for shelter services and infrastructure, hygiene services, and homeless outreach. Health, Housing & Human Services has prioritized these resources for investment in infrastructure in rural communities as part of its overall effort to reposition all non-SHS local, state, and federal funding to fund housing and homeless services of the UGB. Similarly, the department has existing budgeted County General Funds committed to housing and homeless services available to use for rural area investments (no new County General Funds are required).

Subsequent to Board approval of recommendations, staff will draft respective intergovernmental agreements, grants, and/or contracts. Each of these agreements will come to the Board for formal approval at a later time.

Rural Area Resource Centers

Health, Housing & Human Services issued a Notice of Funding Opportunity in August 2023 for Supportive Services Resource Centers. AntFarm submitted a proposal to that NOFO requesting one-time capital and ongoing operations funding to establish a resource center in each Sandy, Estacada, and Molalla. AntFarm was issued an intent to award funds, but the award to site one or more of the resource centers was contingent upon approval from the respective city. Staff have been working with AntFarm and these cities to hear concerns and develop program model(s) that meet the unique needs of each community. As part of the city-led initiatives process, Estacada and Molalla have submitted letters of support in favor of AntFarm's proposal. Staff have proposed to fund the capital acquisition/improvement of a site in each Estacada and Sandy through the city-led initiatives process with HB 5202 funding. Ongoing operations, which is anticipated to cost approximately \$1.0 million per year for each site, will be funded with homeless services funding from the state. Acquisition/renovation will be contingent upon securing ongoing operations funds.

Re: Notice of Funding Opportunity for City-led Homelessness Initiatives

Overview

In working to improve coordination and collaboration, increase geographical distribution of services, and support local leaders in tailoring approaches to addressing housing insecurity and homelessness that best suit their communities, Clackamas County is releasing this Notice of Funding Opportunity for city-led homelessness initiatives. Through its Health, Housing & Human Services Department, Clackamas County anticipates allocating more than \$5.0 million in funding towards one-time and limited-term pilot projects. Proposed initiatives should have a clearly articulated connection to the needs of low- and extremely-low income households experiencing housing instability or homelessness and support the county's recovery-oriented system of care.

City-led Homelessness Initiatives

Qualifying city-led homelessness initiatives should be one-time or limited-term investments in capital infrastructure and/or pilot programs for services that have the support of local leaders and are tailored to meet the needs of a specific community. There is no one-size-fits-all approach to addressing housing insecurity and homelessness. This funding opportunity is intended to spur creativity and innovation at the city level, empowering local leaders to supplement the often highly effective but under resourced local efforts to meet the needs of very low income households.

The county will enter into intergovernmental agreements with cities or directly contract with city-identified community based organizations to fund successful proposals. Cities are not expected to assume responsibility for administering homeless services programs. As the county's largest safety-net service provider and funder, the county anticipates retaining this responsibility and is committed to partnering with cities to structure the administration of investments in ways that meet city needs.

Allowable Initiative Categories

Proposed initiatives should have a clearly articulated connection to the recovery-oriented needs of low- and extremely-low income households experiencing housing instability or homelessness. Allowable investment categories include, but are not limited to:

Outreach & Engagement Supports

- Street outreach services
- In-reach services
- Basic survival support services

Housing Services

- Supportive housing
- Long-term rent assistance
- Short-term rent assistance
- Housing placement services
- Eviction prevention

Health & Wellness Supports

- Mental health services
- Interventions and addiction services
- Physical health services
- Nutritional support services, food banks
- Intervention services with physical impairments and disabilities
- Peer support services
- Discharge intervention services

Emergency Shelter & Navigation

- Sanctioned camping infrastructure
- Village-style shelter
- Congregate shelter
- Non-congregate (hotel) shelter
- Navigation, resource, or access centers

Advocacy Supports

- Landlord tenant education and legal services
- Fair housing advocacy

Employment & Benefit Supports

- Financial literacy services
- Employment services
- Job training and retention services

Proposal Requirements

In no more than four pages, proposals should:

- Identify the proposing city and any partnering agencies or community based organizations.
- Describe the need or infrastructure/service gap that exists in the community, including any population-specific needs.
- Articulate the proposed investment and its connection to the recovery-oriented needs of low- and extremely-low income households experiencing housing instability or homelessness.

- State whether the investment is one-time or limited-term. If limited-term, state the requested duration.
- Provide a high-level budget with costs broken out by capital, personnel, and materials and services. Include the total number of full-time equivalent (FTE) positions that will be funded any applicable line-level detail, distinguishing between one-time and limitedterm costs.
- Information on community engagement, outreach, or other public communication that has been conducted on the project to date and future plans for those activities.

Proposals can be fully-formed or conceptual. The county is committed to engaging successful proposers in an interactive process to shape investments to best meet community needs.

Proposal Review & Selection

Proposals will be reviewed starting on **January 31, 2024**. The review and selection of proposals will be based on:

- Promoting the equitable geographic distribution of services.
- Reducing homelessness or the risk of homelessness.
- Enhancing the capacity of local communities.
- Incorporating culturally response practices.

More than \$5.0 million in funding is available. The county is committed to funding as many proposals as possible, but the ability to do so will be based on the sum of proposal budgets.

In the spirit of partnership, submissions and inquiries for collaboration will be welcome after January 31, 2024, but availability of funding cannot be guaranteed.

Re: Summary of City-led Initiatives Proposals & Recommendations

This memo provides a summary and staff funding recommendations for proposals received as part of the county's Notice of Funding Opportunity for city-led initiatives. Proposals are listed by city and separated into urban and rural city proposals due to the restriction that Supportive Housing Services funds can only be used for programs and services within the Metro area Urban Growth Boundary (UGB). Health, Housing & Human Services has prioritized other local and state funding for proposals from cities located outside of UGB.

There is a brief summary, the requested funding amount and duration, and a recommendation for each proposal. For transparency, in the accompanying tables, staff have struck the amounts requested but not funded.

Urban City Proposals

Unincorporated Clackamas County

1. Proposal Summary: Development of a 30 pod transitional housing village on a 0.93 acre site just outside the City of Milwaukie.

Proposal Amount and Duration: \$1,750,000 one-time and \$1,684,830 ongoing.

Recommendation: Do not fund – proposal does not meet requirement of being

submitted by city.

Gladstone

2. Proposal Summary: Operations funding for the Gladstone Food Pantry (GFP). This is a partnership between the City of Gladstone, the Gladstone School District, Northwest Family Services, and the Oregon Food Bank. The GFP includes pantries in district schools. It increases food security for individuals, families and community members through free nutritional support services for low-income households.

Proposal Amount and Duration: \$262,717 over three years.

Recommendation: Fund using Supportive Housing Services funds.

Happy Valley

- **3. Proposal Summary:** Operations funding for the Happy Valley Empathy and Assistance Resource Team (HEART Program), which includes:
 - a. Immediate Care: Shelter, healthcare, and food to meet basic needs.
 - b. Dedicated Personal Assessment and Follow-up: Supportive services like counseling, employment assistance, and longer-term care.
 - c. City Homeless Liaison Coordinator: To maintain direct and continuous engagement with homeless residents.

Funding is requested for care packages, outreach and case management support provided by The Father's Heart / LoveOne, and 1.00 FTE city position.

Proposal Amount and Duration: \$863,550 over five years.

Recommendation: Partially fund using Supportive Housing Services funds.

4. Proposal Summary: Joint proposal with the City of West Linn for a 1.00 FTE Behavioral Health Case Manager and flex funds to support the existing joint 1.00 FTE Behavioral Health Specialist embedded with the Lake Oswego Police Department.

Proposal Amount and Duration: \$465,000 over three years.

Recommendation: Fund using Supportive Housing Services funds.

5. Proposal Summary: Operations funding for Hunger Fighters, a local food pantry that provides basic food and hygiene items to low-income households.

Proposal Amount and Duration: \$375,000 over three years.

Recommendation: Fund using Supportive Housing Services funds.

6. Proposal Summary: Joint proposal with West Linn, Oregon City, Canby, and Milwaukie to fund a cross-jurisdictional electronic health database for Behavioral Health Specialists operating within police agencies.

Proposal Amount and Duration: \$875,000 over five years.

Recommendation: Do not fund – look for alternative solution.

7. Proposal Summary: Operations funding to utilize the Ledding Library as a cooling center for up to 30 nights per year by extending library hours until 10:00 pm.

Proposal Amount and Duration: \$30,000 per year ongoing.

Recommendation: Fund for three years using Supportive Housing Services funds.

8. Proposal Summary: Funding for 0.50 FTE of the existing 1.00 FTE Behavioral Health & Housing Specialist operating within the Milwaukie Police Department and related vehicle costs.

Proposal Amount and Duration: \$102,000 ongoing.

Recommendation: Do not fund – this is backfill of existing investment.
