### **EXECUTIVE SUMMARY (why and why now):**

In October 2010 the BCC adopted a policy to provide some financial incentives and assistance to land owners / developers who had approved subdivision or partition applications expire in the last several years due to the downtum in the economy. The policy authorized the Planning Director to waive all or portions of land use fees for re-filing of partition and subdivision applications which expired due to the downturn in the economy. Funding for this program was requested from the remainder of redirected funds to economic development that occurred with FY 2010-11 adopted budget redirected monies. The program was set to sunset at the end of 2011 or when funds were expended. The waivers are further discussed in the attached memo from Planning Director, Mike McCallister.

### FINANCIAL IMPLICATIONS (current year and ongoing):

The remainder of economic development redirected funds available for this program totaled \$12,000. In all, \$13,528 in fee waivers were approved by the Planning Director. The gap of \$1,528 was paid from the General Fund.
