CALL TO ORDER

I. BOARD DISCUSSION ITEMS

A. County Administration

Gladstone/Oak Lodge Library Funding

County Administrator Schmidt briefed the Board of County Commissioners on the proposal for funding the libraries.

Commissioner Savas made general comments about the proposal. Commissioner Shull asked a question about previous ARPA funds allocated to the project and whether those dollars could be clawed back. Administrator Schmidt explained that the Board followed the rules in place at the time of the allocation, so there is no possibility of clawback. Commissioners West and Schrader made general comments in support of the proposal. Chair Smith asked about the ownership and ongoing maintenance of the facilities, Administrator Schmidt indicated that Clackamas County would own the facilities and would be responsible for maintenance. Chair Smith expressed a concern about the maintenance plan for the facilities. Commissioner Savas expressed his belief that the ongoing maintenance of the building could be provided for and that the library would align with the County's goals. Commissioner Schrader expressed interest in the creation of a library foundation or other avenue to build community support for the libraries. Chair Smith asked about the existence of the library district and adjusting the millage rate to provide additional funding.

Commissioner Savas: "I move to direct the County Administrator to fill the remaining balance on the construction of the Gladstone and Oak Lodge libraries with a one-time cash payment from the Clackamas County General Fund, with the exact amount contingent upon the determination of final construction costs." Commissioner Schrader seconded the motion.

1. Ratification of the 2022-2025 Labor Agreement with the Federation of Parole and Probation Officers for represented employees. Total value is \$13,889,751 for 3 years. Funding is through State and other funds, including \$1,944,565 in budgeted County General Funds.

- 1. Approval of a Federal Subrecipient Blueprint Grant with Cascade AIDS Project Esther's Pantry for Senior Nutrition. Grant value is \$108,000 for one year. Funding is through the Older Americans Act. No County General Funds are involved.
- 2. Approval of a County-Based Services Revenue Agreement with Health Share of Oregon for Behavioral Health Care and Services. Agreement value is \$4,184,447 for 1 year. Funding is through the Oregon Health Plan. No County General Funds are involved.
