Reviewed how they have assisted program like Bridges to Change and the Hotel/Motel program. Housing navigation and providing case managers to assist people with getting into housing. Long-term rental assistance to help people stay in permanent housing. Taking over operation of Veterans village. Increase outreach and engagement. Expanding peers support services.
