Appointed Boards and Commissions (ABCs) Recommendation

The Forest Advisory Board, staffed by the Department of Transportation and Development's Forest & Timber Management program, currently has four openings on their commission due to term expirations, and two on-going vacancies. Seven members are allowed with three year terms.

Recruitment opened to the public on July 1, and closed on July 29, 2022. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, two applications were received and two were recommended to be appointed. Both applicants are currently on the board, with terms that expired earlier in 2022. The Forest Advisory Board meets quarterly throughout the year. At the August 10, meeting interviews were conducted with all eligible applicants. Due to the technical nature of this board, applicants must be Foresters or persons that have professional forestry experience in the forest industry, forest consulting or governmental employment, or have a professional forestry education, and should have working knowledge of the Oregon Forest Practices Act.

Brent Keller is a graduate of Oregon State University with a Bachelor's degree in Forest Management, is currently employed as a consulting Forester, and has 30 years professional forestry experience.

William (Bill) Street is a University of Oregon graduate with a Masters in Political Science. Bill was Chair of the Board of Directors Program for the Endorsement of Forest Certification for six years, and the Director of Global Wood and Forest Program for five years, both located in Geneva, Switzerland. Bill has worked in the sustainable forestry field for more than two decades.
