**Presentation of National Award for Addressing Disproportionate Minority Contact**  
**In Clackamas County**

Clackamas County received a Certificate of Appreciation for Reducing Disproportionate Minority Contact in the State of Oregon. The award which was presented by the US Dept of Justice, Office of Justice Programs, Office of Juvenile Justice and Delinquency Prevention to the Clackamas County for dedication and in recognition of our significant contributions to addressing Disproportionate Minority Contact. This award is one of three given throughout the nation.

The County was also recognized at the recent 2009 Governor's Summit on Eliminating Disproportionate Minority Contact in the Juvenile Justice system.

In March, 2009, Clackamas County Juvenile Department was awarded a formula grant from the Oregon Juvenile Justice Advisory Committee of the Oregon Commission on Children and Families. This grant provides funding to implement strategies designed to reduce and eliminate disproportionate minority contact and over representation of minorities in the juvenile justice system. The primary goal is to improve disproportionate minority contact in the Clackamas County Juvenile Justice systems by reducing system barriers and increasing the availability and types of prevention programs. The long term outcome will be a reduction of reoffending for youth in the program; a decrease of arrests for minority youth; and an increase in Latino youth referred to Diversion Panels.

Our efforts have focused on prevention programs which created mentoring and afterschool recreational programs. System improvements were also implemented which established two culturally specific Diversion Panels for Latino's and training for juvenile justice staff, law enforcement, diversion panel members and other community members.

**RECOMMENDATION**

I respectfully recommend that the Board of County Commissioners accept this award in recognition for the Juvenile Department's commitment to address disproportionate minority contact within the juvenile justice system of Clackamas County.

**Approval of Resolution 1871- Intergovernmental Cooperation Agreement with the  
Housing Authorities Risk Retention Pool**

The Housing Authority of Clackamas County (HACC), a Division of the Health, Housing and Human Services, requests the approval of Resolution 1871. Resolution 1871 allows HACC to enter into a new Intergovernmental Cooperation Agreement (ICA) with the Housing Authorities Risk Retention Pool (HARRP).

On July 15, 1992, HACC originally entered into an ICA with HARRP. HARRP is HACC's primary insurance provider. HACC is considered a member of HARRP. Due to legislation that became effective January 1, 2010, HARRP has new authority to provide insurance coverage to nonprofit corporations and tax credit limited partnerships/LLCs. This change in offerings at HARRP initiated the need for HACC to update its ICA. Additionally, other provisions in the July 15, 1992, ICA had become outdated and required changing. The new ICA not only contains several provisions that are necessary to organize the Affordable Housing Pool, but also give HARRP additional flexibility to adapt to the changing needs of its members and better protects the financial integrity of HARRP.

The ICA has been reviewed and approved by County Counsel on January 11, 2010. A copy of the ICA is provided for Board review.

**Recommendation**

HACC recommends the approval of Resolution 1871 and the Chair to sign the accompanying Consent on behalf of the Board.

**Approval of an Intergovernmental Agreement between the Housing Authority of Clackamas County and the Housing Authority of Portland for Relocation Services**

The Housing Authority of Clackamas County (HACC), a Division of Health, Housing and Human Services, requests the approval to enter into an Intergovernmental Agreement (IGA) with the Housing Authority of Portland (HAP) for relocation services.

The HAP IGA provides the basis for a cooperative working relationship to provide relocation services. HACC is currently remodeling several Public Housing properties and is in the process of selling 21 scattered site Public Housing units. HACC is required by the Uniform Relocation Act to provide relocation services to families displaced by its remodeling projects and sale of Public Housing units. Currently, HACC does not have the staff expertise in house to perform this function and; therefore, is establishing this working relationship with HAP.

No County General Funds are involved, rather Capital Fund grant money will cover the cost of this IGA. The IGA is not to exceed \$88,624. The IGA is effective for one year from date of execution. This IGA has been reviewed and approved by County Counsel.

**Recommendation**

HACC recommends the approval of this IGA with HAP and further recommends that the Director of Health, Housing and Human Services be authorized to sign on behalf of the Board of Commissioners.

**ADOPTION OF AN INTERGOVERNMENTAL AGREEMENT BETWEEN CLACKAMAS COUNTY AND THE CITY OF OREGON CITY TO CONSTRUCT STREET AND PEDESTRIAN IMPROVEMENTS ON A PORTION OF HOLCOMB BOULEVARD (COUNTY ROAD #22019)**

Clackamas County and the City of Oregon City desire to construct road and pedestrian improvements to improve the safety and functionality of Holcomb Boulevard (County Road #22019) between Front Avenue and the Holcomb School Road intersection, within the city limits of Oregon City. The improvements will consist of installation of curb, sidewalk, crosswalk, street lighting, striping, and storm sewer improvements including catch basins, inlets and manholes. Under this agreement, County staff will be responsible for surveying and designing the storm, pedestrian and road improvements within the County right of way and for providing the final design plans and specifications for the construction of the project and the City will manage the construction project.

The County agrees to provide \$520,000 toward the project design and construction and the City agrees to provide any additional funding for the construction of the project not to exceed \$625,000. The total project construction is not to exceed \$1,145,000. Any project cost savings or overruns will be split equally between the County and the City.

**RECOMMENDATION**

Staff respectfully recommends that the Board approve the Intergovernmental Agreement to construct road and pedestrian improvements on Holcomb Boulevard between Front Avenue and the Holcomb School Road intersection in Oregon City.

2. **Board Order No. 2009-123** Approval of a Resolution of Public Necessity to Acquire Property to be Used for Construction of a Pump Station for the Intertie 2 Pipeline Project Being Constructed by Clackamas County Service District No. 1

Mike Kuenzi, Water Environment Services and Chris Storey, County Counsel presented the staff report. The effects of the proposed resolution would be: 1) to declare that the acquisition of the Property is necessary and in the interest of the public; 2) to authorize the District to proceed to acquire the Property through eminent domain while continuing to negotiate in good faith with the Property owners; 3) to authorize the District to obtain the services of real estate appraisers, negotiations, and other such experts in order to acquire the Property; and 4) to require that any changes in the design of the pipeline project resulting in changes to the property rights that need to be acquired will be brought before the Board for approval. Staff recommends the Board approve the resolution of public necessity to acquire property to be used for construction of a pump station for the intertie 2 pipeline project being constructed by Clackamas County Service District No. 1.

Chair Peterson announced this is a discussion item and asked if anyone wished to speak.

Brooks Brophy – representing his father, Carl Brophy who is the property owner - CR Brophy Machine Works manufacturing company at the proposed site, 13377 SE Johnson Rd., Milwaukie – asked the County to revisit this issue and seek other sites for this proposal.

Chris Story stated there are real impacts to change this proposed site. This is not the end of the negotiation but is a necessary step to move forward. As mentioned before any change in the design of the pipeline project resulting in changes to the property rights that need to be acquired will be brought before the Board for approval.

Commissioner Lininger wanted to make sure staff carefully assets all property sites for this project since there is new information.

Commissioner Bernard stated the market has changed greatly from two years ago and we need to consider this when we negotiate the price.

Brian Brophy, CEO of CR Brophy Machine Works Manufacturing Company, 13377 SE Johnson Rd., Milwaukie – this is not about the money, but the future of his business.

Chair Peterson stated since the approval of this resolution today will start a potential process but does not actually dedicate us to a final outcome - I would ask for a motion to approve the resolution of public necessity to acquire property to be used for construction of a pump station for the intertie 2 pipeline project being constructed by Clackamas County Service District No. 1.

**Approval of Amendment No.1 to the Intergovernmental Agreement Between the  
North Clackamas Parks and Recreation District and the City of Milwaukie Regarding the  
Operation, Management and Administration of Parks, Recreational Facilities and Programs**

December 2008, the Board of County Commissioners (BCC) and the City of Milwaukie (City), approved and updated intergovernmental agreement (IGA) for the operation, management and administration of parks, recreational facilities and programs within the city by the North Clackamas Parks and Recreation District (NCPRD).

The attached IGA amendment No. 1 is necessary to provide more clarity on maintenance requirements at several City properties that NCPRD and the City jointly maintain; specifically Riverfront Park, Scott Park, the NCPRD maintenance facility at SE 40<sup>th</sup> Street and Harvey, and Robert Kronberg Park. In addition, the amendment adds the Minthorne North property to the IGA, which was inadvertently left off during the previous IGA update. Since NCPRD has already been providing maintenance to the previously-listed sites this amendment does not increase the workload on the NCPRD maintenance staff.

The City of Milwaukie has approved and signed the attached Amendment No. 1.

**RECOMMENDATION:**

NCPRD staff respectfully requests the BCC approve Amendment No. 1 to the IGA with the City for park and recreation services.
