

## **NEW FORM**

We have a new form for AFH only, the Mandatory Abuse Reporting Notice. This form meets the department form requirement per OAR. You and your staff will still need to complete the Mandatory Abuse Report training annually located in Workday.

# **AFH Testing**

Effective August 1, 2024, Clackamas County Licensing will no longer be using Eventbrite for testing sign-ups. To schedule testing you, as the provider, will need to contact your assigned licensor via e-mail. Your e-mail must include the test taker's NAME, EMAIL ADDRESS and which test is needed (full test or retaking specific tests). Testing dates in August include the 6<sup>th</sup> and 21<sup>st</sup>, contact your licensor if you need future dates.
