Mobile Crisis Response Presentation (OHSU Report)- Stacy, Hayden, Ashley, Kim, Robbie	<ul style="list-style-type: none"> ➤ Stacy and team did a presentation about the role of MCRT and the Crisis Line which operates 24 hours a day. After-hours calls are routed to Multnomah County, which was previously answered by Lines for Life. ➤ General presentation of MCRT: calls to go into the community can be for folks that are concerned for a person that is threatening to hurt themselves or others. MCRT can partner with law enforcement. MCRT can also be dispatched by 988 and 911 ➤ MCRT operates 24/7, staff dispatched from 8:30-7pm every day of week, and until midnight Mon-Fri. ➤ Team purchased 3 SUVs as team is expanding, the team is able to respond to calls in snowy conditions. ➤ Data submitted to OHSU in May 2023, show clients served during this time was 600, as well as follow up appointments, and peer services. A lot less calls in the rainy/snowy months. Youth calls usually get higher in October. ➤ 25-64 age most seen. 12% under 14. Calls are increasing for folks 65 and up ➤ Mobile team has the ability of doing custody holds. Only when not able to do safety plan, or there is an imminent danger. 87% of calls are no custody required, 10 % are needing a director's hold. Law enforcement on scene 36% yes, 64% No. 	Send out slide to council.
