STATEMENT OF RIGHTS

- 1. Prior to the Hearing. You have the right to make the following requests:
 - (A) You can request the opportunity to review public records and to talk to County staff about the violations or request a subpoena for that purpose if the County does not allow you to do so.
 - (B) You can request that the Hearings Officer postpone the hearing for good cause by writing the Hearings Officer at least 7 calendar days prior to the scheduled hearing date.
 - (C) You can request that the Hearings Officer decide the matter based exclusively on written materials from the parties or conduct the hearing by phone.
- 2. Procedure. The hearing will be governed by general rules of procedure designed to allow you to hear and confront the evidence against you, and for you to present evidence favorable to you. You are not required to present any evidence, the burden is on the County to establish by a preponderance of the evidence that a violation exists, or existed. Either party may, at their own expense, obtain an attorney to represent them at the hearing. If you wish to be represented by an attorney they need only notify the County and the Hearings Officer in writing of their intent to appear on your behalf. The County will present evidence first, and then you may question that evidence. You may then present your own evidence, if you wish, and the County may question your evidence. Testimony by witnesses is evidence. The Hearings Officer may inquire into any facts that are relevant to the hearing and may question the parties or witnesses about the case. Evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their serious affairs shall be admissible.
- 3. Record of Proceedings. An audio record will be made of the proceedings when a hearing is conducted. The audio record is available through the Clackamas County Code Enforcement Section and is available to you upon request.
- 4. Hearings Officer. The Hearings Officer is an independent contractor paid by the County to conduct hearings and render decisions. He/she is not a County employee. His/her function is to preside over the hearing, make a record of proceedings, consider admissible evidence, and interpret and apply the law. After the hearing is closed the Hearings Officer will enter written findings of fact, conclusions of law, and any Order deemed proper. If a violation is proven, then the Order may include civil penalties, fines, administrative fees, or may require the respondent to take certain actions, or refrain from certain actions. An Order issued by the Hearings Officer may be a Final Order or Continuing Order. The Hearings Officers Order is the final decision of the County, and may be appealed pursuant to Oregon law. - 5. Right to Recess. If, during the course of the hearing, Respondent or the County requests a recess or postponement, or additional time to present crucial evidence, the Hearings Officer may allow a continuance of the hearing for good cause. The Respondent may also request that the proceeding be continued after the end of the hearing if the Respondent determines that additional evidence should be brought to the attention of the Hearings Officer.
- 6. <u>Right to Appeal</u>. The Final Order of the Hearings Officer shall set forth the right of the respondent to appeal any adverse Order. Appeal may be taken pursuant to Section 2.07.130 of the Clackamas County Hearings Officer Code, and Oregon Revised Statute 34.010-34.100. If appeal is taken, appellant is responsible for all costs of appeal including preparation of transcript.

COMPLAINT AND REQUEST FOR HEARING

I, Kimberly Benthin, Code Enforcement Specialist for Clackamas County, allege the following:

1.

Respondents mailing address is: 16031 SE Johnson Rd., Clackamas, OR 97015.

2.

The address or location of the violation(s) of law alleged in this Complaint is: 16031 SE Johnson Rd., Clackamas, OR 97015 also known as T2S, R2E, Section 09CC, Tax Lot 02200, and located in Clackamas County, Oregon.

3.

On or about the 30th day of November, 2022, AND on or about the 12th day of January, 2023, the Respondents violated the following laws, in the following ways:

Page 1 of 3 – COMPLAINT AND REQUEST FOR HEARING File No. V0045022

Respondents violated Title 9.02 of the Clackamas County Code Building Code Section 10.03.060 (A,B,C) by constructing an unpermitted carport, and failing to obtain all inspections and permits for the pole building. This violation is a Priority 4 violation pursuant to the Clackamas County Violation Priorities.

4.

The Department initiating this procedure is the Code Enforcement Section of the Department of Transportation and Development.

5.

Notice of the violation was given to Respondents in the following manner: Violation notice dated November 30, 2022 and Administrative Citation #2200450-1 dated January 12, 2023. A copy of the notice documents are attached to this Complaint as Exhibits B and C respectively, and incorporated by this reference.

6.

Based on these allegations, petitioner requests that a hearing be set in this matter. Petitioner seeks an Order from the Hearings Officer granting the following relief:

- Pursuant to Clackamas County Code Section 2.07.090, ordering
 Respondent to immediately abate the violations and bring the property at issue into compliance with all laws, and permanently enjoining Respondent from violating these laws in the future;
- 2. Pursuant to Clackamas County Code Section 2.07.090, imposing a civil penalty against Respondent for each violation, within the range established by the

Board of County Commissioners. Said range for the Priority 4 violation being \$100.00 to \$1,000.00 per occurrence as provided by Appendix B to the Clackamas County Code;

 Respondent to pay an administrative compliance fee as provided by Appendix A to the
 Clackamas County Code; and

4. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondent to reimburse the County for any expense the County may incur in collection of any penalties, fines or fees that may be imposed:

5. Ordering any other relief deemed reasonably necessary to correct the violations.

History of Events and Exhibits:

November 15, 2022 Clackamas County received a complaint regarding a shed, and a

carport attached to the shop.

November 23, 2022 Clackamas County Building Inspector viewed the structures from

off site and determined the carport requires permitting and there

appears to be a stove in the shop/pole building.

November 28, 2022 Code Enforcement Specialist Kimberly Benthin researched permit

history of the subject address. No permits were found for the shed, or carport. The shop/pole building permits were incomplete. The

stove pipe was not permitted.

November 30, 2022 Facts of the alleged violation were reviewed, the violation verified,

and Notice of Violation mailed to the Respondents via first class

mail.

January 12, 2023 The County did not receive any contact from the Respondents. A

review of the building permit history revealed no permit submittals.

January 12, 2023 Citation # 2200450-1 was issued for a priority 4 violation for the Exhibit C unpermitted carport, expired permit for the pole building and

unpermitted carport, expired permit for the pole building and unpermitted mechanical work. The citation was sent via first class

mail, the mail was not returned. The County waives the \$200.00

fine.

January 20, 2023 Permit Specialist Becky Bishop spoke with Respondent Daniel

Exhibit D Zuniga.

January 25, 2023 Respondent Daniel Zuniga and Permit Specialist Bishop

Exhibit E exchanged emails regarding the steps to gain compliance through

the permitting process.

February 2, 2023 Exhibit F	An aerial shows the carport remains on the property.
July 10, 2023	Mechanical permit fee was paid and added to the pole building permit # B0183915
July 25, 2023	The mechanical inspection occurred and passed.
November 14, 2023 Exhibit: G	An aerial photo of the property shows the carport has been taken down.
December 11, 2023 Exhibit H	CES Benthin sent the Respondent an email regarding next steps for gaining compliance.
November 25. 2024 Exhibit I	A review of permit history shows that the permit for the pole building has not had any further inspections. The electrical permit has not been submitted.

If the Hearings Officer affirms the County's position that a violation of the Building

November 26, 2024 The County prepared this file to be set for a hearing.

Code exists on the subject property, the County would request a Continuing Order be issued requiring the Respondent to renew the structural permit, obtain an electrical permit and all required inspections not later than 45 days of the date of the Continuing Order.

The County will submit a timely Post Hearing Status Report. The report will be sent to the Compliance Hearings Officer and to the Respondent. The report may include the following recommendations:

- The imposition of civil penalties of up to \$1000.00
- The administrative compliance fee to be imposed from November 2022 until the violation is abated.
- If the violations are not abated the County may request authorization for further enforcement action including to proceed to Circuit Court.
- The County requests the Hearing's Officer to permanently enjoin the Respondent from violating these laws in the future.
- If the Compliance Hearings Officer imposes penalties, fines and fees. The County would also ask the Hearings Officer to order reimbursement for any expense the County incurs in collection of those monies, per Clackamas County Code Chapter 2.07.090(6)

The County received a complaint regarding unpermitted carport type structure, an unpermitted shed greater than 200sqft in size and unpermitted mechanical work attached to the pipe vent in the roof of the pole building. In response to the complaint an inspector from the Building Codes Division recently conducted an inspection of the subject property.

It was confirmed that a carport type structure exists on site next to the pole building, a chimney extending from the pole building and what appears to be a shed between the property line and carport. The shed will need a permit if it does not meet the exemptions from the Building Code. Review of County records also reveals that the pole building never received all inspections including the final approved inspections. The permit # B0183915 or the pole building is now expired, you may contact the Building Division to determine if the permit can be renewed, or if a new submittal must take place. There is also no electrical permit for the pole building.

The unpermitted structures and mechanical associated with the pipe vent are violations of Chapter 9.02 of the Clackamas County Code as it pertains to the Application and Enforcement of the Clackamas County Building Code.

In order to abate the violations, please complete one of the following options for each structure not later than January 11, 2022:

- Please submit, or have your professional submit, the building permit application(s), technically complete plans and appropriate fee(s) for the unpermitted structures.
 - Respond to requests for clarification or additional information from permitting staff within 15 days of receiving such request.

- The permit(s) must have the fee(s) paid in full within ten days of your being notified by Building Codes in order to prevent delay of the issuance of permits.
- Please schedule all inspections so that final inspections may be obtained not later than 45 days of the date of receipt of your approved permit(s). If the structure requires modifications and you need additional time for the work – please contact this office to discuss the timeline.

Or:

- Submit an application for a demolition permit. Please be advised that if you
 choose to remove the structure or work you may still be required to get
 permits to confirm construction and utilities were removed, or remain in
 compliance with the codes.
 - The permit(s) must have the fee(s) paid in full within ten days of your being notified by Building Codes.
 - Please schedule all inspections so that final inspections may be obtained not later than 45 days of the date of receipt of your approved permit(s).
 - Please call this office to schedule an inspection to confirm removal of structure and all debris.

<u>Or:</u>

 It may be that the small shed structure meets the Oregon Residential Specialty Code exemption:

R105.2 (1) **Building**: 1. Nonhabitable one-*story* detached *accessory structures*, provided that the floor area does not exceed 200 square feet and does not exceed a height of 15 feet measured from grade plane to the average height of the highest roof surface.

Please schedule an inspection to confirm the exemption standards are met and the structure is in compliance. It is important to note that electrical, plumbing and mechanical permits remain required.

The submitted permit documents will be subject to the review and approval of the Planning and Zoning Division. The construction and use must meet the requirements and standards of the zoning district applied to the subject property. Important Notices

- 1. Administrative Compliance Fees. It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. An administration compliance fee of \$75 will now be assessed monthly until the violations are abated.
- 2. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, and (2) referral of this matter to the County Code Enforcement Compliance Hearings Officer.
- Request for a Hearing: If you dispute the existence of the violations described in the
 enclosed letter you may request a hearing before the Hearings Officer by sending a
 written request for a hearing, including your name and address to: Code Enforcement
 Section, 150 Beavercreek Rd., Oregon City, OR 97045, or at
 codeenforcement@clackamas.us.
- 4. **Potential Fines and Penalties:** The Clackamas County Code provides for Citation fine amounts of up to \$500 and additional civil penalties imposed by the Hearings Officer of up to \$3,500 for each day the County verifies the noncompliance. Fine amounts and civil penalties may be assessed for each cited violation and may be assessed separately against each named party. In addition, the Hearings Officer may order the violation to be abated by the County at the expense of the property owner(s) and responsible parties.
- 5. **Voluntary Compliance:** Clackamas County encourages voluntary compliance with code violations to support a safe and healthy community for all. Please note that when a property owner works cooperatively with the County to resolve a confirmed code enforcement violation, the County may in its discretion waive all or part of the \$75 per month administrative fee.
- 6. **Non-Compliance may result in a lien upon your property:** Fines and costs are payable upon the effective date of the final order declaring the fine and costs. Fines and costs under this Chapter are a debt owing to the County, pursuant to ORS 30.460, and may be collected in the same manner as any other debt allowed by law. If fines or costs are not paid within 60 days after payment is ordered, the County may file and record the order for payment in the County Clerk Lien Record.
- 7. **Final Order may be enforced in Circuit Court:** Also, be advised that non-compliance with a Hearings Officer's Order may result in the matter being referred to County Counsel for legal action in Circuit Court which may result in additional penalties or other sanctions.
- 8. **Recurrences will result in additional Citations:** Finally, recurrences of abated violations may result in the issuance of a citation without prior notice.

Here's a recap of my conversation at 12:24 pm today with Daniel Zuniga. Please review and let me know if I should go ahead and respond to Daniel:

1. Pole Barn:

- I let him know the fee to renew the 2015 permit would be 190.40 which would cover two inspections. I said I would scan the approved plans and email them to him so he can have them on site for inspections.
- A plumbing permit was pulled for the rain drains was issued and the final took place 9/29/2017
- A fan was installed in the ceiling that activates by a thermal switch when heat is excessive. It is powered
 by a cord that plugs into an outlet on the wall. Note: I let him know no electrical permit was obtained
 for the pole barn. He said there is an interior wall that is covered and he wondered if the wall would
 need to be opened for inspections. I said I did not know the answer but would find out.

2. Shop:

- He confirmed the wood stove and I let him a mechanical permit would be necessary for this work.
- A panel & circuits were installed in the shop I let him know about application for an electrical permit.




