BACKGROUND: The Clackamas County Sheriff's Office has requested that Clackamas County Fleet Services purchase nine (9) 2022 Dodge Pursuit AWD Durangos from Withnell Dodge through the State of Oregon Contract # 1651.

PROCUREMENT PROCESS: Approval of the purchase is being requested under the Local Contract Review Board Rule C-046-0400, Authority of Cooperative Procurements. The purchase will be made using cooperative contract #1651 of the State of Oregon Cooperative Purchasing Agreement Program from Withnell Dodge.

A notice of Intent to Purchase the nine (9) 2022 Dodge Pursuit AWD Durangos was issued on September 1st, 2022. No comments were received at the time of closing on September 8th, 2022.

RECOMMENDATION: Staff respectfully recommends the Board approve this purchase and authorizes Procurement staff to issue the PO on behalf of the County.
