**Wilson:** Homeless issue is getting depressing. Rifle work at Veterans Cemetery and hates to see all this trash and homeless build up.

Rhodes: Nothing to report; light holiday season.

Whitley Package theft witnessed. Reported it. Saw car on River Rd and provide information of license plate to kids/package owners who had package stolen from USPS deliver.

Also had a question – survey by Sheriff – unable to access it so may not have gotten much response. CPT O'Neil to pass this up the chain of command.

Wells: No updates since last time; Car prowl increase a few streets away was all he heard about.

#### VIII. Brainstorm:

O'Neil Update: Hiring – Banner year Sheriff wanted 20 but we wanted 30 and we did it. 26 of 30 are still in training. Between 1-5 a month coming out of training through year. This year we want to hire at least 30 and more if possible; hired one already this year. Batch hiring for a streamlined process. 20 interviews today; 10 of 20 went to backgrounds. 17 in background and 3 in conditional offer.

February is a new Recruit recruitment; Laterals are continues quick hires and are being interviewed within 1-2 weeks of hire. They can be utilized 5-6 mos from hire as opposed to Recruits who are 18-24 mos.

July 1- 21 positions are coming into play from levy with 5 detectives and 15 are patrol deputies

COVID – Hit us hard as of late – OHA changing rules sometimes daily. It is a FT job to monitor this. Readiness rate calculated each day with a contingency plan it dips too low. 5 day quarantine is helping as this isn't a large chunk of time.

Hendricks – Academy update request; Cpt O'Neil said now up to one a month where last year it was one every other but recent shutdown has started to bump that back and delay the classes.

Dr. Lowe – Testing question; availability of tests.

Wilson – Asking question re: jail recruitments; Looking to pull bigger number of applicants. Some of beds are still shut down per OHA rules/guidelines.

Cpt. O'Neil: Cam – Beta testing over last month; already paid off with handful out on Patrol; rolled out this month to everybody. Wilson Question: Policy on use of cams; when can be turned off or on. Cpt. believes all policies are available online but not sure if this is updated. Should be public info.
