**EXECUTIVE SUMMARY**: Oak Lodge Water Services Authority (OLWSA) will install a new sanitary sewer pipe across a section of the NCPRD-owned Trolley Trail in spring 2025. This will replace an existing pipe that is no longer efficient to maintain. To complete this work and to maintain the new pipe, OLWSA has requested a permanent utility easement across the Trolley Trail.

The easement requested is approximately 991 square feet and will be located between SE Roethe Road and SE Boardman Avenue (see attached 2024 OLWSD Proposed Easement Location Map).

Total just compensation offered to North Clackamas Parks and Recreation District for the easement is \$1,100.

**RECOMMENDATION:** Staff recommends approval of the permanent easement with Oak Lodge Water Services Authority across a section of the NCPRD-owned Trolley Trail.

#### PERMANENT PUBLIC UTILITY EASEMENT

For value received, <u>North Clackamas Parks & Recreation District</u> (Grantor), hereby grants, bargains, sells and conveys to Oak Lodge Water Service District, its heirs, successors and assigns, (Grantee), a permanent easement for the construction, reconstruction, upgrade, replacement, repair, maintenance, and inspection of public utilities, and related appurtenances, in, under, upon, and across Grantor's real property located in Clackamas County, State of Oregon.

The true and actual consideration for this conveyance is Zero and No/100 Dollars (\$ 0.00).

Grantor reserves the right to use the surface of the land for walkways, landscaping, parking, and other uses undertaken by the Grantor that are not inconsistent and do not interfere with the use of the subject Easement area by the Grantee. No building or utility shall be placed upon, under, or within the property subject to this easement during its term without the written permission of the Grantee.

Grantee shall have the right to enter upon and utilize the Easement Area for the purposes described in this document provided that reasonable notice is provided to Grantor prior to entry. Grantee may not remove trees, shrubs, brush, paving or other materials within the Easement Area without permission from Grantor to accomplish these purposes. Permission to complete these tasks will not be unreasonably withheld.

Grantor, Grantor's heirs, successors, assigns or representatives, shall not construct or maintain any building or other structures upon the above described Easement Area without prior written approval from the Oak Lodge Water Service District. Grantor:


Sewer Easement



The Oak Lodge Water Services Authority (OLWS) seeks to acquire property interests from you that are needed for the Boardman Sewer System Upgrade Improvement Project. These property interests are described in the Permanent Utility Easement document that accompanies this letter.

Oregon law provides a minimum of 40 days from the date of this initial written offer for you to consider accepting or rejecting it. Your decision to accept or reject may be made at any time prior to expiration of the 40-day period if you choose. If, following this 40-day period an agreement has not been reached, OLSW may need to proceed with legal action to acquire the property interests.

OLWS will pay recording costs, title insurance premiums and all other normal costs of sale for the acquisition.

Please read the enclosed documents carefully, and if acceptable, sign and notarize the acquisition documents. Our agents are Oregon notaries and are available to meet with you to assist with any questions you may have and to help with signing the documents. After the District accepts the acquisition documents, you will receive notification of that acceptance.
