SUBJECT CALLOUT AND	INITIAL ACTIONS									

On 11/04/16 at approximately 0045 hours I received a request for detectives from Detective Sergeant Jesse Ashby regarding a death investigation. I responded that I was available and called Sergeant Ashby to learn details of where I was responding to. I was told the investigation would be led by someone from the Clackamas County Major Crimes Team (MCT) due to the deceased person being an inmate who was in custody at the Clackamas County Jail prior to being transported to the hospital by ambulance, where he died. I responded to the Clackamas County Jail where I met with Clackamas County District Attorney Investigator Tom Gaumer. Gaumer is currently in charge of the MCT and told me he had Detective Jonathan Funkhouser from Lake Oswego Police Department on his way to be the lead investigator. I had previously learned from Sergeant Ashby that Detective Christie Fryett was also on her way to assist.

I contacted Captain Lee Eby and Lieutenant Steve Hohensee at the jail when I arrived. I was told the inmate, identified as Bryan Perry, had been transported to Kaiser Sunnyside Hospital where he died, possibly as a result of an overdose. I contacted Detective Fryett and asked her to go to the hospital and conduct any interviews that would be necessary there. I requested the Clackamas County Medical Examiner's Office on duty personnel contact me and I received a phone call from Deputy Medical Examiner Eric Tonsfeldt at 0150 hours. Tonsfeldt told me he would be responding to the hospital and deal with Perry's body.

I was told there were several Corrections Deputies who were at the end of their work day and a request was made to interview them first. See seperate reports for interviews.

I took photos of the cell where Perry had been housed as well as a paper "water log" that was being kept of Perry's water consumption. I provided copies of all the photos to Detective Funkhouser and placed a copy on the Arbitrator Cedar Server for storage.

After the interviews I was provided a copy of the jail CCTV footage from staff at the jail, which I provided to Detective Funkhouser. Detective Funkhouser and I determined we had conducted all the interviews that were possible that day and we would reconvene the following day. We concluded our actions for the night.

On October 4, 2016 at about 12:45 AM I received a page to respond to a death investigation at the Clackamas County Jail. As I was on my way to the jail I was contacted by Det. Terway who told me the deceased inmate had been transported to Kaiser Sunnyside Hospital and asked me to respond there. I arrived at Kaiser Sunyside at about 1:36 AM. At the hospital I contacted corrections Deputies Kettle and Piercy. They were standing outside an exam room in the emergency room. They told me the deceased was inside the room they were standing in front of. They told me the charge nurse's name, that attended to the deceased, was Matt. They provided me with paperwork identifying the deceased as Bryan Everett Perry. They told me Mr. Perry was lodged in the jail by CCITF. They told me Mr. Perry's girlfriend had also been transported to the hospital and was currently upstairs in the ICU. Deputies Kettle and Piercy told me the did not know what drugs Mr. Perry was on but that he was the worst case of "tweeking" they had ever seen. They also said they heard that Mr. Perry may have taken bath salts.

I learned from Det. Terway that the medical examiner had been notified and was enroute to the hospital. I told him about Mr. Perry's girlfriend also being at the hospital under similar circumstances to Mr. Perry. Deputies Kettle and Piercy told me Mr. Perry's girlfriend had drugs taken off of her person at the jail and at the hospital. They also told me she had to be restrained at the jail so that the nurse could take her vital signs. They told me the girlfriend appeared to be fine when she first came into the jail and that the deputies had talked to her to try and elicit information on what Mr. Perry may have taken. I left Deputies Kettle and Piercy with Mr. Perry and went to the ICU where I contacted two other corrections deputies. I learned Mr. Perry's girlfriend was Bridgette Tara Mountsier. I saw that Ms. Mountsier was in a private room and appeared to be sedated. I spoke to her nurse who told me they had found some sort of drugs wrapped in toilet paper when they were treating Ms. Mountsier, but that they had been "flushed out" of her and were disposed of. I was told Ms. Mountsier was being kept in a medically sedated. I was told that Ms. Mountsier's blood came back with methamphetamine and opiates in her system. I later asked nurse Matt to retain the blood and urine seized from Ms. Mountsier. He told me he would make sure that happened. I was told there was no blood or urine seized from Mr. Perry.

Once Deputy Medical Examiner Tonsfeldt arrived I went into the room where Mr. Perry's body was located. I saw it was covered with a blanket from the hospital. DME Tonsfeldt uncovered Mr. Perry and I saw he was unclothed other than a pair of underwear. I did not see any noticeable injuries to his body. DME Tonsfeldt told me after his initial examination of Mr. Perry that he believed he died from excited delirium. DME Tonsfeldt took control of Mr. Perry's body and transported it to the Medical Examiner's Office. I saw there was a board in the room Mr. Perry's body was in with times and notes of procedures performed on him prior to his death. I took pictures of it and have attached them to this report.

SUBJECT INTERVIEW WITH DEPUTY PAURUS									

On 11/04/16, at 0221 hours I spoke with Deputy Ricky Paurus regarding this case. The interview took place in the "Matrix" office at the Clackamas County Jail. Present for the interview was also CCPOA President Steve Steinberg and CCPOA Shop Steward Dustin Cochran.

The following is a basic summary of the interview; it is not a transcript. For clarity, the information contained in the summary is not necessarily in the order or using the same verbiage in which the information was provided. For a complete and verbatim account of what was said, please refer to the audio file contained in evidence.

Deputy Paurus told me he has been employed at the Clackamas County Jail for approximately 18 years. He is currently assigned to the Matrix position. He told me he learned an inmate had been placed in the High Security room, which is immediately next to the Matrix office. Paurus saw the inmate, later identified as Bryan Perry was "tweaking" pretty hard. Paurus described Perry's movements as "Thrashing" around. He stated it was pretty common to see an inmate who was using Methamphetamine acting similar to how Perry was currently acting. Paurus told me he could hear a nurse request to go check on Perry at an unknown time, but Paurus believed it was approximately 1900 hours. Paurus heard Deputies and nursing staff checking on Perry multiple times throughout the night.

At approximately 2300 hours Paurus heard deputies speaking to Perry and telling him they were there to check on him. Paurus decided to go in and see how things were going since he knows an inmate who is impaired on Methamphetamine can get volatile quickly. Paurus put on gloves and went in the cell to help out by holding one of Perry's arms. Paurus told me Perry was not resisting, but was not in control of his movements so deputies assisted the medical staff by holding him still so medical staff could check his vitals. During the time when Paurus went into the cell to assist he held Perry's arm still so medical staff could check his blood pressure. While holding Perry's arm, Paurus felt Perry start to become less rigid and saw the color start to leave Perry's face. At that time the medical staff recognized Perry needed further care and left the cell to get other instruments. A few moments later an AED was brought to the cell and CPR was started on Perry. Paurus heard the Sgt being called over the radio and someone requested an ambulance. Paurus assisted with CPR by using an airbag to provide breaths for Perry. Paurus told me Perry's neck was stiff and it was difficult to get breaths into Perry due to the head and neck not being able to get into the perfect position. Deputies, Savage and Lefever were doing chest compressions. Paramedics arrived a few minutes later and took over Perry's care. Perry was transported to the hospital by ambulance.

On 11/04/16 at approximately 0130 hours I spoke with Clackamas County Sergeant Doug Burgess regarding this case. The interview took place in a conference room at the Clackamas County Jail administrative offices. I asked Sgt Burgess how he came to be in contact with Bryan Perry, who was the immate who had been transported to the hospital where he died. Burgess told me from the Clackamas County Inter-agency Task Force (CCITF) when they first saw Bryan Perry. Burgess told me they were looking for which drew their attention to him. Perry and a female were first observed in the parking lot and a short time later Perry and another male and the female was no longer with them.  Perry got out of the vehicle and walked away while stayed with the vehicle. Burgess told me CCITF conducted the business they were there to conduct and when they were finished they turned their attention to and Perry. Perry, who previously walked away was still gone so two members of CCITF walked down a walkway in the direction Perry was thought to have headed. While walking in the direction Perry was last seen Perry emerged from around a corner and started walking toward them. One of the CCITF members, corrections clients who had a warrant for his arrest. Perry was taken into custody without incident.  Perry was asked where the female went and Perry said they got into an argument and she walked away. Perry stated the female. Bridgette Mountsier had a warrant and would not come back now that the police were there. A few minutes later Mountsier approached the group of law enforcement and asked where her boyfriend, Perry, was. They told her he was in custody for his warrant and she was placed in custody for her warrant. Both Perry and Mountsier were compliant and did not exhibit any behavior which was concerning.  Sgt Burgess told me Perry was transported to the Clackamas County Jail by Burgess was told after the transport that Perry began exhibiting signs of impairment consistent with Methamphetamine use during the transport and told that he had

On 11/04/16 at approximately 0328 hours I interviewed Deputy Ben Lefever regarding this incident. Deputy Lefever was working in the booking area during the time Bryan Perry was brought to the jail through the time Perry left in an ambulance.

The following is a basic summary of the interview; it is not a transcript. For clarity, the information contained in the summary is not necessarily in the order or using the same verbiage in which the information was provided. For a complete and verbatim account of what was said, please refer to the audio file contained in evidence.

Deputy Lefever told me he has worked at the Clackamas County Jail for just under two years. He confirmed he was working in booking during his shift that day. Deputy Lefever told me Perry entered the jail at approximately 1915 hours and was uneasy on his feet and appeared to be "on something." Deputy Lefever told me he searched Perry during his intake and Perry was so unstable on his feet he was eventually taken to the high security cell. Deputy Lefever told me Perry admitted to taking Methamphetamine, Heroin, and Bath Salts prior to coming to jail. Deputy Lefever told me the difficulty with dealing with Perry did not appear to be Perry being belligerent, and that Perry appeared to be trying to comply, but his body would not cooperate with him. Deputy Lefever told me he had Perry take his pants off once in the cell so they could search his pants due to deputies not being able to prior because of Perry's involuntary movements. After searching his pants, Perry's pants were given back to him and the door was closed.

Deputy Lefever told me Perry was put on a 15 minute watch, which means a deputy looks in the cell to see Perry's current condition. Deputy Lefever told me he went in Perry's cell with medical staff approximately 20 minutes after he arrived so the medical staff could check Perry's vitals. Deputy Lefever told me Perry was difficult to deal with due to the arm and leg movements, but Perry did not appear to be combative, just not in control of his body. Deputy Lefever told me they started to offer Perry water and Perry seemed happy to have the water and drank several cups of water. Perry was offered water on several occasions and drank at each occasion. During one of the interactions Deputy Lefever and another deputy asked Perry what his girlfriend, Bridgette Mountsier, may have taken. Perry stated she may have had his "PTSD" medications and heroin hidden in her body and may have taken that. Deputy Lefever felt Perry was starting to sober up since he was able to communicate better and answers questions more appropriately. This interaction happened at approximately the time Mountsier was transported to the hospital.

Deputy Lefever said at approximately 2315 hours he and Deputy Savage went into Perry's cell with the medical staff to check on Perry. At some unknown time during the interaction Lefever saw Deputy Paurus in the cell, but did not know when he entered. Perry was sitting on the bench and leaning against the wall, but was asked to lay down so they could get his vitals. Medical staff attempted to gain Perry's vitals with no success and the medical staff left the cell to get another piece of equipment. When she returned Lefever heard Deputy Savage tell the nurse that his breathing had become labored and they needed to get the AED. Deputy Savage started chest compressions and Deputy Paurus started breathing for Perry using a bag. After several minutes Lefever replaced Deputy Savage doing chest compressions and they all continued until paramedics arrived. Deputy Lefever told me at one point the AED stated "Shock Advised," but when the medical staff pushed the button the message stated "Shock Canceled" and no shock was delivered.

Deputy Lefever told me when paramedics took Perry away he heard them say Perry had a strong pulse. Deputy Lefever did not

have any further information regarding this case.

On 11/04/16, I attended the post mortem examination for Bryan Perry, conducted at the Oregon State Medical Examiners Office by Dr. Larry Lewman. During the examination Dr Lewman did not indicate any signs of trauma to Perry. The preliminary drug screen indicated levels of Amphetamine, Methamphetamine, and THC. Samples were sent to the Oregon State Police Forensic Laboratory for further toxicology testing. Please refer to Dr. Lewman's report (not yet received) for details of the examination.

#### NARRATIVE:

On 11/03/2016 I was assigned to the Clackamas County Jail as Housing Sergeant from the hours of 1800-2200. Sergeant Taylor was assigned as Booking Sergeant from 1800-2200 hours. At approximately 1900 hours I overheard multiple incomings custodies announced over the radio by the Control Deputy. At the time I was in the Housing Sgt. Office and observed over the camera monitoring system a Male and a Female custody being brought into the intake area of the Jail. The male later identified as being Perry, Bryan Everett Booking #16-070402 and the Female later identified as Mountsier, Bridgette Tiara Booking #16-070403.

I intermittently observed from the housing Sgt.s office over video the male Mr. Perry moving uncontrollably and twitching. Although he was standing under his own power and will he could not hold still. This is something I have witnessed over and over when Inmates are brought into the jail and generally are high on Methamphetamines. The booking Deputies performed an initial pat down search and then went and retrieved a chair for Mr. Perry to sit in. I assumed from watching the video up into that point that they were utilizing having Mr. Perry sit in a chair to mitigate his uncontrolled movement. It also indicated to me that Mr. Perry was not being uncooperative or combative but just unable to sit still. Any time there is an uncooperative or combative immate it is common sense to not introduce any item that could be a weapon in to the situation in this case the deputies using a basic chair to allow the immate to sit. This is something I myself have used as a technique to allow the immate to in this case the deputies using a basic chair to allow the inmate to sit. This is something I myself have used as a technique to allow the inmate to sit and focus on the intake medical screener and finish logging their property into inventory. It also keeps the inmate from potentially falling and injuring themselves inadvertently because they are high and restrained.

Mr. Perry was escorted to the Booking High Security Cell and I then returned to my area responsibilities and ended up leaving the Housing Sgt. Office and no longer observed the video. Based on my observations the Deputys in booking were utilizing the High Security Cell because it is completely padded. Observing video from the Housing Sgt.s office alone indicated to me Mr. Perrys inability to maintain control of his body movement. Mr. Perry was secured in the safest place should he fall. With the cell being padded if Mr. Perry should fall or hit his head on the wall the padded cell would greatly diminish the chance of injury.

By approximately 1945 hours I had walked down to booking to check out the area. Knowing that Sgt. Taylor was going to be off duty at 2200 hours I wanted to see what was going in booking and be able to be up to speed on any issues that might be going on. At 2200 hours I would be taking control of Booking and Housing posts as the only Sergeant on duty for the duration of the shift which ended at 0600 hours.

One of the first things I did was walk down the hall way and begin checking out the Isolation Cells. Mr. Perry was located in the IIS cell and was still there from what I witnessed on video approximately 20-30 prior while I was in the Housing Sgt.s office. Now that I was located just outside the cell I watch Mr. Perry through the window laying on the bench flopping around flaring his arms and legs around uncontrollably. At one point Mr. Perry sat himself up on the bench and began rocking back and forth. Again, it was apparent he was intoxicated on some type of drug Mr. Perry did not appear to be in any distress medically. I have seen this time and time again where Inmates are brought in to the jail high on Meth and have displayed this same type of behavior. Sometimes this behavior last for hours before the drugs wear off and the body is able to burn off the drugs in the inmate system.

After observing Mr. Perry for a while I went into the MATRIX office. Within a few moments Sgt. Taylor and Nurse Jana were standing in the hall way observing Mr. Perry. I went out into the hall way and stood by as Sgt. Taylor and Nurse Jana discussed Mr. Perrys behavior and tried to figure out what drugs Mr. Perry and consumed in order to provide the best plan medically should Mr. Perry begin to have medical issues. Sgt. Taylor then went to the womens holding tank and called a female inmate out in to the hallway. At that time I learned that Ms. Mountsier BK#16-070403 who was brought in at the same time was Mr. Perrys girlfriend. Sgt. Taylor and Nurse Jana began asking questions to Ms.

Mountsier about what drugs Mr. Perry possibly consumed.

Ms. Mountsier explained that earlier in the day they had gotten in to an argument and he left her for a while and she thought while Mr. Perry was gone he took some drugs. Ms. Mountsier said that they usually do meth together and had been using for the last few days. When Ms. Mountsier was asked if they took anything other than Meth she mentioned Heroin. Sgt. Taylor or Nurse Jana then asked about bath salts? Ms. Mountsier then became very evasive and appeared to get somewhat defensive, Ms. Mountsier then began asking Sgt. Taylor what bath salts looked like, and made the comment that it looked like meth right? Ms. Mountsier then went off conversation and said that she only smokes meth. Although I was approximately 5 to 10 feet away I could see scaring on her arms from in my experience indicated IV drug use.

Ms. Mountsier was returned to the Womens holding tank and just before she enter the cell she yelled, "I love you Bryan" and immediately Mr. Perry yelled back, "I love you too". Sgt. Taylor and Nurse Jana went back to the HS cell and began examining Mr. Perry. Sgt. Taylor had multiple Deputies enter the cell and hold on to Mr. Perry who was lying on the flor so Nurse Jana could get a good read on his vitals. Mr. Perry was still moving around uncontrollably so that is why the Deputies had to hold on to him. Mr. Perry was not being uncooperative he just couldnt hold still because of the drugs he had in his system.

After Nurse Jana got his vitals everyone exited the cell and retrieved some water for Mr. Perry. Mr. Perry was given a cup of water and Sgt. Taylor and walked back down the hall way. Sgt. Taylor informed me that he had started a water log had and Mr. Perry had been seen by Medical Staff and they were aware to closely monitor him. At that time it was determined Mr. Perry was cleared through Medical staff to remain in custody and we would proceed with having Medical monitor Mr. Perrys condition for any signs of improvement or deterioration.

At approximately 2030 hours Deputy Miller called for me to come down to the Main Womens Holding tank. Ms. Mountsier had all of a sudden started flopping around and acting just like Mr. Perry. The other women in the holding tank were becoming frightened and upset because she was begin to uncontrollably twitch, flair her arms and legs and could not hold still. The Deputys immediately responded and held Ms. Mountsier arms and secorted to the next cell ISO#2. Deputy Miller walked her through the door way and told her to sit down on the bench. Ms. Mountsier went from normal behavior in a matter of minutes to now being as intoxicated as Mr. Perry. After securing her in ISO#2 we stood at the door and observed her. We told her to stay sitting down and within a few seconds she was up and trying to walk around. All of a sudden she was leaning over forward at the waist and walked a few steps in to the center of the cell where she fell straight on her head. This took me off guard because she didnt even flinch as she fell and the sound of her head hitting the floor was loud. I immediately told everyone in the area to glove up and lets get her to medical. Surprisingly she did not appear to be injured, I was expecting her head to a least be cut open although she only had a small red mark. While in medical she was completely unable to maintain control of herself and almost appeared to be fighting herself. The Deputys had to hold her because in the midst of her flopping around she hit her head on the wall. There were multiple Deputy no holding on to her arms, legs and her flopping around.

At this point the Deputies were in a confined area trying to keep her under control in the medical room in booking, with the number of Deputies and Nurse in that confined area with an inmate who was having medical issues I made the decision to get her in the restraint chair. I directed them to get her out of the room restrained in the restraint chair. This would allow us to keep her from injuring herself, allow for her air way to unobstructed and Medical Staff could get all her vitals. Ms. Mountsier was now progressively getting worse and had surpassed the level of intoxication Mr. Perry was displaying.

After getting her restrained in the restraint chair and while the nurse was tending to Ms. Mountsier I walked down to the womens holding tank and asked all females in the tank if they had seen her eat anything. Multiple inmates explained that they seen Ms. Mountsier reach down the front of her pants and retrieved something from her crotch area and then put in in her mouth and swallow it. The other female Inmates said that within minutes she was flopping like fish out of water and that is when we came in a took her out of the cell.

Knowing that Ms. Mountsier had consumed something and her erratic behavior indicated she had ingested drugs although she was now having a more severe reaction to it than Mr. Perry. Again both of these inmates came in together and with similar symptoms now occurring the decision was made to transport Ms. Mountsier to the hospital. Ms. Mountsier was not responding verbally and had begun to foam at the mouth brown and bloody looking fluid. Although she was not conscious she would have bouts of fighting to get out of the restraint chair to going limp and making a gurgling/snoring type of noises. Fire and AMR were called code to the jail and I assigned Deputy Shultz and Deputy Pliska to the transport.

Before Ms. Mountsier was transported out of the facility I got Nurse Jana and two of the booking Deputies to go to the HS cell where Mr. Perry was located and check on him. I was concerned because as I indicated these two came in together Mr. Perry was intoxicated from the start and now Ms. Mountsier went from sober while being booking in, to physical actions like Mr. Perry was displaying, to now unconscious and going to the hospital via ambulance. Based on that information I felt it was necessary to check Mr. Perry sooner and have Medical assess him to make sure his condition was not getting worse. By 2138 hours AMR was in route to the Hospital with Ms. Mountsier for overdosing on some type of intoxicant.

After seeing the Ambulance exit the facility I spoke with Nurse Jana and got the update on Mr. Perrys condition. From her report Mr. Perry had begun to calm down Nurse Jana was able to get another set of vitals and explained that Mr. Perry was able to hold still and remain seated while she was checking him. Nurse Jana also explained that he was given water and drank multiple cups willingly and on his own unassisted. At that time Mr. Perry appeared to be improving and was even able to articulate better in conversation.

At 2146 I again went and observed Mr. Perry in the HS cell. Mr. Perry did seem calmer and although he had removed his shirt was able to say hi and recognized me as I stood at the door. I asked him how he was feeling and he told me he was feeling better and in a few minutes he would like more water but he was concerned that if he drank too much he would throw up. I told him to just knock and when he was ready I would get him all the water he wanted.

At approximately 2226 hours I again walked down to the HS cell and Deputy Lefever was giving Mr. Perry more water. I watched as he drank a cup or two and then threw one on himself and again he was appearing to calm down more and was sitting on the bench just in front of the door.

After seeing Mr. Perry drink more water I went down to Medical and talked to Nurse Camille to double check to see if she was up to date on Mr. Perry and his condition and to insure she did another check on him. I knew Nurse Jana was on her way out of the facility and off duty. Nurse Jana to my knowledge was the last to check Mr. Perry so I wanted to make sure Nurse Camille was going to go check Mr. Perry again. Nurse Camille was aware she needed to check him again and she asked me to put Mr. Perry in the restraint chair so she could get a good set of vitals. I explained to her that I would not put Mr. Perry in the restraint chair at that time. I explained to her some different situations where we could use the chair

although up to this time Mr. Perry was not hurting himself, in danger of hurting himself or actively being aggressive or combative towards anybody. In fact I knew already that Nurse Jana had just got vitals without incident and with the Deputies present they would be assisting her in get vitals the next check Nurse Camille did.

I was called to the 1st floor by Deputy Sneath at around 2236 and at the time still needed to complete my walk around of the facility. After talking to Deputy Sneath about an inmate in M-Block I left 1st floor and went to control to check on the Deputies.

While in Control at approximately 2316 hours I watched on video the Booking Deputies and the Nurse respond to the HS cell to do another routine medical check on Mr. Perry as I had instructed. At 2321 Deputy Savage called me over the radio to respond to Booking HS Cell. I immediately began to make my way down there and as I left to the Control room I could see on video that Mr. Perry was laying on the bench. I at first went to 1st floor and was going to tell Deputy Piercey to preemptively go get ready to go on a transport. That way I had a Deputy already getting prepared to go on transport should Mr. Perry need to be taken to the Hospital. Before I could get the door open on first floor to tell Deputy Piercey Deputy Savage called again over the radio and told me to urgently get to booking ASAP. I then called over the radio for Deputy Piercey on 1st floor and Deputy Kettle in control to suit up and prepare for transport. Not knowing at that time for sure Inmate Perry was needing to go to the hospital I was preparing my staff in the effort to be ready to go if it was determined that Mr. Perry be transport to the hospital cutting off valuable time.

I responded to booking and when I got to the HS cell the Deputy had just applied the AED machine. Mr. Perry was ashy colored and was not breathing on his own that I could tell. The AED ran its test and advised to stand clear for a shock. Immediately following the machine advised no shock necessary and to proceed with CPR if needed. At that time the Deputys began CPR. I wrote on my arm the time CPR was started which was 2323 and called control over the radio to get AMR and FIRE here code 3 for a male custody unconscious and not breathing.

I then called all available nurses in the facility to respond to booking ASASP and went down the hall to the booking techs office and advised the booking techs to get me a transport packet and notified Admiration by telephone of the situation.

I then returned to the HS cell and observed the Deputys continuing CPR. Deputy Miller told me that he thought Mr. Perrys air way was obstructed and to get the Nurse to retrieve a (NPR). I then told the Nurse who were standing by to check for a pulse. The reason I did this was to insure somebody who was not doing CPR check the pulse from previous experience when in a high stress or physical demanding situation sometimes when you feel for a pulse your only feeling you own personal blood pumping in your fingers. I needed someone who was not in this situation of physical exertion to check to Mr. Perrys pulse and give me that information to relay to responding fire and AMR units.

Sgt. Bell and Officer Orta from Gladstone Police were in the booking area and they were standing by to assist. I instructed them to jump in on CPR only if needed to allow the Deputies an break should they need it.

At approximately 2330 Fire was in the building and actively taking over CPR on Mr. Perry. During this time I monitored the situation and was able to make phone contact with Admin and Advise Lt. McCullough of the situation. I had to run up to the Housing Sgt.s office and retrieve two 800 radios for the two transport deputies I had assigned to go with Mr. Perry to the hospital I then returned to booking.

During this time I directed everybody in the facility to cease all unnecessary movement throughout the facility. I also ordered anyone not involved to stay at their assigned posts unless directed to come to booking by myself. This was to insure people not actively involved in the situation not get involved and to keep a chain of evidence. I was treating this as a possible death so I assigned Deputy Sandquist to gather all the responding units Names and keep track of anyone who came in contact with either Mr. Perry or the booking area. I also advised the booking techs that were in the middle of a shift change to remain in the booking tech office and not leave until directed.

At approximately 2350 hours the Fire Fighters and AMR indicated that they had a pulse on Mr. Perry and immediately transferred Mr. Perry to a gurney. AMR was in route to Kaiser Sunnyside at 2355 hours with Mr. Perry, Deputy Kettle was driving in a chase car and Deputy Piercey riding in the ambulance.

At the time I had multiple Officers and Deputies with custodies waiting outside the sally port I went out and advised them that it would be awhile and I would come back and tell them when it was ok to bring their custodies in the building. I assigned Deputy Miller to stand by the #510 door which is the entrance to booking and not let anyone leave or come in to the area that was not involved or of higher rank to insure the scene. From there I waited until Lt. Hohensee arrived and was the first to respond to the jail and advise him of the situation. Shortly afterwards Captain Eby arrived I was relieved of my duty station temporally as I assisted Lt. Hohensee in pulling the video of the incident. Everyone involved in the incident was assigned to write a incident report on their involvement.

#### NARRATIVE:

On 11/3/2016 at approximately 1915, Inmate PERRY was booked into the Clackamas County Jail. He could not stand up by himself or stand still. To search him, I had to help hold him up. His speech was barely coherent. He did not intentionally resist me, while I was trying to search him, but he had no control of his movements. He was able to tell us that he had taken bath salts, heroin, and meth.

Because of the physical condition he was in, we decided to put him in the High Security Cell. He also was put on a 15 minute administrative watch, meaning we do a visual check on him every 15 minutes. He was on this watch until he left the facility. As much as he could be, PERRY was compliant to our verbal commands, but he was moving uncontrollably and making strange noises.

The nurse wanted to take his vitals. PERRY was not able to sit still, so I along with other deputies went in and held him down so she could get them. Again, he was trying to be compliant and did not intentionally resist us, but he had no control of his movements, so in order to get the vitals, his movements had to be restricted.

At approximately 2120, PERRY was still moving uncontrollably, but his speech was getting better and we were able to get him to drink 4 cups of water and he sat still the best he could so the nurse could again try to take his vitals. I didnt know what reading the nurse was getting.

At approximately 2141, I was able to get PERRY to drink 3 more cups of water. Again, he was not able to control his movements, but seemed to be doing a little bit better. His speech continued to get better.

At approximately 2230, Sergeant Johnson and I went in and I were able to get him to drink 4 more cups of water. His condition seemed about the same at this time. No worse, or no better.

Throughout this entire time, we were watching him on the cameras and although he continued to erratically move about the cell, we all thought that he was doing better.

At about 2315, the nurse wanted to get his vitals. Deputy Savage and I went in to assist and try to get him to drink more water. He said that he wanted more water, but didnt take it before the nurse started trying to get his vitals. He laid down on the bench with help from us. The nurse began taking his vitals and this is when his breath started slowing. I noticed at this time that he was foaming at the mouth. The nurse was not able to get a reading. She left for a few seconds and his breath continued to seem labored.

After a few seconds of this, it appeared that his breathing had stopped. Deputy Savage asked the nurse if we should start CPR and get the AED. She said that we needed the AED. At some point, Deputy Purus had come in and one of either he or savage ran and got the AED. We attached the pads to his chest. The first time it said that no shock was needed. At this time, Deputy Savage started chest compressions. I stood by for when he needed a break. After the AED took another reading, it said a shock was needed and when the nurse hit the button, it said shock cancelled. At this time, I took over for Deputy Savage doing chest compressions. Once the Bag Valve Mask (BVM) was brought in we were doing 30 compression and then 2 breaths. The air appeared to be going straight to his stomach and when we were doing compressions, we could hear gurgling. At one point, we turned him to his side to try to get the liquid that was filling up in his mouth out of his airway and then continued compressions and breaths. We did this two times throughout this process. We continued to try to get air into PERRYs lungs, but we struggled to get his airway open because his mouth was filling up with liquid. The AED intermittently would take readings. We ceased CPR while it was doing its reading and then continued as soon as it finished its reading.

Once AMR arrived, they took over doing CPR. They were in the High Security Cell for approximately 30 minutes before they left, trying to get PERRY stable. I, along with a few other deputies, stood by in case they needed help with anything. I was not sure what was going on, but as they left I did hear them saying that he currently had a strong pulse. I heard them say that they would be running Code 3 to the hospital. Deputy Piercey was in the Ambulance and Deputy Kettle followed behind.

#### NARRATIVE:

At approximately 2317 hours on November 3rd 2016, I was working in the booking area at the Clackamas County Jail 2206 Kaen Rd. Oregon City 97038. I was getting an hourly check while Deputy Savage and Deputy Lefever were assisting Nurse Camille, in the high security room. They were checking vitals on Inmate Perry 16-007495. I heard them call over the radio they needed Sergeant Johnson to come down to booking. I ran to the high security, thinking they needed assistance in holding the inmate down. From prior observations from when he came into the jail, Inmate Perry was extremely high and couldnt hold still.

When I got there Deputy Savage and Deputy Lefever were still holding his arm and legs. And Nurse Camille was giving Inmate Perry a sternum rub, asking if he could hear her. Deputy Paurus and I, Deputy Sandquist, stood by and within seconds I saw the color in his face turn purple. Inmate Perry didnt move or respond to the sternum rub. The nurse then tried to take his pulse but couldnt find one. Deputy Savage and Deputy Lefever started CPR. Sergeant Bell DPPST#55552 of Gladstone Police department and Deputy Orta of Gladstone Police Department DPPST#55617, were on scene from an intake, and were standing by outside the high security cell in case of needing switching out for CPR. I saw Deputy Miller and Deputy Paurus clearing his airway, there was a lot of discharge from his mouth and then used the airbag to try to get air to his lungs. Deputy Savage then directed for me to get an AED. Immediately I ran down the booking hall to where the AED is near the 550 door. I grabbed it and ran down to the high security and passed it to Deputy Savage, he then sent me to see if AMR was called. I passed Sergeant Johnson in the hallway and confirmed with me that control was calling AMR and was enroute at approximately 2323 hours.

I went and got some towels down the hallway for the stomach discharge, and then I went back down to the High Security Cell. Deputies were switching back and forth between compressions. The AED was attached, but it told us to stand clear and then would cancel the shock. The compressions were still applied by Deputies. Nurse Lydia and Nurse Kate stood by in the hallway. Deputies continued CPR and Nurse Lydia went in the cell, she tried to find a pulse. The AED was tried again, but once again it canceled the shock. The CPR was continued until AMR and Firefighters arrived, at approximately 2325 hours.

Fire Engine 16 and Engine 17, Mike Baurer, Kyle Carrothers, Tyson Lowther, and Steve McAdoo arrived first, I assisted in directing them where to go from the sally port and they took over the CPR immediately. I stood by the sally port with Chris Mitchell, who also came down to booking to assist. I was waiting for AMR to arrive and to make sure no one else came in to the booking area, in order to keep the scene intact. AMR Medical #217, Medics Cole Theander and Erik Miller were on the scene at approximately 2325, I directed them to the High Security cell.

Deputy Kettle and Deputy Piercey prepared to go on the transport and were standing by.

At around 2345 hours the medies found a pulse, and immediately got Inmate Perry ready transport. At 2350 they were enroute to the hospital.

#### NARRATIVE:

On 11/03/2016 at approximately 2320 hours I was involved in an attempt to save Inmate Perry, Bryan (16-70402) who had become unresponsive in the high security cell.

I was in the ID room at approximately 2320 hours when I heard a radio call for Sgt. Johnson to come to booking immediately. The transmission also stated that Inmate Perry would need to be transported to the hospital and that his breath was shallow. At the same time control notified the booking area that there would be two incoming patrol Deputies waiting to bring and incoming Inmate in. I informed control that I would go outside the vehicle sally port and notify the incoming Deputies that it might be a little bit before they could come in. I went outside and notified the Deputies that there was a medical situation in the booking area and that they would have to wait for a little bit.

At this time I heard over the radio that the AED was being set up. I ran back into the vehicle sally port and into the booking area. I went to the high security cell and found Deputy Savage, Deputy Paurus, and Deputy Savage conducting CPR on Inmate Perry. Deputy Paurus asked someone to get the bag valve mask (BVM). I ran to the location the BVM was kept and removed it from its packaging on the way back to the high security cell. I handed the BVM to Paurus who placed it over Inmate Perrys mouth and nose.

Deputy Savage and Deputy Lefever would take turns conducting chest compressions on Inmate Perry. After 30 compressions Deputy Paurus would attempt to use the BVM. After a couple of CPR cycles Deputy Paurus noticed that no air was entering Inmate Perrys lungs and that the BVM was pushing air into his stomach. At this time I attempted a head tilt chin lift to try and clear Inmate Perrys airway, but it did not seem to work. During the next cycle of CPR I could hear an audible gurgling noise coming from Inmate Perrys airway. I looked inside Inmate Perrys mouth and could see liquid blocking his airway. I informed the other Deputies of my findings and we lifted Inmate Perry to his side attempting to drain some of the liquid from his airway. After a few seconds Inmate Perry was placed back onto his back and a Deputy resumed chest compressions, while some fluid was drained from his mouth I could still hear the gurgling noise. At this time I asked a nurse for a nasopharyngeal (NPG) so that I could try to create a secondary airway. There was no nurse who knew what an NPG was. I left the high security cell and ran to the booking nurse station where I found a nurse going through an aid bag. After searching the bag I found no NPGs.

At approximately 2325 Fire/EMS arrived on scene, I informed them that Inmate Perrys airway was occluded and that I was unable to attempt a secondary airway. At this time Fire/EMS took over resuscitation efforts from all Deputies. At approximately 2350 I was standing outside the high security cell when I heard one of the Fire/EMS/EMTs inside the cell state that there was a "strong pulse." At approximately 0000 Inmate Perry was loaded into the ambulance and leaving to a hospital.

Lefever and Savage continued chest compressions while I assisted with rescue breaths. Inmate Perrys neck was very stiff so I struggled to get his neck tilted back. Deputy Miller who was now in the cell assisted me getting a better seal around the nose and mouth and holding this head back. Inmate Perry had either stomach bile or mucous coming out of his nose and mouth making the task difficult.

Deputies Savage, Lefever and I continued our efforts until Paramedics arrived and took over for us.

Deputy Shadrin said she spoke with both Mr. Perry and Ms. Mountsier. She said Mr. Perry was initially snippy but calmed down and later apologized to her. She said Mr. Perry was fine after that and didn't seem intoxicated. She said Ms. Mountsier talked a lot during the time but seemed fine and normal.									
Deputy Shadrin told me she didn't see either of them ingest anything. She said she was not aware of any drugs found on Mr. Perry or Ms. Mountsier. She said transported them to the Clackamas County Jail (CCJ.)									
Deputy Shadrin told me she was at the CCJ later that night and saw Mr. Perry. She said a jail deputy called her to the cell where Mr. Perry was being held. She told me Mr. Perry was acing bizarre. She said she had never seen anything like it so she recorded Mr. Perry in the cell with her cellular telephone.									
Deputy Shadrin told me Mr. Perry's behavior at the jail was completely different than his behavior at the scene where he and Ms. Mountsier were contacted. Deputy Shadrin said Mr. Perry was acting appropriately when she spoke with him in Portland.
