Use of Force 2021 Annual Report

#### **Overview**

At the Clackamas County Sheriff's Office, we invest in hiring people who have the right temperament for public safety work with backgrounds that demonstrate good decision making. Fewer than 4% of applicants are hired. Typically, it takes eighteen months of training from the date of hire to the day a Deputy Sheriff begins their independent assignment. Then, throughout their career, professional training and on-going performance evaluation continue. These standards are among the ways we ensure we have a professional workforce capable of making the best decisions in the field.

Our commitment to public safety emphasizes respect, professionalism and the protection of human life, even when force is necessary. We expect our deputies to use their skills and abilities to safely and effectively resolve confrontations and minimize the need to use force whenever reasonably possible. To ensure this capacity, our deputies receive monthly training by certified instructors on all categories of force and de-escalation techniques.

Deputies are trained to continually evaluate the situation in an application of force, and to render first aid as needed. By Sheriff's Office policy, every deputy is required to intervene whenever they believe a fellow law enforcement officer's use of force is unjustified or excessive.

The Sheriff's Office recognizes the degree of responsibility that comes with the authority to use force and the obligation to be accountable for its proper use. That is why Sheriff's Office policy requires every use of force to be accounted for and justified. Following a use of force, a deputy must complete a Use of Force Report documenting and explaining why force was used, the nature of the force, and the outcome. All Use of Force Reports are reviewed by supervisors to determine whether the deputy's actions were justified and within policy. Reports are also reviewed by command staff to ensure consistency in practices throughout our agency and to inform continued training.

We recognize that police use of force is a matter of critical public concern and that transparency in use of force practices is essential to community trust. The intent of our Use of Force Annual Report is to aid the public in understanding our practices by providing transparent and accountable information. The data presented in this report is derived from our 2021 Use of Force Reports. 

Deputies reported 17 injuries.




