Homeless Solution Coalition of Clackamas County Presentation	Adam introduced John Duke and Lynne Deshler from the Homeless Solutions Coalition of Clackamas County (HSCCC). Lynne explained the history of the HSCCC starting as a small group of Clackamas County residents and growing into a State of Oregon recognized nonprofit. John then described HSCCC's current project, the Caring Place. It is envisioned as a services mall to provide a one stop place for resources for houseless individuals. After the presentation Lynne and John answered questions from the committee members about HSCCC and the Caring Place.

Sending the letter has been paused and will be reviewed again when the new BCC is sworn in.
