EXECUTIVE SUMMARY:

Each fiscal year it is necessary to allocate additional sources of revenue and appropriate additional expenditures to more accurately meet the changing requirements of the operating departments.

A supplemental budget is a method of appropriating fund expenditures less than 10% during the fiscal year as required by state budget law per ORS 294.471.

The **Library Service District** Fund is recognizing additional beginning fund balance in the amount of \$40,000, recognizing additional Current Year Taxes & Penalties in the amount of \$470,000 and Interest Income in the amount of \$90,000 and recognizing additional expenditures

in the Special Payments category (Payments to Local Governments & Other Special Payments) in the amount of \$600,000. The Library Service District is required to distribute all revenue to the Libraries within the District per IGA's with each Library, and these payments are made through the Special Payment expense category.
