

# Appointed Boards and Commissions (ABCs) Recommendation

The Tourism Development Council, staffed by the Tourism Department, currently has 3 openings on their commission due to term expirations. 9 total members are allowed, each serving a maximum of 2 terms.

Recruitment opened to the public on November 4, 2024 and closed on December 9, 2024. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, 8 applications were received and 3 are recommended for appointment. Interviews were conducted with eligible applicants.
