1. CALL TO ORDER

2. CITIZEN COMMUICATION

- d. Electrical Project Laurie met with Ralph Williams from Clackamas County. Ralph has map of all electrical sites on the grounds.

- f. Main Pavilion Roof County just completed walk through. Hosted 6 contractors on this walk-through. Projected cost is \$108,000 for next year's budget. Timeline to start is September.

 - iii. Motion: Increase Commercial Vendor booth space prices by 10%. Moved by Raeline, seconded by Matt. All in favor, motion carried.
 - iv. Motion: Increase Concessionaire Fees by 25% (Non Profit increase by 20%). Increase minimum flat fee to \$500. Moved by Matt, second by Raeline. All in favor, motion Carried.
 - v. Motion: Minimum flat fee for Non-Profit is \$ 300.00. Moved by Matt, second by Raeline. All in favor, motion carried.
 - vi. Motion: Increase all non-fair camping fees to \$25.00 per day including non-hook up campsites. Moved by Dan, second by Raeline. All in favor, motion carried.
 - vii. Increase stall rents by 25%. Increase late fees to \$35.00 per stall per occurrence. Moved by Raeline, seconded by Matt. All in favor, motion carried.
 - viii. Motion: Walk-around beer sales in Rodeo Arena shall be allowed in all sections except Section A & E, (formally section F). Dan moved, seconded by Matt. All in favor, motion carried.
- k. Clackamas County Fair and Rodeo Court Coronation March 10th, Main Pavilion starting at 5:30PM
