Background:

Social Services Division of the Health, Housing and Human Services Department requests the approval to apply for a grant from the Oregon Health Authority, Health Systems Division, Rental Assistance Program to provide permanent housing and services for veterans with a serious mental illness.

This program would provide rental assistance, a housing specialist and a mental health peer support specialist to veterans with a serious mental illness who are either: transitioning from the state hospital, transitioning from a licensed residential setting, without supportive housing at risk of reentering a licensed residential or hospital setting, homeless or at risk of being homeless. Up to 30 veteran households would be assisted annually.

CareOregon, Inc. Behavioral Health Integration Letter of Agreement

This Letter of Agreement (Agreement) is between CareOregon, Inc. (CareOregon) and Clackamas County acting by and through its Health, Housing and Human Services Department, Health Center Division (Provider) effective on July 1, 2016 and expiring on December 31, 2017.

I. Project Description:

CareOregon would like to support the ongoing work of primary care clinics to deliver the kind of outcomes-based care that the Patient Centered Primary Care Home (PCPCH) model promotes. CareOregon wants to recognize the work that is put into building and sustaining an Integrated Behavioral Health program by providing sustainability for working towards improvement in patient's behavioral health outcomes. Participating practices will be required to measure and track quality improvement metrics for their behavioral health program for all patients in the Providers clinic.

II. Project Objectives:

The Behavioral Health Integration outcomes for the project are:

- A. Provider will work towards improving on identified targets on selected Quality Metrics, as defined in Exhibit A, Payment and Quality Metrics.
- B. Provider will submit three (3) progress reports on Quality Metrics selected in Exhibit A to CareOregon.
- C. Provider will be available to participate in technical assistance and community collaborative learning regarding behavioral health integration efforts to be determined by CareOregon.

III. Conditions of Payment:

- A. CareOregon will pay Provider a per member per month (PMPM), as defined in Exhibit A, Payment and Quality Metrics.
- B. PMPM payment will be based on CareOregon assigned member on the fifth (5th) of the month.
- C. CareOregon will initiate the PMPM payment upon Provider's Agreement being fully executed according to the following time lines:
 - 1. If Provider's Agreements is executed between the 1st and the 20th day of the month, PMPM will start the following month.
 - 2. If Provider's Agreement is executed between the 20th and the last day of the month, PMPM will start in two (2) months.
 - 3. CareOregon will not pay Provider a retro-active PMPM.
- D. Provider agrees this payment is for the time period outlined above only and does not imply or guarantee ongoing funding.

IV. Terms:

- A. Terms of this Agreement are effective July 1, 2016 and will terminate December 31, 2017.
- B. Provider will submit progress reports by the deadline of 30 days after each six (6) month reporting period to be eligible to continue the PMPM payment.
 - a. Progress reports are due:
 - i. January 31, 2017 for reporting period July 1, 2016 to December 31, 2016.
 - ii. July 31, 2017 for reporting period January 1, 2017 to June 30, 2017.
 - iii. January 31, 2018 for reporting period July 1, 2017 to December 31, 2017.
- C. CareOregon may request a site visit to meet with Provider and review their Behavioral Health Integration program.
- D. Either party can terminate this Agreement with 30 days written notice.

IV. General Provisions:

- A. Should Provider's participation in the CareOregon Provider Agreement terminate, this funding will cease immediately upon written notification of termination and Provider agrees to refund any paid amounts prorated form the date of termination to the end of the time period outlined above.
- B. Provider agrees that Agreement Contact named above is responsible for all aspects of the Agreement, including monitoring progress and performance, obtaining all necessary data and information, and notifying CareOregon of any significant obstacles or delays. Provider will notify CareOregon if the Agreement Contact changes.
- C. Both parties agree to seek written approval for, and provide a copy of, any news releases or any other external communication related to the Agreement. Email approval by CareOregon or Agreement Contact will suffice as written approval.
- D. All copyright interests in materials produced as a result of Fund support are owned by the Provider. The Provider grants to CareOregon nonexclusive, irrevocable, perpetual, royalty-free license to reproduce, publish, republish, summarize, excerpt, or otherwise use and license others to use, in print or electronic forms, including electronic databases or in any future form not yet discovered or implemented, any and all such materials produced in connection with this grant.
- E. Provider agrees to uphold all confidentiality provisions of the Agreement between CareOregon and Provider, and specifically safeguard the health information of CareOregon members as it applies to activities related to this program.

INTERGOVERNMENTAL AGREEMENT

BETWEEN

CLACKAMAS COUNTY, OREGON BEHAVIORAL HEALTH DIVISION

AND

WASHINGTON COUNTY CONTRACT NUMBER: 7646

I. Purpose

This agreement is entered into between Clackamas County Department of Health, Housing and Human Services, Behavioral Health Division (CLACKAMAS) and <u>WASHINGTON</u> <u>COUNTY</u> (WASHINGTON) for the cooperation of units of local government under the authority of ORS 190.010.

This agreement provides coaching and consultation to the Wraparound Care Coordinators implementing Fidelity Wraparound in WASHINGTON and WASHINGTON Counties.

II. Scope of Work and Cooperation

The Regional Wraparound Coach will provide coaching and consultation to the Wraparound Care Coordinators implementing Fidelity Wraparound in each respective county. This position will understand the unique needs of each county and provide a balanced amount of time for all three counties.

Specifically, the Wraparound Coach will conduct monthly trainings and consultations with Wraparound Care Coordinators. This position will conduct review of Wraparound Care Coordinators by use of the Team Observation Measure (TOM) and will provide individual feedback to both the Wraparound Care Coordinator and their respective supervisor.

The Wraparound Coach will meet monthly with each county Wraparound Supervisor to review training and consultation needs for both individual Wraparound Care Coordinator and the Wraparound Team.

III. Compensation

A. WASHINGTON shall compensate CLACKAMAS for a portion of the of the Wrap Around Coach salary as listed below:

V. <u>Special Requirements</u>

A. CLACKAMAS and WASHINGTON agree to comply with all applicable local, state and federal ordinances, statutes, laws and regulations, including Oregon Public Contract laws and all applicable provisions of the Health Insurance Portability and Accountability Act of 1996 (HIPAA), PL 104-191, 45 CFR Parts 160-164, as well as all applicable provisions in each party's Intergovernmental Agreement with the AMH.

B. Within the limits of the Oregon Tort Claims Act, WASHINGTON agrees to protect and save CLACKAMAS, its elected and appointed officials, agents, and employees while acting within the scope of their duties as such, harmless from and against all claims, demands, and causes of action of any kind or character, including the cost of defense thereof, arising against CLACKAMAS' employees on account of personal injuries, death or damage to property arising out of services performed or omissions of services or in any way resulting from the acts or omissions of WASHINGTON, and/or its agents, employees, subcontractors, or representatives under this agreement.

Within the limits of the Oregon Tort Claims Act, CLACKAMAS agrees to protect and save WASHINGTON, its elected and appointed officials, agents, and employees while acting within the scope of their duties as such, harmless from and against all claims, demands, and causes of action of any kind or character, including the cost of defense thereof, arising against WASHINGTON's employees on account of personal injuries, death or damage to property arising out of services performed or omissions of services or in any way resulting from the acts or omissions of CLACKAMAS, and/or its appointed officials, agents, employees, subcontractors, or representatives under this agreement.

C. Access to Records. Each party to this agreement, as well as the State of Oregon and the Federal Government, and their duly authorized representatives shall have access to the books, documents, papers, and records of the other party to this agreement which are directly pertinent to the agreement for the purpose of making audit, examination, excerpts, and transcripts.

D. This agreement is expressly subject to the debt limitation of Oregon counties set forth in Article XI, Section I0, of the Oregon Constitution, and is contingent upon funds being appropriated therefor. Any provisions herein that would conflict with law are deemed inoperative to that extent.

VI. <u>Amendment</u>

This agreement may be amended at any time with the concurrence of both parties. Any changes in the proposed budget or scope of work will be negotiated between the designated liaisons. Amendments become a part of this agreement only after the written amendment has been signed by both parties.

BACKGROUND:

The Clackamas County Department of Transportation and Development, Transportation Maintenance Division requests approval to purchase a new Wirtgen 120CFi asphalt milling machine. An asphalt milling machine is used to remove the old asphalt layer of a road surface so that a new smooth and level surface may be poured. The milling machine is being purchased off of an existing National Joint Powers Alliance (NJPA) cooperative purchasing agreement.

This Permissive Cooperative Procurement complies with ORS 279A.215 and qualifies for an exemption from formal competitive bidding under LCRB Rule C-046-0430; Contracts for the purchase of goods or services where competitive offers for the same goods or services have been obtained by any other public agency which is substantially equivalent the processes required in ORS Chapter 279.

The cost for the milling machine is \$537,804.85. Funds for this purchase have been budgeted under line 215-7433-00-485520 within the DTD Department's current FY 15/16 budget. This purchase has been reviewed by Fleet Services.

Recommendation:

Staff respectfully recommends that the Board give approval to the Transportation Maintenance Division, to purchase a new milling machine from Modern Machinery. Total purchase amount not to exceed \$537,804.85.
