Background:

The Clackamas County Courthouse is home to the Fifth Circuit Court of the Oregon Judicial Department. The current courthouse was built in 1937 to house county offices and a single courtroom. The courthouse has been retrofitted over the years to its current configuration of eleven courtrooms and cannot be expanded any further to accommodate the current demand for three additional courtrooms. Due to the insufficient amount of space available in the building, services in support of the courthouse are located off-site, creating numerous operational inefficiencies. The courthouse is greater than 85 years old, requires significant ongoing repairs, lacks seismic upgrades and is functionally obsolete for the administration and delivery of justice services.

Recognizing the need for new county courthouses, the Oregon State Legislature created the Oregon Courthouse Capital Construction and Improvement Fund ("OCCCIF") in 2013 administered through the Oregon Judicial Department (the "OJD"). Counties that meet OCCCIF requirements and are approved will receive OCCCIF funding for 50% of the cost of a new county courthouse. Clackamas County (the "County") applied to the OCCIF for its courthouse replacement project (the "Project") and was approved by the state in 2017.

The County and the OJD have chosen a Public-Private Partnership ("P3") delivery approach to design, build, partially finance, operate and maintain ("DBfOM") the Project. This determination was driven by a recently completed Value-for-Money (VFM) analysis that compared five project

delivery approaches and showed the P3 Availability Model approach as providing the greatest Value-for-Money to the county and the state.

To execute the P3 procurement effort, Clackamas County formed a Project Technical Advisory Team ("TAT") to include representatives of the County and the OJD with extensive external support from consultants with experience in the procurement and structuring of P3's for similar social infrastructure projects. The TAT has now completed the procurement effort resulting in Fengate PCL Progress Partners (FP3) being selected as the successful proposer. On July 7, 2022 the Board adopted a Board Order authorizing the execution of the Project Agreement with FP3. At financial and commercial close in mid-to-late August 2022, the project will commence the final design and construction phase.

Through this amendment, WT Partnership will transition to the role of Owners (County) Representative during the final design and onstruction phase, ensuring that the County's interests are represented and the technical requirements contained in the Project Agreement are met.

Procurement Process:

This Amendment #3 is in accordance with LCRB C-047-0800(a) for an anticipated amendment. We have completed prior project phases. The next and final phase will be construction commencing upon Project Agreement execution

Recommendation:

Staff respectfully recommends that the Board approve and execute the Amendment #3 with WTP America, LLC dba WT Partnership to serve as a P3 Technical Advisor/Owner Representative.

AMENDMENT #3

TO THE CONTRACT DOCUMENTS WITH WTP America, LLC dba WT Partnership FOR P3 Technical Advisory Services Contract #3376

This Amendment #3 is entered into between WTP America, LLC dba WT Partnership ("Contractor") and Clackamas County ("County") and shall become part of the Contract documents entered into between both parties on **October 29, 2020** ("Contract").

The Purpose of this Amendment #3 is to make the following changes to the Contract:

1. **ARTICLE I, Section 2. Scope of Work** is hereby amended as follows:

The County has approved Contractor providing additional Work related to the County's courthouse project ("Project"). The additional Work will include continuation of Phase 3 of the Project, described in RFP 2020-65, that will take the Project to completion. The additional technical services are described in Attachment "D," which is attached hereto and incorporated by this reference herein.

2. ARTICLE I, Section 3. Consideration is hereby amended as follows:

In consideration for Contractor performing the additional Work, County will pay Contractor in the amounts set forth in Attachment D. Payment shall be in accordance with the terms and conditions of the Contract. Additional compensation authorized by this Amendment #3 shall not exceed \$2,009,700.00. The maximum compensation authorized under the Contract, including all amendments thereto, shall not exceed \$4,598,32.00.

^{*} The above fee budget assumes a 30month construction period with Phase III design review and Phase IV Implementation overlapping (and commencing in tandem). As a result of this overlap, economies of scale can be achieved as the Project Management, Leadership and Contract Management resources will manage both the design review and implementation.

Should these be bisected i.e. WT manage design review while implementation is managed by another firm we would suggest the following fee budget allowance is maintained.
