### 6:35 p.m. Approval of September Minutes

### 6:50 p.m. Get Moving 2020

Jamie gave an overview of the new measure Get Moving 2020 that will be on the ballot this November. She went through the website, showing the corridors that are involved with the measure, which includes four different corridors in Clackamas County (McLoughlin Blvd, Hwy 43, Hwy 212/Sunrise, & 82<sup>nd</sup> Ave). The measure will involve \$4.2 billion in expenditures for corridors.

Ray asked about 82<sup>nd</sup> Ave transferring from ODOT to the City of Portland, but the roadway maintaining ODOT ownership along the Clackamas County portion. Jamie said there's a lot still up in the air with this measure and jurisdictional transfers that will need to be addressed if the measure passes. She said that people need to stay involved if the measure passes, and these types of questions are important to bring up.

Joseph asked about the portion of McLoughlin Blvd receiving \$92.7 million on pedestrian safety funding (sidewalks, crossings, lighting). Jamie said that Metro has released some high-level information on the potential for what it involves, but it won't be until after the measure passes (if it passes) that the outreach will begin. Joseph asked if there were any substantial changes that have been incorporated since the last time the Committee was presented on this topic, and Jamie said not really.

Jamie said she'll come back to the Committee if the measure passes, as there will be a lot of work to do with what the projects will look like.

# 7:45 p.m. Oak Grove Bike Parking Follow-Up:"Marketing Video"

Scott discussed the new bike parking and fix-it station that was recently installed in downtown Oak Grove along the Trolley Trail. The County's cable channel group wants to develop a marketing video for the new infrastructure, and they're looking for two volunteers to play a role in the video. He said it'd be during the day in the next week or two

Hans said he'd be willing to do it, along with Ray. Scott said he'll work with the videographers and then loop in Hans and Ray for the process. They'll be simple things like locking up their bikes and pumping up your tire.
