BACKGROUND:

The Children, Family & Community Connections (CFCC) Division of the Health, Housing and Human Services Department requests approval of a U.S. Department of Justice, Office of Justice Programs (OJP) grant for Improving Reentry Education and Employment Outcomes. CFCC will partner closely with the Clackamas County Sheriff's Office to provide employment services to those leaving incarceration starting while incarcerated and continuing after release. This program will allow for the restoration of the Second Chance Employment program that ended two years ago due to budget cuts. The grant would fund 1.5 FTE, including a new 1.0 FTE position.

Grant Award has a maximum value of \$900,000 for services from October 1, 2022 through September 30, 2025.

RECOMMENDATION:

Staff recommends the Board signature approval of this Grant and for Tootie Smith, Board Chair, to sign on behalf of Clackamas County. Finance recommends signature on the attached Board Order authorizing Adam Freer, in the role of Director for CFCC, to electronically accept the grant award through JustGrants, the US Department of Justice online grant management portal.

Project Description

The Children, Family and Community Connections (CFCC) Division of Clackamas County's

Department of Health, Housing & Human Services (H3S) Second Chance Employment

program will involve a close partnership with the Clackamas County Sheriff's Office (CCSO).

Both H3S and CCSO are departments within the same organizational structure - Clackamas

County, Oregon – which is in the Portland Metropolitan area. CCSO manages the County Jail

in addition to Community Corrections (parole/probation).

Purpose: Provide comprehensive employment services for those reentering society from

incarceration, beginning during incarceration.

Primary Activities: pre-employment assessment, career planning, job search training,

career/technical education, intensive case management.

Expected Outcomes:

• Provide services to a preliminary estimate of 60 individuals each year

• Reduce one-year re-arrest recidivism rate from current 35.9%

Service Area: Clackamas County, Oregon.

Intended Beneficiaries: Individuals reentering society from Clackamas County Jail – BIPOC

(Black, Indigenous, People of Color) will be prioritized, and perhaps those with children at

home.

• Latest figures indicate the County has a record high number of job vacancies at 11,000.

The highest number of vacancies are in healthcare, social services, retail and

construction industries.

- Second Chance will conduct individualized career planning during incarceration and post release.
- CFCC has extensive relationships with local employers. This is demonstrated by the fact that when clients of existing programs are ready for employment, staff are often able to place them within 48 hours.
- CFCC recently launched a new customized database that greatly enhances the ability of the team to track and monitor employment outcomes, which is does for hundreds of clients at any given time.

4. Rules of construction

A. Staff involved in the hiring process

For purposes of this condition, persons "who are or will be involved in activities under this award" specifically includes (without limitation) any and all recipient (or any subrecipient) officials or other staff who are or will be involved in the hiring process with respect to a position that is or will be funded (in whole or in part) with award funds.

B. Employment eligibility confirmation with E-Verify

For purposes of satisfying the requirement of this condition regarding verification of employment eligibility, the recipient (or any subrecipient) may choose to participate in, and use, E-Verify (www.e-verify.gov), provided an appropriate person authorized to act on behalf of the recipient (or subrecipient) uses E-Verify (and follows the proper E-Verify procedures, including in the event of a "Tentative Nonconfirmation" or a "Final Nonconfirmation") to confirm employment eligibility for each hiring for a position in the United States that is or will be funded (in whole or in part) with award funds.

- a. represents that it neither requires nor has required internal confidentiality agreements or statements from employees or contractors that currently prohibit or otherwise currently restrict (or purport to prohibit or restrict) employees or contractors from reporting waste, fraud, or abuse as described above; and
- b. certifies that, if it learns or is notified that it is or has been requiring its employees or contractors to execute agreements or statements that prohibit or otherwise restrict (or purport to prohibit or restrict), reporting of waste, fraud, or abuse as described above, it will immediately stop any further obligations of award funds, will provide prompt written notification to the federal agency making this award, and will resume (or permit resumption of) such obligations only if expressly authorized to do so by that agency.
