WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Review and approve the revised fee schedule for Business & Community Services' County Parks division for inclusion in the Proposed Budget for FY 2018-19.

EXECUTIVE SUMMARY:

Each year, the Board of County Commissioners reviews all proposed fee or fine adjustments in order to adopt any fee or fine schedules concurrent with budget adoption. Early review and preliminary approval of proposed fee or fine changes allows County departments to integrate fee and fine proposals into the existing budget review process.

Business & Community Services (BCS) County Parks division is proposing several fee adjustments for FY 2018-19. Fee increases for camping and parking will help offset rising costs for operating and maintaining clean, safe parks for the public to use for recreation while meeting an increase in demand.

Over the past several years, County Parks has responded to significant increases in river recreation activities in the summer months, leading to additional costs. Additional spending within the parks has been incurred for contracted traffic control and parking services as well as additional staff to clean and maintain park restrooms, campgrounds and remove garbage. Rising minimum wage rates have further exacerbated these cost overruns. County Parks has budgeted for additional electronic ticketing machines and employs part time parking marshals to help increase parking fee payment compliance to help recoup a portion of these costs.

To better ensure fairness and equity across park jurisdictions, County Parks' staff conducted a survey of similar park and campground facilities in the tri-county metro area. It has long been the practice at Clackamas County to be consistent with State Parks on fees, length of stay, refund policies and services (i.e. disabled veteran discounts). The fee increases proposed here will continue this parity in camping rates between the County and State-managed campgrounds.

Currently County Park fees are \$21 per night for tent camping, \$26 per night for RV camping and \$5 for vehicle parking. Proposed fee increases will add \$1 to tent camping, \$2 to RV camping and \$1 for parking. In comparison, Oregon State Park fees range from \$26 to \$35 per night depending on date and site and \$7 for parking.

The proposed fee schedule is estimated to generate an additional \$31,200 in revenue, which will offset increased operating costs resulting from the increased level of service demand. The County Parks division receives modest general fund support, at approximately 6% of total operating costs. It relies on diverse revenue streams including park fees, State RV fee allocation, net timber and golf proceeds,

as well as a marina lease, in order to fund operations and meet capital repair/replace requirements. Staff respectfully recommend the Board approve these modest fee increases in order to keep County Parks' facilities clean and maintained through FY 2018-19.
