# Blueprint for a Healthy Clackamas County – 2017 CHIP Updates

Dawn presented a slideshow on how we have arrived at this point in the Blueprint for a Healthy Clackamas County planning process. The planning process began with the release of the Community Health Assessment (CHA) survey from the Healthy Columbia Willamette Consortium. The HCWC is made up of regional health focused entities from the four counties. Responses to the HCWC survey helped to create the CHA and is a reflection of the community's needs, strengths and challenges in our county and the region. Response to the HCWC survey was strong thus providing valuable information that assisted with the development of the draft Blueprint CHIP. Public Health (PH) staff/ambassadors then went throughout Clackamas County and

conducted over 70 Roadshows to get feedback on the CHA findings. Based on this feedback the draft Blueprint CHIP was created.

## Public Health Vision Updates & Refocusing

Dawn presented information to PHAC on the direction of the Public Health Division and what has occurred during the past 18 months. Dawn outlined the phases of change the division has gone through that has included staffing and structural changes to reflect HB3100 - Public Health Modernization. Modernization has forced PH to change its focus and make changes to its operation and focus; these are called Foundational Programs and Capabilities. Clackamas County is the only county in the state to make staffing and operational changes to reflect the goals of Modernization.

<u>Foundational Programs Includes</u>: Communicable Disease, Environmental Health, Healthy, Safe and Clean Places & Access to Care & Human Services

<u>Foundational Capabilities</u>: Communications, Emergency Preparedness & Response, Assessment & Epidemiology, Health Equity & Cultural Responsiveness, Leadership & Organizational Competencies, Policy & Planning, Community Partnership Development.
