#### WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Continue to support legislation that implements recommendations from the Task Force on the Future of Public Health Services to modernize Oregon's public health system.

#### **EXECUTIVE SUMMARY:**

This session provides an update on Public Health Modernization.

House Bill 3100 (2015) established Public Health Modernization as the new model for public health services across Oregon. It is based on the recommendations from the Task Force on the Future of Public Health Services (created in 2013 by HB 2348). The new model includes basic services & programs that no community should be without.

Clackamas County Public Health Division participated in a state-wide assessment. The assessment highlights the necessity that it is essential we invest in the Public Health Division's capacity to investigate and respond, its ability to educate and provide timely information and promote its role in leading and building collaboration.

The assessment determined that system-wide the following public health programs are limited or minimal in over a third of Oregon communities:

- Capacity to investigate and respond to disease outbreaks.
- Ability to identify and prevent environmental health hazards.
- Promote health equity through partnerships and engagement with communities that experience an excess burden of disease and death.
- Access to local, timely and accurate population health data that helps drive communitybased decision-making and resource allocation.

Investment in these areas is a critical first step in modernizing public health in Clackamas County.

#### **OPTIONS:**

- 2. BCC change its position related to this effort.

#### **RECOMMENDATION:**

H3S/ Public Health Division recommends Option #1. Examples of support includes:

- Continuing to support & prioritize legislative efforts to implement the recommendations from the Future of Public Health Task Force;
- Attending the H3S Legislative Forum on October 5<sup>th</sup>, 2016; and
- Working with H3S & PGA in developing testimony & supporting legislation that moves public health modernization forward.


# Oregon Public Health Modernization

## What is Public Health Modernization?

A new model to describe the role of governmental public health programs & services across all of Oregon developed based on recommendations from the Future of Public Health Taskforce.



"Public Health Modernization will ensure basic public protections critical to the health of all in Oregon and future generations—including clean air, safe food and water, health promotion and prevention of diseases and responding to new health threats."



# Before Modernization (since 1978)

- Safety net services for the most vulnerable
- Mandated health inspections
- Responding to current health issues / problems in communities
- Federal funding to carry-out specific activities with stringent requirements



# After Modernization (by 2023)

- A foundational level of services provided for all communities
- Local public health agencies working proactively with partners to address the health needs of the entire community
- Programs supported by diverse funding that allows for local needs to be met
- Local Public Health Authorities are accountable for the health of the community



# Why is the State of Oregon pursuing Public Health Modernization?

- In more than one third of Oregon communities, foundational public health programs are limited or minimal
- A "patch work" of funding to address vital public health services
- Oregon is ranked 31<sup>st</sup> nationally for spending \$26.60 per capita on public health
  - California (10<sup>th</sup>) spends \$56.20
  - Idaho (7<sup>th</sup>) spends \$94.70
  - Washington (23<sup>rd</sup>) spends \$38.20



# Why is Clackamas County supportive of Public Health Modernization?

- We are faced with capacity and resource limitations to respond to emerging public health issues, while at the same time proactively addressing ongoing concerns in every community
- Federal funding is spread too thin and we rely on unpredictable categorical funding streams that cannot fully deliver on local community needs
- This effort aligns with Performance Clackamas –
  accountability, transparency & clarity as we work to ensure
  safe, healthy & secure communities



# The path towards Public Health Modernization

### **Timeline**

### January-September 2014

Task Force on the Future of Public Health Services met monthly

### **July 2015**

Oregon legislature passed House Bill 3100

### January 2016

Public Health Advisory Board begins meeting monthly

#### June 2016

Public Health Modernization Assessment Report, funding formula framework and framework for accountability metrics submitted to Legislative Fiscal Office

#### December 2016

Initial statewide public health modernization plan adopted

### June 2013

House Bill 2348 passed Oregon legislature

### September 2014

Modernizing Oregon's Public Health System report submitted to Oregon legislature

#### December 2015

Public Health Modernization Manual published; Public Health Advisory Board appointed

### **April 2016**


State and local public health authorities complete individual public health modernization assessments

### September 2016

Report on estimated health outcomes and cost savings attributable to public health modernization released







# Public Health Modernization – Assessment Findings

Clackamas County Public Health participated in a state-wide assessment toward answering these questions:

- To what extent are programs & functions of public health modernization being implemented today?
- Using a funding formula, what resources are needed to fully implement HB 3100?
- What criteria should be used to identify priorities for the 2017-2019 biennium?



## **Clackamas County Assessment Findings**

It is essential that we invest in the Public Health Division's capacity to investigate and respond, its ability to educate and provide timely information and promote its role in leading and building collaboration.

We need Legislators to support a first step investment of \$30M for the 2017-2019 biennium to build upon our existing capacity and fill identified gaps—this is only a fraction of the \$105M/year investment needed to fully upgrade the state and local public health system in Oregon.



# Phase 1 – State Recommendations for the 2017-2019 Biennium

- Environmental Health identifying & addressing local environmental health hazards; policy, planning & partnership development
- Data & Assessment assessing healthcare access issues; providing timely & local data to all the communities across Clackamas County
- Health Equity engage with the community to identify & eliminate health disparities
- Communicable Disease & Emergency Preparedness increasing capacity to plan for, investigate & respond to disease outbreaks



# Continued support needed from the Clackamas County Board of Commissioners

- Since 2013, the Clackamas County BCC has supported the creation of the Future of Public Health Taskforce and implementation of their recommendations. Continued support for this work is critical to assure Clackamas County needs are met.
