Whereas, the Clackamas County Board of County Commissioners (the “Board”), has authority to sign all contracts and any amendments or renewals of the same;

Whereas, Oregon Revised Statutes (“ORS”) 279A.200-220 and Local Contract Review Board Rules C-046-0400 through 0480 permit the purchase of goods and services using cooperative contracts;

Whereas, the United States General Services Administration established a cooperative contract with Datec, Inc. for the purchase of IT Solutions and Services, contract #47QTCA19D00MM (the “Cooperative Contract”);

Whereas, Clackamas County Sheriff’s Office (“CCSO”) desires to utilize the Cooperative Contract and purchase 55 Panasonic FZ-55 TOUGHBOOKS, Docking Stations, and DVD Drives, for total of \$162,452.40, as set forth in the Datec Quote #Q24A3001, attached hereto as Exhibit A;

Whereas, the Clackamas County Department of Finance requests authority to purchase the aforementioned goods and services on behalf of CCSO by issuance of a purchase order (“PO”); and

Whereas, a PO is issued directly through the Clackamas County Department of Finance’s management software on CCSOs’ behalf with no additional signature;

NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:

1. The requested purchase of the aforementioned goods, through the Cooperative Contract, from Datec, Inc., in the amount of \$162,452.40, is hereby approved; and
2. The Clackamas County Department of Finance is hereby delegated limited authority to issue a PO to purchase the aforementioned goods on behalf of CCSO.
