Appointed Boards and Commissions (ABCs) Recommendation

The Timber Sale Advisory Committee (TSAC), staffed by the Department of Transportation and Development's Forest & Timber Management program, currently has two openings on their committee. One opening was created by the resignation of a County Parks Advisory Board member in 2021. The other opening is due to the need for a citizen member representing the community in the area where the next timber sale is being proposed.

The purpose of the TSAC is to advise the County Forester, County Parks & Forestry Manager and Board of County Commissioners on all matters pertaining to the sale of County Forestry program timber. The TSAC is comprised of two members of the Forest Advisory Board (FAB), two members of the County Parks Advisory Board (PAB), and one member at-large representing the community in which the timber sale will take place. The committee only convenes when there is a proposed timber sale and public process to consider.

The FAB and PAB boards nominate and elect two of their members to fill positions on the TSAC. The PAB met on September 20, 2022, and Eric Pfeiffer-Robinson volunteered to fill the vacant PAB position on the TSAC. The PAB held an election and Mr. Pfeiffer-Robinson was approved to serve. Mr. Pfeiffer-Robinson has served on the PAB since December 2019, lives in Canby, and is a professional arborist.

Recruitment opened to the public on September 1, and closed on September 30, 2022, for the TSAC citizen-at-large member. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Recruitment focused on the communities of Estacada, Eagle Creek, and Firwood based on the location of the Forestry program's upcoming timber sale. Through this recruitment process, one application was received from Marjorie Stewart. Ms. Stewart is a retired Professional Engineer and worked for the US Forest Service on the Mt Hood Forest and the Kootenai Forest in Montana for the first half of her career. Ms. Stewart spent the last half of her career working for the US Army as a contractor. Ms. Stewart is an active member of the Firwood community and is a member of the Firwood CPO. Ms. Stewart also serves as a Clackamas County Coordinating Committee alternate member, was previously the Clackamas County Coordinating Committee representative for CPOs, is a County Road Fund Advisory Committee member, and previously served on the Clackamas County REACT committee. Ms. Stewart serves as a volunteer Timberline Lodge tour guide, and is a board member of two bands and orchestras in the local community.
