#### REASONS FOR DEMANDING RECALL OF ALLAN CAMERON, MAYOR, CITY OF ESTACADA

Misuse of elected office to secure a paid position as city manager. Misuse of elected office by reviewing private information relating to applicants for city manager, thus creating an unfair advantage over other applicants. Failure to disclose a conflict of interest, even after being approached by several city councilors stating their concern over his actions. Failure to remove himself as a vote in the hiring process, even after being advised by the city attorney not articipate in the proceedings. Failure to collect monies paid by the city on a contract that was not authorized by the city council of over \$6500,00 dollars. Failure to protect citizens from misuse of tax dollars by not asking for not voting to collect over \$7000.00 dollars paid to the city attorney that were not awarded by the court as reasonable and necessary. Failure of responsibility to citizens in that as both councilor and as mayor he did assure the citizens of Estacada that the information on a 2.6 million dollar bond was accurate and true. Failure to see that the benefit of the water project being paid for by residents benefited those residents. Failure to represent the voters on water rate increases.

#### JUSTIFICATION OF HIS COURSE IN OFFICE BY ALLAN CAMERON, MAYOR, CITY OF ESTACADA

This recall election is a sham. Before newly elected city councilors had taken their seats in January, their recall was being planned. Some who lost the November election, and their supporters, are using this recall to gain control of City government.

As at present, a healthy City Council has people representing varying points of view. This recall is an effort to change the council, as much as possible, to a single point of view. I feel such a change would be to the detriment Du. the citizens of Estacada.

The Council has been criticized because its decisions do not agree with the personal agendas of some local citizens. Note that all the people targeted for recall made decisions which don't support these personal agendas.

I can assure you that decisions of the council are sound and show good judgement. They are frequently supported by professional opinions from attorneys, engineers, etc. There is a very valid 'other side of the issues' regarding the so called facts of this recall election. I encourage you to listen to both sides.

#### REASONS FOR DEMANDING RECALL OF KAREN HARDMAN, CITY COUNCILOR, CITY OF ESTACADA

Excessive absence to budget meetings. Excessive tardiness and absence from council meetings. Failure to be advised of current issues and major items before the council. Example: Reagan Hill development of over 200 homes, Ms. Hardman was unaware of the project despite it being the major reason for the proposed 1 million dollar reservoir, and despite the fact that plat maps hang less than 20 feet from her seat. Ms. Hardman also was the person who motioned to bypass normal procedure of hiring a city manager to give an advantage to her choice Allan Cameron, whom she had been lobbying for. Ms. Hardman also attempted to have the qualifications of at least a B.A. degree for the job removed. Again to provide her choice with a chance at the position as he did not possess the required educational background. Sarcasm toward the public. As a city councilor and a budget committee member, she insulted a committee member by referring to him as "Severely emotionally disadvantaged, when he used the initials SED's instead of SDC's during the budget hearing. #### REASONS FOR DEMANDING RECALL OF TOM SAGER, CITY COUNCILOR, CITY OF ESTACADA
