## Request For An Exemption And Authorization To Use The Request For Proposals Method To Purchase A Boathouse for the Clackamas County Sheriff's Office Marine Unit

In order to use the Request for Proposals method to solicit for Public Improvement projects the Board must approve, acting as the Local Contract Review Board, Findings of Fact that justify the granting of an exemption from the requirement of public contract rules and regulations which require competitively bidding the project.

The Local Contract Review Board Rule C049-0620 and ORS 279C.335 require the following process for exemptions of this nature.

Before final adoption of the findings exempting a contract for a public improvement from the requirement of competitive bidding, a public agency shall hold a public hearing. Notification of the public hearing shall be published in at least one trade newspaper of general statewide circulation a minimum of 14 days prior to the hearing.

The notice shall state that the public hearing is for the purpose of taking comments on the agency's draft findings for an exemption from the competitive bidding requirement. At the time of the notice, copies of the draft findings shall be made available to the public. At the option of the public agency the notice may describe the process by which the findings are finally adopted and may indicate the opportunity for public comment.

At the public hearing the agency shall offer an opportunity for any interested party to appear and present comment.

To meet these requirements this draft of the finding is being presented to the Board for the exemption from the competitive bidding requirement.

The Purchasing Manager caused an advertisement to be placed in the Daily Journal of Commerce on June 16, 2010 notifying interested parties of the draft findings. The advertisement states that the draft findings are available at the Office of the Purchasing Manager and that a Public Hearing will be held on July 8, 2010. This meeting will be the last opportunity for receiving comments. If no comments are received that result in a revision of the draft findings the Board of Commissioners may, at its discretion, adopt these draft findings as the final findings for the exemption at the public hearing.

#### PROPOSED FINDINGS:

#### A. Nature of the Project:

Clackamas County is requesting proposals for design, construction and moorage of a Boathouse to be located on the Willamette River in proximity to the mouth of the Clackamas River. The Clackamas County Sheriff's Office Marine Unit currently operates out of the Clackamas Lagoon and is experiencing difficulty with year round operations during low water conditions in the Clackamas River. These low water conditions occur during the time of year that the waterways receive a significant amount of use by the public. The low water conditions inhibit if not precludes the ability to respond to emergencies from the lagoon location because of the draft needed to safely navigate the opening from the lagoon to the Clackamas River.

It has been determined that the Marine Unit is in need of a location that can provide year round access to the Willamette and Clackamas Rivers to ensure the ability to respond to emergencies and conduct enforcement patrols. The boathouse is anticipated to be located on the Willamette River in the area of the Clackamas River and the proposed solution will need to address the provision of a long term lease for boathouse moorage.

The new boathouse is anticipated to house 4 boats, one of which is 24 feet long, the other 3 boats range from 18 to 22 feet long. The boathouse will have space for classroom area, restrooms with adjacent locker room capacity, kitchen, and an office area. Additional considerations include: pilings to secure the boathouse, upriver protection from floating debris, electrical and telephone connections, connection to water and sewer services.

During the process of identifying the project requirements it was determined that a number of different contractors could provide solutions that would meet the needs of the County. However, it was also discovered that the solutions varied in design of the boathouse, availability of moorage site, methods of construction, and suitability of the location. This discovery creates a condition that makes it problematic to develop a traditional set of project bid specifications that would treat all potential bidders equally and award solely on the criterion of price.

The Sheriff's Office Marine Unit has developed conceptual building specifications and drawings for the project, that illustrate the requirements for the Boathouse. These specifications provide the minimum design specifications which the vendor will be required to meet without calling for specific products or designs.

#### B. Estimated Cost of the Project:

The current budget for the project is \$300,000 for design and construction services.

## C. Narrative Description of Anticipated Cost Savings from Exemption to use the Request for Proposals to Purchsae a Boathouse for Sheriff's Marine Unit;

A number of factors make this project unique and present an opportunity for cost savings from the use of the Request for Proposal process

1. This project is complex owing to the need to provide both a moorage location as well as the boathouse building.

- 2. The selection of construction methods and sequencing will benefit significantly by involving a single contracting entity for both design and construction of the Boathouse.
- 3. By identifying a moorage location available to the operations of the construction contractor the opportunity for on-site construction savings is created.
- 4. The experience of the proposed boathouse designers and constructors can be evaluated as a part of the selection process, thereby minimizing the chance of change orders which raise the cost of the project.
- 5. Project costs may be lower because of the close working relationship between the designer and constructor. This may lead to incorporation of more economical design features and the application of cost-saving construction methods.
- 6. The County gains the opportunity to fix the total acquisition cost early in the process cooperatively with the contractor.
- 7. The County's administrative burden and time for completion for the project is reduced by conducting one solicitation for the project, as opposed to conducting multiple solicitations for design/ bid/ build/ locate approach. Having a single source of responsibility for design and construction of a facility in accordance with a performance-based specification helps ensure the County that the facility will perform as specified.

### D. Proposed Alternative Contracting and Purchasing Practices:

- 1. The County desires to select the vendor using the following competitive process:
  - Publicly advertise a Request for Proposal to contractors.
  - b. The contractor will be selected through an evaluation process that will consider the project understanding and approach, qualifications, design and construction team experience, references and the price proposal.

#### **Project Understanding and Approach**

- A brief understanding of the project.
- A positive commitment to complete the project within the time period specified and under the terms of the RFP.
- Assist with the design and administrative coordination, scheduling, and budget estimating, as per specifications provided in the RFP. The specifications outline the minimal design requirements.
- The proposed design of the Boathouse including construction materials and methods of construction.
- Location of moorage.
- Provide a critical timeline schedule for completion of the project.

#### **Qualifications**

- Provide a brief description of the firm's history and its capabilities.
- Provide the status of current work within the firm, in time and magnitude.
- Provide Bonding Capacities for:
  - a. Public Works Bond
  - b. Performance Bond
  - c. Payment Bond
- Provide insurances limits for general liability, additional commercial general, automotive, pollution and worker compensation.
- Construction Contractors Board registration and classification of license

#### **Experience**

- Detail the firms experience in providing boathouses or floating structures, including installation services, similar to the proposed boathouse.
- Provide a discussion of the Key Personnel
  - Supervisor to employee ratio
    - o Crew size
    - o In-house capacity
    - Expected sub-contractors

#### References

The Contractor must provide a list of references that are similar in size and scope of the services, where the Contractor or its subcontractors have provided the requested design and construction services. The reference list shall include the agency name, address, telephone number and contact name. A survey of these references may be made to determine the success and satisfaction with the vendor's service. Each reference contacted will be asked the same questions regarding products and services, including but not limited to;

- quality of products
- delivery
- responsiveness to reported problems, including maintenance and billing
- how well the contractor met the terms of the contract
- whether the reference would choose to use the services of the contractor again

#### Financi<u>al</u>

- Provide a lump sum cost of the completed boathouse and payment terms.
- Provide monthly cost with all terms and conditions for ongoing moorage agreement.

- c. The submitted proposals will be reviewed and scored by the Selection Committee. Points will be awarded based on the relative merit of the information provided in response to the solicitation. The highest rated response in each area will be given the maximum number of points available. The County may ask proposers to make oral presentations to discuss and clarify the submitted proposal.
- d. The Selection Committee will provide a recommendation to the Board of Commissioners for their consideration.

#### E. Statutory Tests

#### 1. Background:

ORS279C.335 requires that the Local Contract Review Board make certain findings as a part of authorizing the use of an Alternative Contracting Method. Clackamas County desires to use a Request for Proposals solicitation method to select a contractor for this project. The Clackamas County Request for Proposals approach has been designed to fully comply with the tests of Oregon Public Contracts Statute ORS 279C.335 for alternative contracting methods:

- a. It is unlikely that the exemption will encourage favoritism in the awarding of public improvement contracts or substantially diminish competition for public improvement contracts; and,
- b. The awarding of public improvement contract under the exemption will result in a substantial cost savings to the contracting agency or the public.

#### 2. Test:

#### a. <u>Maximizing Competition:</u>

The County will employ a competitive Request for Proposals process for selecting the vendor, where the cost of boathouse (along with other factors) is one element of the selection criteria.

#### b. Minimizing Favoritism:

The Request for Proposals will be publicly advertised in the trade publication of greatest circulation in the area.

#### c. <u>Substantial Cost Savings:</u>

It is anticipated that the process of evaluating potential contractors experience with similar projects and soliciting cost proposals from those contractors will minimize the County's exposure to changes in cost. Having a moorage location available to the operations of the construction contractor will allow the opportunity for on-site construction savings.

A close relationship between the designer and constructor will allow the opportunity for cost saving design choices and construction methods. Additionally, the RFP process provides that the contract will be awarded as soon as practicable to the responsible proposer whose proposal is determined to be the most advantageous to the County which will maximize cost savings. The project will be able to be completed more rapidly thereby minimizing the impact to the Marine Unit operations.

#### Approval of an Oregon State Parks and Recreation Department Local Government Grant Award for the Boring Station Trailhead Park

Clackamas County Parks (CCP) applied for an Oregon Parks and Recreation Department local government grant for specific improvements to the Boring Station Trailhead Park property in 2009. CCP has been awarded \$425,000 for improvements at Boring Trailhead Park including site preparation, street improvements within the park boundary, sidewalks, restroom building, paving, landscaping, utilities, and irrigation, permits, mobilization, and site amenities. The attached Grant Agreement with the State of Oregon (State) assigns roles, responsibilities and financial obligations for the use of these grant funds.

The Boring Station Trailhead Park project involves the development of approximately 2.8 acres of park land. This project benefits from strong community support and when completed will allow for public use and enjoyment of Boring Station Trailhead Park. The park will also serve users of the Springwater Corridor trail and Cazadero Trail as a trailhead facility.

Under this agreement the State agrees to pay the lesser of \$425,000 or 46.44% of the total project costs. The total cost of the project covered by this agreement is \$915,209. The required match has been included in CCP's budget. Matching funds are from Metro's Natural Areas bond measure, volunteer contributions, and the CCP Capital Improvement Plan.

County Counsel's Office has reviewed and approved the attached agreement.

#### RECOMMENDATIONS

Staff respectfully recommends that the Board approve and sign the Agreement (Project No. LGP0314) between CCP and the State.

Approval of an Intergovernmental Agreement between Clackamas County and the State of Oregon for the Springwater Trail Transportation Enhancement Project

Clackamas County Parks (CCP) and the State of Oregon Department of Transportation (ODOT) have negotiated an Intergovernmental Agreement (IGA) allocating Transportation Enhancement (TE) funds for completion of the Springwater Trail in Clackamas County, between Rugg Road in Damascus and Dee Street in Boring.

The Springwater Trail, acquired in 1990 by the City of Portland, extends from the Willamette River in Portland to Boring. The entire 21.5 mile Springwater Corridor is a unique regional natural resource area for walking, hiking, biking, and equestrian use. The City of Portland has granted an IGA that provides Clackamas County the right to design, construct, operate, maintain and repair of this section of the trail. This portion of the trail is currently gravel and unimproved. The project entails construction and paving an 2.21 mile extension of the Springwater Trail shared-use path with signs, bollards, drainage and landscaping. Paving the trail will allow this portion of the trail to be used more effectively as a recreational and transportation corridor.

The project will be funded by approximately \$1,200,000 in TE funds and a combination of 2006 Metro Natural Areas Bond Local Share funds and CCP Capital Improvement funds.

County Counsel's Office has reviewed and approved the attached agreement.

#### RECOMMENDATIONS

Staff respectfully recommends that the Board approve and sign the attached Transportation Enhancement Program Project Intergovernmental Agreement (IGA) between Clackamas County and the State of Oregon for the Springwater Trail: Rugg Road to Dee Street (Boring) project.

Community Solutions for Clackamas County (CSCC) a Division of the Health, Housing and Human Services Department requests the approval of amendment No.1 to IGA #129315 with the State of Oregon DHS-Children, Adults and Families. Approval will continue the Job Opportunity and Basic Skills (JOBS) Program in the County.

CSCC will continue responsibility for service management to DHS referred clientele. Contract requirements include employment plan development; job preparation and placement; transition services; and self-sufficiency services. All contract services are to assist adult clients with employment placement.

The agreement provides \$1,164,040 additional revenue for FY 10-11 for a new current maximum sum of \$2,328,080. This agreement is effective July 1, 2010 and terminates on June 30, 2011. This contract includes a new allocated position of 1 FTE Human Services Assistant. No County General Funds are involved. County Counsel reviewed and approved this contract in May, 2000.

## Approval to Accept Grant Funds from the U.S. Department of Labor For the Working for Independence Program

Community Solutions for Clackamas County (CSCC), a Division of the Health, Housing and Human Services Department (H3S)) requests the approval to accept federal Workforce Investment Act (WIA) earmark revenue from the U.S. Department of Labor for CSCC's Working for Independence program (WFI). This Federal Congressional Earmark is administered by the U.S. Department of Labor

The earmark amount awarded to CSCC is \$381,000. The grant period begins April 1, 2010 and ends September 30, 2011. The grant will provide employment and training services to individuals with mental health challenges, including those with severe and persistent mental illness and veterans suffering from post-traumatic stress disorder, and/or traumatic brain injury. ## A BOARD ORDER APPROVING SOLID WASTE MANAGEMENT FEE ADJUSTMENTS

The Board of County Commissioners is responsible for establishing uniform Waste Management Fees for solid waste collection services throughout the County. Any adjustment to the Fees is made with a recommendation from the Solid Waste Commission and is based on the increases or decreases in the cost of doing business, or an increased cost of additional, better or more comprehensive service.

The Strategic Planning & Sustainability Division of the Department of Transportation and Development (DTD) is responsible for managing the County's Integrated Solid Waste Collection System. This includes an annual review of the production records of the fourteen (14) franchised solid waste collection companies currently holding the County's twenty-two franchises. The purpose of the review is to ensure the solid waste collection services provided to the citizens of the County are being provided as safely and as efficiently as possible. The review is used to establish the fees charged for the variety of services required by the County and ensure a reasonable return and operating margin for the owner(s) of the business.

The County is currently divided into four fee zones: 1)Urban; 2)Rural; 3)Distant Rural and 4)Mountain. The Urban zone is within the Metro Urban Growth Boundary established prior to March 2003. Zones are differentiated by services offered (no Yard Debris outside Urban zone) and the distances traveled between houses and to and from disposal facilities.

The annual review revealed while production levels are as expected, the projected rise in labor and equipment costs, the loss of revenue from the sale of recyclables, slight rise in fuel prices, and a disposal fee increase effective August 1, 2010, place the composite operating margins at the low end of the reasonable return spectrum.

Almost immediately after the County adopted new collection fees in September of 2008 the bottom fell out of the market for recyclables. The revenue from the sale of recyclables, prior to the downturn directly offset 24% of the direct expenses attributed to the collection of the recyclables. While 2011 is anticipated to be better,

Last year the collection, mileage, and delivery fees for drop box service were adjusted to address the requirement to meet expenses when serving the areas outside the urban zone. The distances traveled to deliver and collect a box in this area of the County and the infrequency of service continues to have a tremendous impact on the cost of delivering service to the outlying portions of the County. Staff believes the best way to address this concern is to increase the mileage fee. The proposed change is listed below.

Drop Box Mileage Fee	Current	Proposed	Change
Over 18 miles round trip	\$2.70	\$4.70	\$2.00

#### **RECOMMENDATION:**

Staff respectfully recommends that Board of County Commissioners adopt the Solid Waste Management Fee Schedule as presented in Exhibit A effective August 1, 2010.

Waste Commission for a Waste Management Fee adjustment for the franchised collectors, and

It further appearing to the Board that the Solid Waste Commission, at a meeting on June 8, 2010, reviewed the application and supporting data received by the Commission for a Waste Management Fee adjustment for the franchised solid waste collectors within the County, and made their findings as follows:

- A. That a Waste Management Fee adjustment has been requested by 22 franchisees; and
- B. That it is the County's responsibility to ensure each portion of the solid waste collection system recovers the cost of providing that particular service; and
- C. That no general operating cost adjustment in Waste Management Fees be established for biomedical waste collection service: and
- D. That operating costs such as labor, insurance, and vehicle are increasing; and
- E. That disposal costs are increasing on August 1, 2010; and
- F. That the Waste Management Fees be adjusted for a majority of the classes of residential and commercial can/cart service; for container collection service, for drop box service and for miscellaneous services in all fee zones as set forth in Exhibit A of this Order; and
- G. That this request is just and reasonable under Chapter 10.03 of the Clackamas County Code; and
- H. That the urban Waste Management Fees inside the Urban Growth Boundary should apply to each of the following firms:
