## Shawn Olson, Clackamas Fire Marshal

- Discussed the Levy (passed last year) and that funds are going towards things as planned. Station 13 (Clarke's) is fully staffed.
- Annual Hilltop Safety Fair on September 14, 2024 10 a.m. to 2 p.m. Local vendors, emergency preparedness, kid friendly events, fire safety events, NW Natural present, PGE, etc.
- South End Fire Station Open House on October 12, 2024.

# **Department of Transportation & Development**

- Discussed the list of topics that were presented to Mr. Marek from the Hamlet Board including: speed zone reductions at Kamrath & Leland, OR213 Speed Zone request (contact <u>askODOT@ODOT.Oregon.gov</u>), Beavercreek Road slip lane to OR213 (traffic analysis work being completed), Beavercreek Road speed zoning (entire road being changed to 45 mph, 70+ on list), Farm equipment signs (used primarily when sight distance is restricted in heavy farming areas), Beavercreek Road school signage (congestion sign is already in place, no more signs can be put in), Henrici Chip Seal, OR213 at Beavercreek Rd. (back of queue warning), School Bus Stop signs (signs are put up when it's not visible for drivers to see), Community Road Fund Project Status (Canby/Marquam Highway complete and Redland Rd/Bradley Rd. complete), The Safe System Approach (Zero is our goal, system principles, etc.), Get Involved: Transportation System Plan Update which is investment planning for the next 20 years (300+ projects). - Questions from Hamlet members: radar feedback signs seem pointless because there are no repercussions for going over the speed limit and they are "visual pollution." Per Mr. Marek: Clackamas County does not legally allow recorded signage and referred the community member to contact state legislators to request that the law be changed.

- a. Z0290-24 property owner Carol Wright Trustee, applicant Dan Williams, Faster Permits, approx. 6,500' west of the intersection of Hwy 213 & S Freeman Road, zoned Agricultural/Forest District, 44.8 acres, requesting a forest land dwelling template test.
  - i. Discussed application location (near boundary of Hamlet).
  - ii. Tammy read response from Faster Permits which explains putting a home on the lot while staying within the requirements of the County and Hamlet.
  - iii. Hamlet Board made decision to not make a motion at this time.
- b. Z0305-24 property owner Robert W White Trustee, applicant Kim Reynolds, 15684 S Thayer Road, Oregon City, zoned RRFF5, 24.2 acres, requesting a Measure 49 property partition.
  - i. Discussed application details and what are the Measure 49 requirements.
  - ii. Hamlet Board made decision to not make a motion at this time.

- a. Ordinance ZDO-288 Zoning & Development Ordinance Amendments Related to Utility Facilities. Planning Commission Hearing 4/8, deliberations rescheduled to 5/13. BCC 6/12.
  - i. Effective September 9, 2024: Electric or gas utilities require a permit.
- b. Ordinance ZDO-285 Minor & Time Sensitive Amendments & New Housing Options ADUs & RVs in Rural Residential Areas. PC Hearing 4/22, BCC 5/8. Bill Merchant testified. BCC reconsidering RV portion.
  - i. This ZDO has been approved and goes live September 3, 2024.
- c. Z0346-23-ZAP & Z0347-23-SL, applicant Mann Construction, property owner Enoh & Danielle Man & Cornel & Vitoria Man, 20750 S Beavercreek Road/Wilson, zoned RRFF5, 56.22 acres, requesting a zone change from RRFF5 to RA2 and a 28-lot subdivision for future development of single-family dwellings. Hearings Officer approved. City of Oregon City appealing to LUBA & DLCD will consider appealing to LUBA on 6/27&28.
  - i. Appeal is placed on hold for outcome of appeal for subdivision across from Stone Creek Golf Course.
- d. Thimble Creek South, City of Oregon City, 20124 S Beavercreek Road, 42 residential lots with 143 dwelling units. Letter sent 1/18. 6/25 approved subject to conditions.
  - i. No new report of Thimble Creek South.
- e. Z0277-23-Z applicants Jessey Cereghino & Garrett Stephenson, property owners Gayleen Weiler, Joleeta Perkins, Janice W Kennedy, Trustee, 21418 S Hwy 213, zoned FF10, Weiler Farm 111 acres, requesting a zone change from FF10 to RA2. Approved subject to conditions. DLCD appealed to LUBA, Hamlet cannot intervene. HOW DO WE HANDLE FUTURE APPEALS/INTERVENSIONS? LUBA hearing 4/30. Decision remanded to Clackamas County. Appealed to Oregon's Court of Appeals 8/14.
  - i. Plan to hear response from Oregon's Court of Appeals by mid-September.
- IV. OTHER: Mark mentioned the need for a Land Use Attorney to represent the Hamlet CPO to give us a voice to the Oregon Court of Appeals.
