Form Details:

Public Information Officer (PIO) Information: If your agency has a Public Information Officer, please fill out his or her contact information. If your agency does not have a PIO, and the agency coordinator is acting as the PIO, please inform the National Coordinator of this so the agency coordinator may receive media information.

Agency Participation List: We strongly encourage your agency to attempt to involve other agencies in this effort. You may want to contact city police departments, probation departments, DA's offices, victim/witness agencies, shelter organizations, or any other community-based or governmental organizations that are dedicated to family violence. Additionally, if you are in contact with neighboring counties, we encourage that you collaborate and get them on board with this important event. Please include the agency head of your department and other participating agencies, as this information is helpful in sending correct appreciation letters after the completion of the Sweep.

Warrant Information Sheet: Many agencies have a warrant cover sheet they use for gathering information about suspects and warrants. However, if your agency does not have a warrant cover sheet, this is a sample one that you can modify to meet your agency's needs.

Officer Final Reporting Form: In order to effectively track the number of warrant attempts and services, we suggest printing this form on a different color sheet of paper, distributing it to your officers prior to the Sweep, and have them return it to a designated person the night of the Sweep. This may help facilitate tallying the total number of attempts, services, and persons involved in your event.

Agency Final Reporting Form:

This form will need to be completed after the completion of the Sweep and returned to National Headquarters prior to 12:00 a.m. Please note that the media continuously contacts the National Headquarters for up-to-date numbers — so it is essential that this is faxed or emailed as soon as possible.

Preparation Section

Preparation Section Purpose:

To provide agencies with a list of possible organizational strategies to perform a successful Warrant Sweep.

Preparation Details:

Organizational Information: A sample list of steps that agencies can perform to get ready for this year's Warrant Sweep. We do recognize that many agencies have performed a previous Warrant Sweep; therefore, use whatever information you think is best for your agency.

Sample Task List

o clarify Warrant Sweep operations, we've created a **sample task list**. This list is simply a model for what our agencies are doing. Many agencies have their own systems in place and do this on a regular basis, while others have limited experience. Our goal is to share some often-used practices.

Prior to the Warrant Sweep

Researching the Warrants

1. IDENTIFY FAMILY VIOLENCE CRIMES

The first step in preparing your agency for the Sweep is to create a list of family violence warrants that you will serve. Depending on your agency, here are some suggested types of family violence warrants:

- Domestic Violence Crimes (e.g., Harassment, Assault, Burglary, Criminal Mischief, Criminal Mistreatment, Cruelty to Animals, etc.)
- Interfering with Making 911 Calls, Obstructing Telephone Service, or Crimes Relating to a Victim Calling 911
- Restraining Order Violations
- Stalking Order Violations
- Domestic Violence Release Agreement Violations or Bail Bond Violations
- Non Payment of Child Support
- Child Abuse Crimes
- Elder Abuse Crimes (e.g., Theft, Fraud, Neglect, Abuse, etc.)
- Any other Family Violence or Child Abuse crimes specific to your jurisdiction.

2. WARRANT TIME FRAME

It is recommended that your agency put priority on warrants that are less than one year old — putting the most effort into getting the most current information on the suspects (i.e., quality versus quantity).

3. WARRANT PACKETS

This traditionally has been the most important — and the most time-consuming — part of the planning. But creating thorough warrant packets for officers may increase efficiency. These packets should be prepared in advance. It is also advisable to separate packets geographically and assign officers to specific quadrants.

The warrant packets should include:

- **1.** Possible addresses of the suspect.
- **2.** Possible address/contact information for the victim (occasionally, the victim may know how to locate the suspect).
- 3. Suspect's criminal history.
- **4.** Copy of the warrant.
- **5.** Mug shots of the suspect.
- **6.** Officer safety information.

4. INVOLVING RESOURCES

Here is a list of ideas that may be helpful to aid in the success of your Warrant Sweep:

- **1.** Notify the jail that you will be participating in the Warrant Sweep so they can prepare.
- **2.** Notify your communications agency that you will be participating in the Sweep so they can prepare.
- **3.** Notify the courts that you will be participating in the Sweep so they can prepare.
- 4. Notify outside agencies (e.g., probation, local battered-women's shelters, District Attorney's office, DA advocates, etc.) that you will be participating and coordinate any partnering for patrol cars if they choose to join your effort.
- **5.** Have designated jail transports available to allow officers to make more warrant attempts.
- **6.** Place Reserve Officers together with regular Officers for two person cars.
- 7. Have Reserves or Corrections personnel at holding facilities — so officers can drop off arrested subjects to be picked up by transport teams.



Sample Task List (continued)

- 8. Consider using additional resources
 - On day of Sweep, have people assigned to phone banks to attempt to locate offenders by phone and give leads to officers working on the Sweep. (These contacts can be counted as warrant attempts.)
 - Invite survivors of family violence to speak to the media at your briefings.

Public Information Officers

A sample press release is included in this packet, in the Media Section. After the Sweep, DVERT will send out arrest and warrant-service totals to your Public Information Officer (PIO). It is a good idea to get the PIO and administrators on board for positive media attention before and after the Sweep. However, when notifying the print or television media, please advise them not to broadcast the Sweep prior to the event — as we do not want to notify suspects that we will be attempting to locate them.

Day of the Warrant Sweep

Command Post

The Sweep will begin at 12:00 a.m. and will end at 11:59 p.m. This does not mean that your agency *has* to begin at 12:00 a.m. — rather, it is a standardized time frame for the nation. Remember to do what works best with your particular agency.

It is a useful idea to have a command post that acts as a centralized hub. This post will serve as the central area where officers can pick up warrant packets and return unserved warrants. Initially, your agency may distribute a small number of packets to each team to attempt to serve — and then have teams return for more packets as needed.

Officer Involvement

Each officer should be given a copy of the **Officer Final Reporting Form** (page 7 of this packet) to complete throughout the Sweep. They can tally all of their activities and return the form to you for a final count.

Tracking and Reporting Warrant Attempts

Plan to track warrant attempts, arrests, and persons involved in the Sweep, so that this information can be easily faxed or emailed to the National Coordinator for final statistics.

The simplest way to achieve this is to have each officer track his or her individual attempts on the **Officer Final Reporting Form** (page 7). Consider printing out that form on a different color of paper (so it is not confused with warrant paperwork) to pass out at the Sweep briefing, and require each officer to turn one in at the end of his or her shift.

Additionally, designate one person responsible for collecting all of the Officer Final Reporting Forms, tallying the final numbers, and faxing or emailing them to National Headquarters. Please keep copies of all forms returned to you in order for the numbers to be double checked for the final total.

IMPORTANT INFORMATION FOR EACH AGENCY:

You will need to return the **Agency Final Reporting Form** (page 8 of this packet) to the National Coordinator. Please fax or email your report at the end of your Sweep detail. If your agency is unable to participate for whatever reason, please contact the National Coordinator as soon as possible. If you do not contact the National Coordinator we will be contacting you after the Sweep. Please send your final reports as soon as you have completed them. It is helpful to communicate with your regional coordinator at the beginning and end of your Sweep, so they know when to expect your last report. Please provide your regional coordinator with a cell phone or pager number so you can be reached during the Sweep.

After all agencies have completed their Sweep, the National Coordinator will notify you via e-mail of the nationwide statistics.

Media Section Purpose:

To provide agencies with information to provide to media for a successful publicized Sweep.

Media Details:

Press Release Information: Included on the following pages are Clackamas County's Warrant Sweep press releases from 2019 — which you can use as a reference/starting point for your own news releases.

Local shelter agencies may be a great resource for specific domestic and family violence statistics for your area. A final **participating-agency list** will be available to send to the press prior to the event.

Please note that any press release given to the media should be **embargoed** — to avoid warning wanted persons that they will be arrested.

You may also want to consider **allowing media to ride along with officers** to publicize your agency. However, if media is riding along, we suggest that before the Sweep, you designate which team they will be with — and then give that team some warrants that will most likely result in an arrest.

Consider attaching Domestic Violence, Child Abuse, and State Domestic Violence Fact Sheets:

It is a good idea to provide the media with local and/or national statistical information regarding family violence along with your press release.

Pre-event release (Tuesday, Oct. 22, 2019):

MEDIA OPPORTUNITY / DATE EMBARGOED: JOIN LOCAL LAW ENFORCEMENT ON NATIONWIDE DOMESTIC-VIOLENCE WARRANT Sweep THIS WEEK

IMPORTANT -- EMBARGO NOTICE: In an effort to keep wanted persons from being tipped off about our apprehension detail, we ask that media outlets NOT disseminate this information until 10 p.m. on Wednesday, Oct. 23.

This Wednesday, Oct. 23, law-enforcement partners across the country will join forces for the 17th-annual National Family Violence Apprehension Detail -- also known as the "DV Warrant Sweep."

The Sweep is a day-long event, in which agencies across the United States attempt to serve outstanding family-violence warrants.

Stats for last year's Sweep (2018):

- 315 agencies from 29 states participated
- 3,235 nationwide attempts to serve arrest warrants
- 821 arrests nationwide
- 879 law enforcement members participated

Over the Sweep's previous 16-year history, there have been 88,468 DV warrant attempts and 18,726 DV warrants served.

Thursday's local detail will include Clackamas County law-enforcement agencies, as well as local state and federal partners including the Oregon State Police and the U.S. Marshals Service, Oregon District.

MEDIA OPPORTUNITY:

Local media are invited to ride along with law-enforcement partners during the Sweep.

Interested reporters can join us at the 2 p.m. briefing, held Oct. 23 at the Public Safety Training Center (12700 SE 82nd Avenue, Clackamas). During the briefing, the Sheriff will address the participating agencies. Participating members are also scheduled to hear from guest speakers who will underscore the importance of the day's mission.

Post-Event Update # 1 (Friday, Oct. 25, 2022):

LOCAL STATS and PARTICIPANTS

On Wednesday, Oct. 23, 2019, the Clackamas County Sheriff's Office Domestic Violence Enhanced Response Team (DVERT) worked with agencies throughout Oregon -- as well as agencies across the country -- to arrest persons with outstanding family-violence warrants.

Locally, they made 26 arrests during the sweep, on a variety of charges.

Nationwide, the **17th Annual Family Violence Apprehension Detail** included over 350 county sheriffs' offices, police departments, probation departments, and community agencies from 32 states. All agencies served outstanding arrest warrants — with charges ranging from harassment to murder.

In Clackamas County alone, by 10 p.m. Thursday, this massive enforcement effort resulted in the arrests of **26** men and women brought to the Clackamas County Jail on existing arrest warrants on a variety of charges, some of them DV-related.

A PDF of Clackamas County mugshots and arrest charges (ranging from strangulation to assault to failure to report as a sex offender and other crimes) secured during yesterday's sweep is here. (These figures may be updated as more agencies report in.)

The Sheriff's Office founded this national warrant sweep and has coordinated the nationwide effort for the past 17 years. As of last year, authorities across the U.S. had made a total of **88,468** warrant attempts and served **18,726** warrants over the first 16 years of the sweep.

This collaborative effort helps raise awareness of the problem of family and domestic violence in our communities. It also demonstrates to offenders that they will be held accountable for their violence.

In a pre-sweep briefing at the Public Safety Training Center, Clackamas County Sheriff Craig Roberts spoke to law-enforcement personnel and the media, as did Clackamas County Chief Deputy District Attorney John Wentworth and survivor Ashley Bell.

Sheriff Roberts also formally recognized local officials who worked behind the scenes in support of the passage of Senate Bill 1562, which finally made domestic-violence strangulation a felony in May 2018. Roberts presented Chief Clackamas County Deputy DA John Wentworth, Clackamas Women's Services Executive Director Melissa Erlbaum, and former A Safe Place FJC Director (now Undersheriff) Angie Brandenburg with framed shadowboxes containing a signed copy of the bill, a thank-you letter, a signing pen and a photo with Governor Kate Brown. CCSO News Releases (from 2019)

Post-Event Update #2 (Tuesday, Nov. 12, 2019):

NATIONAL STATS

At this writing (Nov. 12), nationwide, the **17th Annual Family Violence Apprehension Detail** included **1,154** law-enforcement personnel (and **1,188** total participants) from **355** county sheriffs' offices, police departments, probation departments, and community agencies in **32** states.

All agencies served outstanding arrest warrants -- with charges ranging from harassment to murder.

Nationwide, 784 warrants were served on Oct. 23, with 3,752 warrant attempts. In Clackamas County alone, 56 local law-

enforcement members made 197 warrant attempts and 31 arrests, with a dozen local agencies working together in the effort.

The Sheriff's Office founded this national warrant sweep, and has coordinated the nationwide effort for the past 17 years. At this writing, since its founding, authorities across the U.S. have made a total of 92,220 warrant attempts and served 19,510 warrants in the 17 years of the sweep.
